Notice is hereby given that a regular meeting of the **California Horse Racing Board** will be held on, **Thursday, March 22, 2007**, commencing at **9:30 a.m.**, at the **Bay Meadows Race Track, Longchamps Room, 2600 S. Delaware Street, San Mateo, California.**

The agenda for the regular meeting will consist of the following matters:

### **Action Items:**

1. Approval of the **minutes of the regular meeting of February 22, 2007.**
2. Discussion and action by the Board on the **Application to Conduct a Horse Racing Meeting of the Pacific Racing Association (T) at Golden Gate Fields**, commencing April 25, 2007 through June 10, 2007, inclusive.
3. Discussion and action by the Board on the **Application to Conduct a Horse Racing Meeting of the Hollywood Park Racing Association, LLC (T) at Hollywood Park**, commencing April 25, 2007 through July 15, 2007, inclusive.
4. Public hearing by the Board on the adoption of the **proposed amendment of CHRB Rule 1481, Occupational Licenses and Fees**, to add the occupational license class "backstretch event personnel."
5. Public hearing by the Board on the adoption of the **proposed amendment of CHRB Rule 1844, Authorized Medication**, to increase the permitted level of flunixin (lasix) in an official urine test sample from 20 nanograms to 50 nanograms, and to allow 25 picograms of clenbuterol in the official blood test sample.
6. Public hearing by the Board on the adoption of the **proposed addition of CHRB Rule 1874.1, Breath Alcohol Testing**, to initiate a breath alcohol testing program for jockeys, apprentice jockeys and drivers, and to authorize breath alcohol testing of all other licensees if reasonable cause exists.
7. Discussion and action by the Board on the **approval of Stewards' contracts.**
8. Discussion and action by the Board on the **request from the Solano County Fair and the Sonoma County Fair**, to conduct a joint fair race meeting, to be called "Sonoma Solano Wine Country Racing" commencing July 11, 2007 through July 15, 2007 and July 18, 2007 through August 6, 2007.

9. Discussion and action by the Board on the **request from the Bay Meadows Racing Association for a two-year waiver of CHRB Rule 1433 (b), Application for License**, which requires a racing association that conducts four or more weeks of continuous thoroughbred racing in a calendar year to install a polymer synthetic racing surface at its facility by January 1, 2008.
10. Discussion and action by the Board on the **proposed amendment of CHRB Rule 1481, Occupational Licenses and Fees**, to increase the fees paid for occupational licenses.
11. Discussion and action by the Board on the **proposed amendment of Rule 1657, Opening of Claim**, to require that all claims in a claiming race, except the successful claimant, be null and void after the claiming race is declared official.
12. Discussion and action by the Board on the **proposed amendment of CHRB Rule 1690.1, Toe Grabs Prohibited**, to prohibit the use of toe grabs greater than four millimeters on the front shoes of quarter horses while racing.
13. Report of the **Medication Committee**.
