Action Items:

1. Discussion and action regarding the **feasibility of adding the proposed CHRB Rule CHRB Rule 1500.2, Random Drug Testing of Racing Participants**, to allow random drug testing of exercise riders and/or racing officials and stewards whose names appear on the official programs, as well as outriders, and the starting gate crew.
2. Discussion and action regarding the **proposed development of a new rule to allow random alcohol testing of jockeys**.
3. Discussion and action regarding the **proposed amendment to CHRB Rule 1536, Stewards Minutes**, to require the new CHRB form Report of Training Accidents (CHRB 201A), to be attached to the stewards' minutes.
4. Discussion and action regarding the **proposed addition of CHRB Rule 1498.1, Exercise Rider Physical Examination**, to require that exercise riders undergo an annual physical examination prior to the race meeting of the year in which they intend to participate.
5. Discussion and action regarding the report from the **CHRB Safety Stewards concerning the procedures for licensing of exercise riders as provided in CHRB Rule 1504.5, Provisional Exercise Rider and Exercise Rider**.
6. Discussion and action regarding the report from the **CHRB Safety Stewards regarding backside improvements being made to help ensure a safe working environment**.
7. **General Business:** Communications, reports, requests for future actions of the Committee.
