CHRB RULE 1844.1, SUSPENSION OF AUTHORIZED MEDICATION, FOR A PERIOD OF
12 MONTHS BEGINNING DECEMBER 26, 2013 THROUGH
DECEMBER 25, 2014

BACKGROUND

Business and Professions Code section 19420 provides that jurisdiction and supervision over meetings in this State where horse races with wagering on their results are held or conducted, and over all persons or things having to do with the operation of such meetings, is vested in the CHRB. Business and Professions Code section 19440 states the Board shall have all powers necessary and proper to enable it to carry out fully and effectually the purposes of this chapter. Responsibilities of the Board shall include adopting rules and regulations for the protection of the public and the control of horse racing and pari-mutuel wagering. Business and Professions Code section 19562 states the Board may prescribe rules, regulations and conditions consistent with the provisions of this chapter, under which all horse races with wagering on their results shall be conducted in this state. Business and Professions Code section 19580 states the Board shall adopt regulations to establish policies, guidelines, and penalties relating to equine medication in order to preserve and enhance the integrity of horse racing in the state. Business and Professions Code section 19581 provides that no substance of any kind shall be administered by any means to a horse after it has been entered to race in a horse race, unless the Board has, by regulation, specifically authorized the use of the substance and the quantity and composition thereof. Board Rule 1844.1, Suspension of Authorized Medication, provides that the Board may temporarily suspend the authorized administration of a permitted drug, substance or medication after a public hearing has been noticed in accordance with Government Code section 11125(a). The temporary suspension may be for a race, breed, or race meeting, provided all horses in the same race compete under the same conditions. The Board shall notify in writing the racing association and the trainer's organization of any temporary suspension, as specified.

Board regulations prohibit the administration of any drug, substance or medication after entry time with a few specific exceptions. The exceptions were established after due consideration by the Board based on information available at the time the regulations were adopted. Scientific information and practical experience in managing the threshold levels for the exceptions change over time as unintended consequences become apparent or public policies and attitudes change. Stanozolol is an example. Stanozolol is a synthetic, manufactured adrenergic anabolic steroid widely recognized as a performance enhancing drug (PED) in athletic competition.

Beginning on July 1, 2008, the CHRB began regulating anabolic steroid use in race horses in California. Prior to that time there were no specific regulations controlling their use in horse

racing under the jurisdiction of the CHRB. There are 3 naturally occurring, endogenous anabolic steroids that are also available as Food and Drug Administration (FDA) approved pharmaceutical drugs, testosterone, boldenone and nandrolone. The Board established threshold levels for these endogenous anabolic steroids in Rule 1844, Authorized Medication, consistent with Association of Racing Commissioners International (ARCI) and international rules and regulations established by the International Federation of Horseracing Authorities (IFHA). An exception was made for the synthetic, manufactured adrenergic anabolic steroid stanozolol. At that time stanozolol was commercially available as Winstrol V, an FDA approved drug for use in debilitated horses. Due to the wide-spread use of the drug, a 1 ng/ml urine threshold was established. The resulting withdrawal time was thought to be a reasonable compromise even though stanozolol is not a natural anabolic steroid. This was a national effort at uniformity and was largely successful. Regardless, the Kentucky Horse Racing Commission never allowed a threshold for stanozolol when they adopted their anabolic steroid regulations. The CHRB conducted the first anabolic free Breeder's Cup in 2008. The Kentucky regulations only dealt with anabolic steroids in racing. They did not address their use in training. Subsequently by directive, the Board required horses treated with anabolic steroids to be placed on the Veterinarian's List for 30 days. Horses requiring an anabolic steroid were assumed to be unfit to race; this action also enforced a minimum 30 day withdrawal time to avoid unintended violations. In the 1st Quarter of FY 13-14 beginning July 1-September 30, 2013, there were 219 treatments of horses at CHRB race tracks of anabolic steroids, the large majority of those treatments were for stanozolol. Eighty-eight of the 219 anabolic steroid treatments come from just 4 trainers (40%). Even with the minimum 30 day withdrawal time there have been several instances of stanozolol levels being found near the threshold in a number of post-race samples. Today, stanozolol is no longer manufactured by pharmaceutical companies or sold as Winstrol-V. All the stanozolol currently available is prepared by compounding pharmacies with significant variations in concentrations due to their lack of standards in manufacturing, quality control and regulation oversight (*Dr. Scott Stanley, unpublished data*). Furthermore, recently published research demonstrated the elimination of stanozolol is highly variable. The time point with the last detectable concentration of stanozolol for these 26 animals varied from 21 days to as long as 56 days. (*Moeller et al., Pharmacokinetics of Stanozolol in Thoroughbred Horses Following Intramuscular Administration. J Vet Pharmacol Therap, 36(2): 201-4(2013)*). The persistent blood levels for such a long time indicate stanozolol is effective longer than previously thought. More importantly, the justification for the use of stanozolol is largely passed. The drug is not widely used as demonstrated by the data above showing 4 trainers are responsible for 40% of its use; stanozolol is no longer available as a quality controlled pharmaceutical; and the use of anabolic steroids are widely recognized as performance enhancing drugs by the public. Stanozolol in particular has a notorious reputation in sport. It was the drug used by Ben Johnson in the 1988 Seoul Olympics leading to his disqualification and more recently was at the center of the Darley/Al Zarooni scandal in British racing. The Racing Medication and Testing Consortium recently recommended the threshold for stanozolol be eliminated from national regulations. This is consistent with international efforts to prohibit the use of all anabolic steroids in racing and training. Recent scandals in Britain over the use of stanozolol have led to a call for an international ban on the use of stanozolol and other adrenergic anabolic steroids in racing and training. National uniform medication regulations promoted by the ARCI effectively eliminate the threshold for stanozolol.

ANALYSIS

The suspension of authorization for a urinary threshold for stanozolol will make California consistent with the Kentucky Horse Racing Commission and with ARCI model rules for stanozolol. The delay in the effective date of the suspension to Dec 26, 2013, will allow time for stanozolol that may have already been administered to a horse to "wash out" of its system. If any trainers are concerned about residue stanozolol levels pre-race testing for stanozolol is available.

RECOMMENDATION

This item is presented for Committee discussion and action. The Committee may wish to hear from the Equine Medical Director, Dr. Rick Arthur.

NZTR APPROVES BAN ON ANABOLIC STEROIDS

New Zealand Thoroughbred Racing has approved a ban on the use of anabolic steroids for horses both in and out of competition.

The new ban will apply to all thoroughbreds from the age of six months, with this period of permitted steroid use allowed only in the interests of animal welfare.

New Zealand's current Rules of Racing prohibit anabolic steroids in horses only on race day, meaning the new ban will require an amendment to the rules.

It is expected the rule change will be implemented by December 1, 2013, with the ban effective from May 1, 2014. The prohibition will apply to any horse that comes within the legal jurisdiction of the New Zealand regulatory authorities to conduct out-of-competition testing.

NZTR Chief Executive Greg Purcell said a zero-tolerance approach would be taken on anabolic steroids.

"While the use of anabolic steroids has not been a major problem in New Zealand, it was important we take a clear and definitive position in the interests of integrity and public perceptions of thoroughbred racing in New Zealand.

"There's no place for performance-enhancing drugs in our sport and this is testament to our commitment."

In considering the ban NZTR consulted with its Veterinary Advisor, the Equine Veterinary Association, Trainers' Association, Breeders' Association, New Zealand Bloodstock, Harness Racing Trainers' and Drivers, and Standardbred Breeders and taken into account that some countries will ban anabolic steroids from birth to retirement.

In mid-September the Australian Racing Board announced a ban on the use of anabolic steroids both in and out of competition. In line with New Zealand's move, the ban will apply to all thoroughbreds from the age of six months with that period allowed in the interests of animal welfare.

BHA Looks Ahead to IFHA Debate on Anabolic Steroids

Paul Bittar, chief executive of the British Horseracing Authority (BHA), outlined his hopes yesterday (Oct. 3) ahead of the sessions at the forthcoming International Federation of Horseracing Authorities (IFHA) Conference, when the subject of the use of anabolic steroids in racing will be considered. The conference will take place Oct. 7-8 in Paris, France.

Bittar expressed support for the introduction of a minimum standard across racing nations and British Racing's commitment to exceeding that minimum standard wherever possible.

In May the BHA wrote to the IFHA seeking their support for the promotion of international harmonization amongst all racing nations regarding anabolic steroids. The existence of inconsistencies among racing authorities had been highlighted following the BHA's finding of prohibited substances in horses trained by Mahmood Al Zarooni and the subsequent eight-year ban issued to the trainer.

"The BHA strongly believes that there is a need to establish a minimum international standard relating to the use of anabolic steroids in horseracing and we welcome the opportunity for this to be discussed in detail amongst major racing nations," Bittar said. "With horseracing subject to increasing levels of international competition, it is in the interests of the sport globally to develop a position which provides a level playing field for all participants. Announcements regarding changes by the authorities in Dubai and, more recently, Australia and New Zealand are welcome and have added momentum to the debate.

"The events of this year, together with the inconsistencies that exist across racing nations, have made it apparent that the control and regulation of the use of anabolic steroids in racing is a complex issue. Our initial objective is to support the IFHA in producing a minimum standard all racing authorities could sign up to," he continued. "However, subsequent to the conference the BHA intends to continue work on establishing a revised position that is relevant for British Racing and comprised of effective and enforceable measures.

"It is anticipated that this position will exceed the minimum standard in several areas. Any amendments to our Rules will provide for the implementation and enforcement of the minimum standard. We anticipate this process, including all necessary consultation, will be completed early in 2014."

Pharmacokinetics of stanozolol in Thoroughbred horses following intramuscular administration

Stanozolol is a potent synthetic anabolic androgenic steroid (AAS) that is classified as a class III drug by the Association of Racing Commissioners International. Recent reviews have discussed in great detail the therapeutic uses of AAS and their potential as performance enhancers in the horse (Fajt & McCook, 2008; Pitts & Davis, 2007). Although the use of AAS such as stanozolol may be medically warranted for short periods, long-term use is associated with adverse side effects particularly in terms of the reproductive and musculoskeletal systems (Squires *et al.*, 1982; Dowling *et al.*, 1993; Hartgens & Kuipers, 2004; Pitts & Davis, 2007; Bonetti *et al.*, 2008; Fajt & McCook, 2008). Currently, no pharmaceutical company manufactures or markets a stanozolol product, and the only available stanozolol products are injectable suspensions prepared by veterinary compounding pharmacies. The purpose of this study was to investigate, using concurrent analysis by two analytical laboratories, the disposition of stanozolol in Thoroughbred horses following intramuscular (IM) administration of a compounded aqueous suspension to provide information necessary for establishing an appropriate withdrawal period before competition.

The disposition of stanozolol in six horses after IM administration has previously been described (Soma *et al.*, 2007). The limited sample size in this study and the large individual variations in disposition following IM administration, however, limit its utility to providing reliable withdrawal guidelines. Other studies considering the disposition of stanozolol in the horse have focused primarily on detection of hydroxylated stanozolol metabolites in urine by liquid chromatography–tandem mass spectrometry (LC-MS/MS) as a means of controlling its use (Muck & Henion, 1990; Poelmans *et al.*, 2002; McKinney *et al.*, 2004).

In this study, the pharmacokinetics of stanozolol were investigated in 26 exercised Thoroughbred horses (seven mares and 19 geldings) with a mean \pm SD weight of 540 ± 37 kg and aged 7.1 ± 1.9 years. Food and water were available *ad libitum* throughout the study. Horses did not receive any medications for at least 2 weeks before commencement of the study. Animal studies were conducted at the University of Florida (UF) and were approved by the Institutional Animal Care and Use Committee at UF. The 26 horses were assigned to four separate groups with each group receiving one of three different lots prepared by the pharmacy. Each horse was weighed before drug administration. All horses received a single IM injection (0.55 mg/kg) of a stanozolol suspension (50 mg/mL, Franck's Pharmacy, Ocala, FL)¹ in the left gluteal muscle. Blood samples were collected by individual venipuncture immediately before drug administration (as a predose control) and at 0.33, 1, 3, 7, 10, 14, 17, 21, 28, 35, 42, 49, 56, and 63 days after drug administration. Six additional samples were collected from one of the four groups with 6 geldings (weighing 540 ± 24 kg and aged 8.1 ± 0.7 years) at 1, 2, 4, 6, 48, and 96 h to better characterize the initial disposition of stanozolol following administration. Blood samples were collected into lithium heparin blood tubes (15 USP units; Becton Dickinson, Franklin Lakes, NJ, USA) and stored on ice for <30 min until separated by centrifugation at $\sim 1300 \times g$ at 4 °C for 15 min. Each plasma sample was immediately divided and transferred into cryovials (Phenix Research Products, Chandler, NC, USA) that were stored at -80 °C until all samples were shipped on dry ice to each of two

racing chemistry laboratories, one at UF and the other at the University of California – Davis (UCD).

Plasma stanozolol concentrations were determined in both racing chemistry laboratories via independently validated liquid-liquid extraction (LLE) methods with quantification by LC-MS/MS on triple-stage quadrupole mass spectrometers (Thermo TSQ Vantage, San Jose, CA, USA) using electrospray ionization operating in the positive mode. For samples analyzed at UCD, 1 mL of plasma was fortified with testosterone- d_3 as the internal standard (IS) and extracted into methyl-*tert*-butyl ether (MTBE) (Moeller *et al.*, 2010). After mixing and centrifuging for 5 min, the top layer was removed and dried with nitrogen at 50 °C. The extract was dissolved in 100 μ L of 90:10 water/methanol with 0.2% formic acid, and 30 μ L was injected onto the LC-MS/MS system. After separation, stanozolol was detected by selective reaction monitoring (SRM). Five SRM transitions were monitored (327 \rightarrow 81, 95, 107, 109, and 121 m/z); the 81 m/z ion was used for quantitation. The 292 \rightarrow 97 m/z transition was monitored for the IS. The limits of detection (LOD) and quantification (LOQ) for stanozolol were 0.5 and 10 pg/mL, respectively. For quantification at UF, a 0.5 mL IS solution of stanozolol- d_3 in 0.9% saline was added to 1 mL of plasma that was extracted with MTBE following 10 min of mixing. The dried residues were dissolved in 60 μ L of 0.1% formic acid in 50% methanol, and 20 μ L was injected onto the LC-MS/MS system. The 81 m/z product ion was monitored by SRM for both stanozolol and IS. The LOQ was 25 pg/mL.




Fig. 1. A percentage similarity histogram comparing stanozolol concentrations determined at UCD and UF. UF was used as the baseline value to which UCD data were compared. A similarity value of 1.0 is equivalent to 100% similarity between measured values at UCD and UF.

To assess agreement between the plasma stanozolol concentrations determined by the two laboratories, the results were compared using the percent similarity model (Graph-Pad Prism Version 5; GraphPad Software, La Jolla, CA, USA) (Scott *et al.*, 2003). The percentage similarity between the two sets of results was 81.5%, with a mean percentage difference of 18.5%, and a SD of 13.9% illustrating the accuracy and precision between the two data sets (Table 1). Although there were differences in stanozolol concentrations between the two laboratories, both generated similar results; the coefficient of variation was 17.1% (Fig. 1) which is well within the pharmaceutical industry standard of 20% for incurred sample repeats [i.e., repeated analysis of 5–10% of the samples by the same laboratory (Rocci *et al.*, 2007)].

Noncompartmental analysis (NCA) using the linear trapezoidal method was used to analyze plasma concentration vs. time data using commercially available software (WinNonlin Version 5.2; Pharsight, Cary, NC, USA). For uniformity, the plasma concentrations generated from UCD were used in pharmacokinetic analysis. NCA was performed using the UCD data for all

collection times until stanozolol was no longer detectable. Pharmacokinetic parameters were determined for each horse, and median, maximum, and minimum values are summarized in Tables 2 and 3. Plasma concentrations vs. time profiles for individual horses along with the calculated median are shown in Fig. 2. The use of nonparametric medians for these evaluations was determined to be more appropriate than the use of means owing to the potential for nonnormal distributions – which tend to be more pronounced at the end of a time course.

The disposition of stanozolol after IM administration was highly variable between horses with differences in the C_{max} , T_{last} , $t_{1/2}$ confirming the previous findings of Soma *et al.* (2007) whose work had also used a stanozolol formulation obtained from a veterinary compounding pharmacy. The six horses with the additional blood samples in the current study were used to determine the initial disposition of stanozolol after administration (Fig. 2b). Overall, disposition between the two groups was very similar (Tables 2 and 3). Although in the six horses, a rapid absorption phase was observed with an initial rise in plasma concentrations between 1 and 2 h, the rise was followed by a rapid decrease (Fig. 2b). Although a similar plasma drug concentration vs. time profile was observed following previous extravascular administration of compounded suspensions of stanozolol the $t_{1/2}$ observed in the present study ranged from 1.6 to 14.7 days, in contrast to the 2.5 to 4.2 days previously reported (Soma *et al.*, 2007). The median $t_{1/2}$, however, was similar in the two studies with both being between 3.4 and 3.5 days. The rapid rise in stanozolol concentrations immediately after administration of the suspension was likely due to the absorption of the stanozolol fraction that was already in solution at the time of injection; this rise was then followed by an initial decrease owing to elimination via metabolism and excretion. The later rise with a T_{max} of 7 days was likely due to the slower



dissolution, and absorption of stanozolol that was in suspension at the time of injection. The large observed $t_{1/2}$ was probably a result of flip-flop kinetics, with the release of the drug into the central compartment controlling the terminal rate constant as opposed to its elimination by metabolism and excretion, as previously noted by Soma *et al.* (2007).

The T_{max} values for stanozolol were consistent with each of the 26 horses having an observed T_{max} of 7 days, a finding that was consistent with those of Soma *et al.* (2007). There was, however, a large discrepancy between the lowest C_{max} value observed in the Soma *et al.* (2007) study and the study presented here. In the current study, the lowest observed C_{max} was 686 pg/mL compared with 3469 pg/mL reported in Soma *et al.* (2007). The horse with the lowest C_{max} along with the other six horses

dosed with the same lot of stanozolol suspension had AUC, Cl/F, C_{max} , and T_{last} values that were lower (Mann-Whitney-Wilcoxon test, $P < 0.01$) than those of the other study horses. The observed differences between groups administered different lots of stanozolol suspension may be due to variability in particle size distribution and/or crystal structure of the suspension, factors which may affect the rate of dissolution and thereby the rate and extent of absorption. Effects such as these may occur more frequently during use of compounded suspensions that lack the standardization and quality control required for all FDA approved formulations.

The time point with the last detectable concentration (T_{last}) of stanozolol for these 26 animals varied from 21 days to as long as 56 days with a median time of 35 days. Soma *et al.* (2007)

reported a T_{last} of 43 days, which is almost 2 weeks earlier than the value reported here and is attributed to the lower LOD of the method used in this study. In conclusion, a withdrawal guideline of 60 days is recommended for a single IM dose of stanozolol to exercise-conditioned Thoroughbred horses. This withdrawal time (>14 half-lives) was determined using statistical analysis to determine a 95% confidence interval that 95% of the population would no longer have a quantifiable concentration of stanozolol in plasma (EMEA, 2000). A plasma threshold of 10 pg/mL based on the limit of quantitation of current analytical methodologies is recommended for the determination of stanozolol administration in the horse. The use of a compounded suspension of stanozolol may result in more variable rates of dissolution as a result of differences in the product formulation; caution must be observed when administering these compounds because they may result in extended detection periods. In addition, repeated dose administrations or use of a dose greater than that investigated here will likely result in a longer detection period for stanozolol and withdrawal times should be adjusted accordingly.

Ban on Anabolic Steroids

In a watershed moment in the history of Australian racing, the Australian Racing Board (ARB) has today announced a total ban on the use of anabolic steroids both in and out of competition.

Anabolic steroids as synthetic derivatives of the male hormone testosterone promote protein synthesis, muscle growth, red blood cell production, tissue repair after stress and injury and appetite to meet demands for additional nutrition.

Currently in Australia anabolic steroids are only prohibited in horses on race day but the new ban will apply to all Thoroughbreds from the age of 6 months with that period allowed in the interests of animal welfare.

"The ban on anabolic steroids goes far beyond any other racing jurisdiction outside of Europe and was decided by the ARB Board after lengthy consideration of veterinary and scientific advice and consultation with trainers' and owners' associations," ARB Chief Executive Peter McGauran said.

"The ARB has adopted a zero tolerance policy to the use of anabolic steroids in competition, training and spelling and will institute heavy penalties for breaches of the ban."

"Foremost in the Board's consideration was the need for absolute integrity and public confidence in racing. Although the use of steroids has greatly diminished over the years to the point where they are rarely relied upon by trainers, the ARB believes it is in the best interests of the industry that they no longer be available for any purpose other than as a therapeutic treatment for young foals," Mr McGauran said.

"Racing is a sport and as such must be a test of the ability of the individual horse, its trainer and rider and not of the pharmacologist, veterinarian or sports scientist. The true spirit of competition means that no-one gets an unfair advantage which anabolic steroids can confer in certain situations."

"A new Australian Rule of Racing will be introduced on the 1st of November with the ban taking effect from 1 May, 2014 thereby giving 6 months for a treated horse to be free of anabolic steroids," Mr McGauran concluded.

The board of directors of the Racing Medication and Testing Consortium (RMTC) held a regular meeting September 17 in Denver, Colo.

The board:

• **Unanimously voted to recommend that stanozolol be eliminated from those substances with an RMTC recommended threshold level and to present that revision to the Association of Racing Commissioners International (RCI) for its adoption. The previous threshold allowed stanozolol to be administered up to about 30 days prior to racing. The removal of the threshold means that stanozolol will become a prohibited substance in jurisdictions adopting this recommendation and can no longer be present at any concentration in a horse on race day. Stanozolol is a synthetic anabolic steroid that was previously marketed as Winstrol™ but is now only available as a compounded product.**

BACKGROUND

Business and Professions Code section 19420 provides that jurisdiction and supervision over meetings in this State where horse races with wagering on their results are held or conducted, and over all persons or things having to do with the operation of such meetings, is vested in the California Horse Racing Board (Board). Business and Professions Code section 19440 states that the Board shall have all powers necessary and proper to enable it to carry out fully and effectually the purposes of this chapter. Responsibilities of the Board shall include, but not be limited to, adopting rules and regulations for the protection of the public and the control of horse racing and pari-mutuel wagering. Board Rule 1561, Duties of the Racing Veterinarian, provides that the Racing Veterinarian shall be present in the paddock, on the race course, and at the starting gate during the saddling, the parade, and until the horses are dispatched from the gate for the race, and he shall examine any horse when there is a question as to the physical condition of such horse. The racing Veterinarian shall examine any horse which appears in physical distress during the race, at the finish of the race and he shall report such horse together with his opinion as to the cause of the distress to the stewards and to the official veterinarian. The Racing Veterinarian has the authority to treat any horse in event of an emergency, accident or injury, and he is authorized to humanely destroy any horse which in his opinion is so seriously injured that it is in the best interests of racing to take such action.

In late September 2013 comments were received to the effect that the Board does not require racing associations or training facilities to have a qualified veterinarian on the grounds during training. The Equine Medical Director stated the issue had been raised in the past. In 2007 and 2008 Fairplex Park Pomona closed on Sundays during the Del Mar meeting because of the difficulty of getting a veterinarian on site during training hours. He added Pleasanton, Golden Gate Fields and Santa Anita have not had issues because a number of veterinarians live close to the tracks, and the tracks are well serviced by private veterinarians. The Santa Anita stewards provide that if a veterinarian is needed during training, private veterinarians are usually onsite. Del Mar arranges for a local veterinarian to be on call, but not necessarily on the grounds. The Equine Medical Director also stated Los Alamitos often has no private veterinarians available on track during the later races, and some of the racing fairs are "hit and miss".

BACKGROUND

Business and Professions Code section 19440 provides that the Board shall have all powers necessary and proper to enable it to carry out fully and effectually the purposes of this chapter. Responsibilities of the Board shall include licensing of each racing association and all persons, other than the public at large, who participate in a horse racing meeting with pari-mutuel wagering. Business and Professions Code section 19460 states all licenses granted under this chapter shall contain such conditions as are deemed necessary or desirable by the Board for the best interests of horse racing and the purposes of this chapter. Business and Professions Code section 19481.3 states every racing association and racing fair licensed pursuant to this article shall maintain, staff and supply an on-track first aid facility, that may be either permanent or mobile, and which shall be staffed and equipped as directed by the Board. An ambulance licensed to operate on public highways provided by the track shall be available at all times during live racing and shall be staffed by two emergency medical technicians licensed in accordance with Division 2.5 of the Health and Safety Code, one of whom may be an Emergency Medical Technician Paramedic. Board Rule 1433, Application for License to Conduct a Horse Racing Meeting, incorporates by reference the form "Application for License to Conduct a Horse Racing Meeting CHRB-17 (Rev. 7/11) (CHRB-17), and Application for License to Conduct a Horse Racing Meeting of a California Fair CHRB-18 (Rev. 7/11) (CHRB-18). The form is to be submitted by racing associations seeking a license to operate a race meeting. The CHRB-17 and CHRB-18 require, among other items, that the association or racing fair describe its ambulance services. Board Rule 1468, Ambulance Service, provides that the association shall provide the services of an ambulance and its properly qualified attendants at all times during the running of races at its meeting, or during the hours the association acts under an agreement as an auxiliary training and stabling facility for a host association.

In 2011 the Board amended Rule 1433 to modify the forms CHRB-17 (Sections 15A and 15B) and CHRB-18 (Section 14) to require the applicant association to certify under the "Emergency Services" section, that the ambulance service paramedic staff is licensed with the California Emergency Medical Services Authority. The amendment was adopted by the Board at its October 2011 Regular Meeting and was effective in January 2012. The "Emergency Services" section of both applications requires the association to provide information regarding ambulance services to be used during workouts, as well as workouts at auxiliary sites. This means there should be an ambulance on-track during morning exercise, and present at off-site tracks during workouts.

Board Rule 1468(a) requires that the association provide the services of an ambulance and its properly qualified attendants during the hours the association acts under an agreement as an auxiliary training and stabling facility for a host association. Rule 1468(d) also provides that if a training facility is not subject to the provisions of subsection 1468(a) it shall either meet the requirements of subsection (a) or submit for approval by the Executive Director a written plan specifying emergency procedures for accidents at the facility. Golden Gate Fields and Santa Anita Park Race Track have provided there is an ambulance on the grounds during morning exercise.

1468. Ambulance Service.

(a) The association shall provide the services of an ambulance and its properly qualified attendants at all times during the running of races at its meeting, or during the hours the association acts under an agreement as an auxiliary training and stabling facility for a host association.

(b) The association shall also provide the services of a horse ambulance at all times during the running of races at its meeting or during the hours the association permits the use of its race course for training purposes.

(c) A means of communication shall be provided by the association between a place of observation of the race course and the place where the required ambulances and their attendants are posted for prompt response in the event of accident to any person or horse.

(d) If the training facility is not subject to the provisions of subsection (a) it shall either meet the requirements of (a) or, in the alternative, submit for approval by the Executive Director or a designated representative, a written plan specifying emergency procedures for accidents at the facility, which shall include but not be limited to:

(1) A list, which includes response times, of at least two emergency medical services to be used by the facility, and at least two alternative emergency medical services to be used in the event the primary service is not available. The list may utilize a combination of ambulance services, fire departments or police services.

(2) The names of one or more facility employees with access to emergency first aid equipment and the location and nature of such equipment.

(3) The names of one or more facility employees who are trained in basic first aid and who hold a current Cardiopulmonary Resuscitation (CPR) certification.

(4) The type and location of communication equipment, such as telephone or hand held radios, to be provided as a means for facility staff to contact emergency medical services.

(5) The locations on the facility where emergency medical service information is posted for public access. Such information shall include but not be limited to emergency telephone numbers of ambulance, fire and police services.

(e) The Executive Director or a designated representative shall, within 30 calendar days from the date the plan is received at Board headquarters, approve or disapprove, stating the reasons for disapproval, in writing the emergency plan submitted by the facility.

(1) An emergency procedure plan shall be disapproved if it fails to meet any of the requirements of subsections (d)(1) through (d)(5).

(2) Upon disapproval of an emergency procedure plan by the Executive Director or a designated representative, a revised emergency plan may be submitted to Board headquarters within 10 working days of the date the facility is notified of the disapproval.

(3) The Executive Director or a designated representative shall, within 10 working days from the date the revised plan is received at Board headquarters, disapprove or approve in writing the revised emergency plan submitted by the facility.

NOTICE TO APPLICANT: All funds generated and retained from on-track pari-mutuel handle which are obligated by law for distribution in the form of purses, breeders' awards or other benefits to horsemen, **shall not** be deemed as income to the fair and **shall**, within 3 calendar days following receipt, be deposited in a segregated and separate liability account in a depository approved by the CHRB and shall be at the disposition of the Paymaster of Purses, who shall pay or distribute such funds to the persons entitled thereto. All funds generated from off-track simulcast wagering, interstate wagering, and out-of-state wagering which are obligated by law for distribution in the form of purses and breeders' awards, shall also be deposited within 3 calendar days following receipt into such liability account. In the event the fair is obligated to the payment of purses prior to those obligated amounts being retained from pari-mutuel wagering for such purpose, or as a result of overpayment of earned purses at the conclusion of the meeting, the fair shall transfer from its own funds such amounts as are necessary for the Paymaster of Purses to distribute to the horse owners statutorily or contractually entitled thereto. The fair is entitled thereafter to recover such transferred funds from the Paymaster of Purses' account; and if insufficient funds remain in the account at the conclusion of the meeting, the fair is entitled to carry forward the deficit to its next succeeding meeting as provided by Business and Professions Code section 19615(c) or (d). (b) Each racing association and racing fair shall adopt and maintain an emergency medical plan detailing the procedures that shall be used in the event of an on-track injury. The plan shall be posted in each jockey room in English and Spanish. (c) Prior to every race meeting, the racing association or racing fair shall contact area hospitals to coordinate procedures for the rapid admittance and treatment of emergency injuries. (d) Each racing association or racing fair shall designate a health and safety manager and assistant manager, who shall be responsible for compliance with the provisions of this section and one of whom shall be on duty at all times when live racing is conducted. The health and safety manager may, at the discretion of the racing association, be the person designated to perform risk management duties on behalf of the association.

Medication and Track Safety Committee Meeting
October 23, 2013

BACKGROUND

Breeder's Cup veterinary services and emergency teams will be very similar to past years. Breeder's Cup brings in an international veterinary inspection consisting of six veterinarians the weekend before the Breeder's Cup event which is supplemented by four California based official and track veterinarian. All horses are examined multiple times at their barns during the week and observed under tack by members of the team while training on the track. Multiple teams will examine the horses on the morning when the horses race. Each team on the morning of the race will have an experienced CHRB official veterinarian or California track (racing/association) veterinarian.

The emergency veterinary teams will consist of two track veterinarian teams and a third team in the paddock. Dr. Stead is the lead track veterinarian; Dr. Grant will lead the second on-track veterinarian team. Dr. Stead attends the starting gate; Dr. Grant's team will be assigned as appropriate for each race, usually the ¼ mile chute. Each team will have multiple veterinarians. There are three horse ambulances at Santa Anita for Breeder's Cup. Two are assigned to the track; the third is a backup ambulance and can be sent to the paddock with a veterinary team if necessary. Each ambulance will have a horse handler and a veterinarian. In addition to the Breeder's Cup veterinarians and aforementioned California track veterinarians, the veterinary emergency teams include faculty for University of California, Davis and Colorado State University veterinary schools. The Southern California Equine Hospital will be fully staffed as it has been each Breeder's Cup event at Santa Anita.

Independent CHRB licensed veterinarians will administer Lasix in Breeder's Cup races where Lasix is permitted as was done at the 2012 Breeders' Cup event. Breeder's Cup will be conducting a voluntary post-race endoscopic examination survey with an independent team of veterinarians brought in for the purpose.

Breeder's Cup provides a Horsemen's Information Guide to all participants well in advance of the event (<https://members.breederscup.com/doc%20repository/other/HIG.pdf>). The CHRB Safety Steward visits each trainer's stable and provides them with an overview of important CHRB regulatory issues and related procedures for the Breeder's Cup races.

Bleeder Registration: All horses must be registered with the California Horse Racing Board (CHRB) by entry time to receive Lasix even if they have run elsewhere as a bleeder. This is a required process for a horse to be treated with Lasix in California and is simply accomplished by submitting form CHRB-194 to the official veterinarian. The form CHRB-194 is available at the Receiving Barn , on p. 121 of the Breeders' Cup Horsemen's Guide and attached here.

Two-Year Old Breeder's Cup races will No Lasix: 2YO's will not be allowed to start in Breeders' Cup races if they are on the CHRB Bleeder List. If a 2YO is on the CHRB Bleeder List form CHRB-194 is used to remove the horse from the list. Breeders' Cup Juvenile Fillies Turf (GI), Breeders' Cup Juvenile Turf (GI), Breeders' Cup Juvenile Fillies (GI), Breeders' Cup Juvenile (GI), AND the 300 North Capital Juvenile Turf Sprint Stakes are NO LASIX races. The CHRB official veterinarians will allow horses to be placed back on the CHRB Bleeder List after the Breeders' Cup races without restrictions.

Two-Year Old preliminary races will be run with Lasix by private veterinarians. The Golden State Juvenile Fillies Stakes and Golden State Juvenile Stakes will be CHRB authorized bleeder medication by private veterinarian. NOTE: the 300 North Capital Juvenile Turf Sprint Stakes is a Breeder's Cup 2YO, NO LASIX race.

Voluntary Two-year Old Post-race Endoscopic examinations: Breeder's Cup will be conducting a voluntary post-race endoscopic examination survey of all 2YO for EIPH at no cost to owners. Owners and trainers of horses in ALL two-year old races are encouraged to participate. Details are available at the Breeder's Cup offices. The post-race endoscopic examination agreement is attached.

Race Day Lasix Administration for Breeders' Cup Races: Bleeder medication is limited to Lasix and only Breeders' Cup veterinarians will be allowed to administer Lasix on race day in Breeders' Cup races. The standard Lasix dose will be 5cc (250mg). The CHRB allows a single IV dose of Lasix of between 150mg (3cc) and 500mg (10cc). If a trainer wishes to vary from the 5cc dose he or she must inform the Breeder's Cup Lasix veterinarians on the attached form prior to the Lasix being administered. **The signature of your attending veterinarian will be required to change the Lasix dosage.** Trainers are reminded that higher Lasix dosages may affect TCO₂ levels. Lasix will be administered between 4 and 4 ½ hours prior to race time. Lasix cannot be administered within 4 hours of post time. By regulation, an attendant must be present at the time the Lasix is administered. The attendant will be required to sign CHRB Bleeder Treatment form (CHRB-36) after the Lasix is administered. Horses receiving Lasix on race day are assigned to a pre-race security stall by regulation which is designated by a yellow detention stall placard available at the Receiving Barn.

Race Day Bleeder Medication Administration for Non-Breeders' Cup Races: The first five (5) races and the last race on Friday and the Damascus Stakes (2nd race) and Ken Maddy Stakes (3rd race) on Saturday are not Breeders' Cup races. Those races will be run under standard CHRB policies. The attending veterinarians will be responsible for authorized bleeder medications for those races.

TCO₂ Testing: All horses in every race will be sampled and tested for TCO₂. The CHRB has a very tight regulation for TCO₂. The permitted level is 37mmol/l whether a horse receives furosemide or not. All horses will be tested as they enter the Receiving Barn for their race, about 45 minutes pre-race. Exceeding 37mmol/l is a Class 3 violation requiring purse redistribution and is a Category B penalty for the trainer. While not specifically prohibited under CHRB regulations until 24 hours prior to post time, electrolytes with or without alkalizing agents-bicarbonate or otherwise, should be used with caution especially if a horse is on the bleeder's list. Regardless, electrolytes cannot be administered by nasogastric tube within 48 hours of post time of the race.

Nasogastric Tubing of Electrolytes: Nasogastric (tubing) administration of any substance or medication is prohibited within 48 hours of post time of the race in which a horse is entered.

Water Only on Race Day: This is a very strict and clear rule. Nothing other than water can be used to flush a horse's mouth on race day. Wind Aid, glycerin or anything other than water will result in a scratch. Horses have been scratched from Grade I events for this violation and the policy will be the same for the Breeders' Cup.

NSAID Medications: One of three NSAID's are allowed as long as they are administered outside of 24 hours prior to post time and do not exceed permitted threshold levels in post race testing. The permitted NSAID's are phenylbutazone, flunixin (Banamine) or ketoprofen; only one approved NSAID may be present in the post race blood test. Phenylbutazone cannot exceed 2micrograms/ml; flunixin cannot exceed 20nanograms/ml and ketoprofen cannot exceed 10nanograms/ml. For phenylbutazone, a 2gm (10 cc) dose of phenylbutazone at 28-30 hours prior to racing or a 1.5gm (7½ cc) at 24 hours prior to racing will avoid an inadvertent phenylbutazone violation. Contact you private veterinarian, CHRB official veterinarian Dr Grande (626-574-6355) or CHRB equine medical director Dr. Arthur (626-574-6351) if you have any questions.

No Medications Allowed after Entry: No medication may be administered after entry except as specifically authorized in the rules and there are few exceptions. The relevant CHRB rules are 1843, 1844 & 1845. They are available at www.chrb.ca.gov; go to Horse Racing Rules. You may also contact you private veterinarian, CHRB official veterinarian Dr. Grande (626-574-6355) or CHRB equine medical director Dr. Arthur (626-574-6351) if you have any questions. Entry for the purposes of this rule is defined as 48 hours prior to the post time of the race the horse is entered to race.

Procaine Penicillin: The CHRB offers free testing for procaine in horses treated with procaine penicillin and has done so for years. Any horse treated with procaine penicillin in the last 30 days should be tested. The CHRB has provision which allows a horse treated with procaine penicillin to participate in races under certain conditions. Contact CHRB official veterinarian Dr Grande (626-574-6355) or CHRB equine medical director Dr. Arthur (626-574-6351) if there are any questions.

Shoe Policy: Restrictions on horse shoes are in place for Breeders' Cup and Santa Anita races. Refer to the Santa Anita condition book or contact Horseshoe Inspector Victor Tovar at the Receiving barn if you have any question. Toe grabs cannot exceed 4mm on the front shoes for main track races by CHRB regulation or 2mm on Queen XT's on the turf course by Santa Anita policy.

Geldings: Even though highly unlikely in Breeder's Cup races, trainers are reminded a first time gelding must be reported to the racing office and Horse ID when entered.

Clenbuterol: California has suspended an authorized level for clenbuterol as of July 18, 2012. Accordingly, any level of clenbuterol in a post-race test is a violation. Clenbuterol is a Class 3 violation requiring a disqualification and purse redistribution. The CHRB recommends a 21 day withdrawal time. The CHRB offers pre-race testing

for clenbuterol. There are time constraints related to this program in terms of shipping and testing the samples. Contact CHRB official veterinarian Dr Grande (626-574-6355) or CHRB equine medical director Dr. Arthur (626-574-6351) if there are any questions.

Breeder's Cup Race Day Lasix Administration

Bleeder medication is limited to Lasix only and only Breeders' Cup veterinarians will be allowed to administer Lasix on race day. **The standard (default) Lasix dose will be 5cc (250mg).** The CHRB allows a single IV (intravenous) dose of Lasix of between 150mg (3cc) and 500mg (10cc). If a trainer wishes to vary from the 5cc dose he or she must inform the Breeder's Cup Lasix veterinarians on the attached form prior to the Lasix being administered. Trainers are reminded that higher Lasix doses may affect TCO₂ levels. Lasix will be administered between 4 and 4 ½ hours prior to race time. Lasix cannot be administered within 4 hours of post time. By regulation, an attendant must be present at the time the Lasix is administered. The attendant will be required to sign CHRB Bleeder Treatment form (CHRB-36) after the Lasix is administered.

The default dose will be 5cc's (250mg) of Lasix (furosemide). You do not need to complete and turn in the information below if the Lasix dosage you wish your horse to receive is 5cc's (250mg) of Lasix (furosemide).

Trainers are advised Lasix elevates TCO₂ levels and there is limited data suggesting higher dosages elevate TCO₂ levels higher. The decision to use Lasix and at what dosage within CHRB regulations is the decision of trainer after consultation with his or her veterinarian.

Breeder's Cup Endoscopy Agreement

The 2013 Breeders' Cup World Championships racing card will include five two-year-old races which will run on Friday, November 1 and Saturday, November 2 under conditions that require all two-year-old entrants in Breeders' Cup races to refrain from having medications or any other unauthorized substances administered within 24 hours of post time, including authorized bleeder medications otherwise permitted by state regulation. In addition, there will be two undercard races conducted on Friday, November 1 where no such restrictive conditions will apply.

Breeders' Cup Limited will be asking the connections of all two-year-old horses to participate in a voluntary observational endoscopy survey of these two-year-old entrants after they have competed over Championship weekend. The results of this survey will be compiled and made available to interested parties to help understand the effects of the presence or absence of furosemide (Lasix or Salix) on the condition known as exercise induced pulmonary hemorrhage (EIPH) in the Thoroughbred.

The endoscopy will be performed in the horse's home stall with a video endoscope 30 to 90 minutes after completion of the race by a team of specialist veterinarians (Drs. Hunt, Spirito & Slovis of Hagyard Equine Medical Institute, Lexington KY) brought in for this purpose at no cost to you or, if you prefer, a veterinarian of your choice using the Breeder's Cup supplied video endoscope. The procedure will be observed by a Breeders' Cup Limited veterinary expert in endoscopic exams who will record and make a report of the examination, maintaining the anonymity of the horse. The endoscopy results, which will include digital images, will be made available to your private veterinarian. When completed the data and images, coded to protect anonymity, will be forwarded to an independent research team for compilation and evaluation of results. At no time will the two-year-olds participating or not participating in the survey be identified individually.

We request that your horse, _____, participate in this survey. If you agree to your horse's participation in the survey, please execute this document in the space indicated below. You acknowledge that participation in this survey is not a condition of entrance to race. Further, you agree that our veterinary expert in endoscopic exams may have access to all information pertaining to the endoscopy exam of your horse.
