

## COMPLAINT

The CHRB hereby files a complaint against **ROGER STEIN** for violation of CHRB Rule **1843 (a)(b), 1843.1 (a), 1887**. The person named in this complaint holds a license as a **TRAINER**, license number **103386**. The offense alleged occurred on or about **MAY 1, 2014** and

is as follows:

**THE OFFICIAL SAMPLE SA15904 TAKEN ON MAY 1, 2014, AT SANTA ANITA WAS REPORTED BY SCOTT STANLEY OF UC DAVIS LABORATORY TO CONTAIN NORPSEUDOEPHEDRINE A METABOLITE OF PSEUDOEPHEDRINE AND O-DESMETHILPYRILAMINE A METABOLITE OF PYRILAMINE. THIS SAMPLE WAS OBTAINED FROM THE HORSE LUCKBOX SAM, WHICH RAN IN THE 4<sup>TH</sup> RACE AND FINISHED 2<sup>ND</sup>. THE TRAINER OF RECORD IS ROGER STEIN.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
