

## COMPLAINT

CASE NUMBER: **15GG0126**

The CHRB hereby files a complaint against **Candido Galeote** for violation of CHRB Rule **1843(a),(b)&(d), 1843.1(a), 1844(a), 1844(e)(6), 1887(a), 1902(c), 1588(j), 1859.5**. The person named in this complaint holds a license as a **Owner**, license number **305454 Exp. 3/2016**. The offense alleged occurred on or about **9/12/15** and is as follows:

**- NOTE: AMMENDED COMPLAINT DUE TO CHANGE OF HEARING DATE - Owners Samuel and Candido Galeote medicated their two horses, Bowyer and Sparkin One, with Clenbuterol three days prior to racing them at the San Joaquin County Fairgrounds. The horses were never under the care of a licensed trainer with them being taken directly to the track from a private ranch. Both owners bypassed the need for the horses to be stabled at a CHRB Auxiliary track at least 24 hours prior to racing. Both Quarter Horses tested positive for Clenbuterol in their system.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
