

## COMPLAINT

CASE NUMBER: **16GG0044**

The CHRB hereby files a complaint against **Samuel G. Galeote** for violation of CHRB Rule **1843(a),(b)&(d), 1843.1(a), 1844(a), 1844(e)(6), 1887(a), 1902(c), 1859.5**. The person named in this complaint holds a license as a **Owner**, license number **314352 Exp. 8/2016**. The offense alleged occurred on or about **September 11<sup>th</sup>, 2015** and

is as follows:

**Owner Samuel Galeote medicated the horse, Sparkin One, who is owned by his brother, Candido Galeote, with Clenbuterol three days prior to the horse racing at the San Joaquin County Fairgrounds. The horse were never under the care of a licensed trainer with Samuel and Candido taking the horse directly to the track from a private ranch. Both owners bypassed the need for the horse to be stabled at a CHRB Auxiliary track at least 24 hours prior to racing. Sparkin One tested positive for Clenbuterol in an official urine test at a level of 427 pg/ml.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
