Issue: APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF CHURCHILL DOWNS CALIFORNIA COMPANY AT HOLLYWOOD PARK APRIL 20, 2005 THROUGH JULY 17, 2005.

Churchill Downs California Company filed its application to conduct a thoroughbred horse racing meeting at Hollywood Park:

- April 20 through July 17, 2005, or 64 race days, one day less than 2004. The association proposes to race a total of 550 races, or 8.6 per day.
- They will simulcast April 20 and 21 and live racing will begin April 22.

  - Early wagering 8:30 a.m. on the day of and advance-day wagering.
  - \$1 trifecta and \$1 superfecta on any race that complies with Rule 1979 and 1979.1.
  - Pick 6 offered on last 6 races - 70% of net pool retained for jackpot and no cap set.
  - Pick 4 on first 4 and last 4 races - major share of the pool is designated as 0%.
  - When available patrons will be given the option of an alternate selection in the place pick all, pick 6 and pick 4.
- Simulcasting conducted with out-of-state racing jurisdictions pursuant to Business and Professions Code Section 19602; and with authorized locations throughout California.
- Inspection of backstretch worker housing completed.

**NOTICE TO APPLICANT** All funds generated and retained from on-track pari-mutuel handle which are obligated by law for distribution in the form of purses, breeders' awards or other benefits to horsemen, **shall not** be deemed as income to the association and **shall**, within 3 calendar days following receipt, be deposited in a segregated and separate liability account in a depository approved by the CHRB and shall be at the disposition of the Paymaster of Purses, who shall pay or distribute such funds to the persons entitled thereto. All funds generated from off-track simulcast wagering, interstate wagering, and out-of-state wagering which are obligated by law for distribution in the form of purses and breeders' awards, shall also be deposited within 3 calendar days following receipt, into such liability account. In the event the association is obligated to the payment of purses prior to those obligated amounts being retained from pari-mutuel wagering for such purpose, or as a result of overpayment of earned purses at the conclusion of the meeting, the association shall transfer from its own funds such amounts as are necessary for the Paymaster of Purses to distribute to the horse owners statutorily or contractually entitled thereto. The association is entitled to recover such transferred funds from the Paymaster of Purses' account; and if insufficient funds remain in the account at the conclusion of the meeting, the association is entitled to carry forward the deficit to its next succeeding meeting as provided by B&P Code Section 19615(c) or (d). 



**STAFF ANALYSIS  
ALLOCATION OF HARNESS DATES**

**REGULAR BOARD MEETING  
FEBRUARY 17, 2005**

**Background:**

During the 2005 dates allocation process, the Board allocated harness dates to the Cal Expo facility in Sacramento through July 31, 2005. No dates were allocated for the remainder of 2005 since the harness industry was unclear about its future plans due to the lease at Cal Expo that expires on or about July 31, 2005. However, in the intervening months Cal Expo has moved forward with plans to lease its facility to a harness operator after July 31 and has requested an allocation of dates (September 23 through December 18, 2005). In addition, the Los Angeles County Fair at Pomona has also made arrangements for a harness meet at its racing facility and is requesting an allocation of dates (October 7 through December 23, 2005).

Because of the overlapping requests for a date allocation the harness horsemen's association (the CHHA) held a meeting to discuss this issue. The CHHA Board of Directors voted (5 to 4) to support Cal Expo's request for harness dates.

**Recommendation:**

Staff recommends that the Board refer this matter to the Race Dates Committee.

Dear Sir or Madam:

This office represents Pari-Mutuel Employees Guild, Local 280. This letter is intended to supplement the letter of November 19, 2004, in which Richard Castro, the President of Local 280, objects to the applications for licenses to conduct advance deposit wagering submitted by three entities. These are action items 4, 5 and 6 on the Board's agenda set for December 2, 2004.

Business and Professions Code Section 19604 is a statutory authorization for advance deposit wagering. Section (c)(1) governs the issue which Local 280 is raising before the Board:

Betting systems and multi-jurisdictional wagering hubs located and operating in California shall be approved by the Board prior to establishing advanced deposit wagering accounts or accepting wagering instructions concerning those accounts and shall enter into written contractual agreement with the bona fide labor organization that has historically represented the same or similar classifications of employees at the nearest horse racing medium.

The same statute authorizes the Board to "develop and adopt rules to license and regulate all phases of operation . . ." The Board's rules which had been adopted are clear in this regard. Section 2071 applies to advanced deposit wagering conducted by an applicant located in California. The rule provides:

Applicants shall enter into a written contractual agreement with a bona fide labor organization that has historically represented the same or similar classifications of employees at the nearest horseracing medium.

Section 2071 (i)

Section 2072 applies to applicants establishing advanced deposit wagering out-of-state. Rule 2072 (n) states as follows:

Page 2

By submitting the Application the out-of-state Applicant consents to the jurisdiction of California courts and the application of California law as to all California wagers and operations.


Item 6 of the Board's agenda concerns XpressBet, Inc. This application is for a "California multi-jurisdictional wagering company. Plainly, this is an in-state application which is governed by the rule cited above.

Item 5 is an application by Youbet.Com, Inc. This is an application for a "California multi-jurisdictional wagering hub . . . and out-of-state multi-jurisdictional wagering hub." The rules also apply to this application.

Finally, the application of ODS Technologies, L.P. is for an "out-of-state multi-jurisdictional wagering hub." None of the applicants has indicated that it has obtained the appropriate contractual relationship with the appropriate labor organization. In fact, none has such an appropriate collective bargaining agreement.

We have been authorized to seek injunctive relief, if the Board approves these applications in violation of the Business and Professions Code and the Board's rules all of which are mandatory. The applicant must in all cases have the appropriate contractual relationship. None does and none of these applications may be approved.

**RE: OPPOSITION TO RE-LICENSE ADW OPERATORS**

I'm sending this letter to be placed in the C.H.R.B. packet. I request this be on record, that Pari-Mutuel Employees Guild, Local 280 is and will remain in **OPPOSITION** until a provision is included to make it mandatory that live phone operators be utilized solely in California, as a condition if wagers are taken from California Race Tracks.

When we gave our support for this legislation, it was with the understanding that we would have live phone operators taking bets based in California. In addition, there was considerable discussion that the Hubs of these businesses should also be housed in California. **Neither of these working environments have taken place to our satisfaction, thus the opposition position on this issue.**

We understand that maybe the law needs to be changed to add more teeth to our position, which we are willing to actively support. We would accept a proposal if it could be demonstrated within a reasonable amount of time that these companies taking California Race Track wagers, would in fact adopt a policy to include full service live phone operators based in California.

BACKGROUND

Business and Professions (B&P) Code Section 19420 states jurisdiction and supervision over meetings in California where horse races with wagering on their results are conducted, and over all persons or things having to do with the operation of such meetings is vested in the California Horse Racing Board. B&P Code Section 19562 provides that the Board may prescribe rules, regulations and conditions under which all horse races with wagering on their results will be conducted in this state. Board Rule 1615, Scale of Weights For Age, mandates the weights to be carried if the conditions for a race do not specify otherwise.

At the March 25, 2004, Regular Board Meeting, the Jockeys' Guild (Guild) proposed an increase in California's jockey weight allowances. After hearing the proposal the Board directed staff to draft amendments to Board rules affecting jockey weights. At the June 3, 2004, Regular Board Meeting proposals to amend rules 1615, Scale of Weights for Age, and 1420, Definitions, and to repeal rules 1616, Minimum Weights to be Carried and 1684, Items Included in Weight, were presented. The Board directed staff to initiate a 45-day public comment period for the proposed amendments. The proposals to amend rules 1615 and 1420, and repeal rules 1616 and 1684, were heard for adoption at the August 19, 2004, Regular Board Meeting. After extensive testimony, the Board directed staff to prepare a modified text of Rule 1615 for consideration at a future Regular Board Meeting.

ANALYSIS

The proposal to amend Rule 1615 would replace the scale of weights for age of the horse and set new minimum weights for California jockeys. The original proposal set minimum weights for jockeys riding an Arabian or Thoroughbred horse at 118 pounds. This weight has been changed to a minimum weight of 116 pounds. For jockeys riding an Appaloosa, Paint, Quarter Horse or mule, the minimum weight has been changed from 123 pounds to 121 pounds. In addition the minimum weights in handicap races is 112 pounds. The requirement that every horse shall carry ten pounds of riding gear from withers to rump has remained unchanged. However, the official program would be required to state the jockey's actual

weight, the weight of the equipment and the combined total weight of jockey and equipment. The proposed amendment to Rule 1615 does not alter or affect apprentice allowances, but if an allowance is used, the minimum weight may be reduced by the amount of the allowance. The original proposal to amend Rule 1615 provided one body fat measurement for male and female jockeys. However, as minimum body fat requirements are different for men and women, the requirement was modified to include minimums for both genders. The new text provides for a minimum body fat content of 10 percent for female jockeys. Finally, subparagraph (h) of the proposed amendment to Rule 1615 exempted jockeys licensed in the United States before December 31, 2004, from the minimum body fat requirements for a period of 24 months commencing June 1, 2005.

No changes were made to the proposal to amend Rule 1420, or the proposed repeal of rules 1616 and 1684.

The modifications to the proposed amendment of Rule 1615 are substantive and would require a 45-day public comment period.

1420. Definitions.

As used in these rules:

(a) "Chairman" means the member elected by the Board to be Chairman of the Board and its presiding member.

(b) "Commissioner" means a member of the Board.

(c) "Age of Horse" means the age as reckoned beginning on the first day of January of the year in which the horse was foaled.

(d) "Authorized Agent" means an agent appointed by a written document, which is signed by the owner and filed with the Board.

(e) "Breeder" means the owner of the dam at the time of foaling.

(f) "Conviction" includes a plea of guilty, forfeiture of bail, a judgment or verdict of guilty, or a conviction following a plea of nolo contendere, whether or not the conviction is later set aside pursuant to the provisions of Section 1203.4 of the Penal Code.

(g) "Driver" means one who drives and controls the horse from a seated position on a two-wheel vehicle.

(h) "Horse" means an equine and includes a stallion, gelding, mare, colt, filly or ridgling and includes mule, jack, jenny, ginnet, and hinney.

(i) "Jockey" means a race rider.

(j) "Licensee" means a licensee of the California Horse Racing Board.

(k) "Maiden" means a horse which has never won a race on the flat in a state or country where the races are covered by the Daily Racing Form or other similar authorized publication. A maiden which has been disqualified after finishing first is still a maiden. Conditions referring to maidens apply to the status at the time of starting.

(l) "Nominator" means a person in whose name a horse is entered to race.

(m) "Objection" means a formal complaint filed before a race with the stewards or the Board objecting to the eligibility of any horse to compete in the race or the right of any person to participate in the race.

(n) "Owner" includes the owner, part owner and lessee of any horse. An interest only in the earnings of a horse does not constitute ownership. If husband and wife, it is presumed that joint ownership exists.

(o) "Post" means the place on the race course from which a start is made.

(p) "Post Time" means the definite time for the start of a race, and is indicated by a clock device set up as directed by the Board.

(q) "Premises" means the inclosure and all other areas collectively utilized by an association in connection with its conduct of a licensed race meeting, including parking lots, auxiliary stabling areas, public inclosure and restricted areas, whether or not the areas are adjacent to the inclosure.

(r) "Protest" means a formal complaint filed after a race with the stewards or the Board protesting the right of any horse to a place, purse or award in the race, or protesting any

decision of the stewards relating to the eligibility, participation or placing of any horse in a race.

(s) "Race" means a contest among horses for a purse, stake or reward, contested at an authorized race meeting. "Race" includes but is not limited to:

(1) Purse Race. A race for money or any other prize to which the owners of the horses engaged do not contribute.

(2) Stake Race. A race for which owners of horses entered or engaged for the race contribute to a purse for which money or any other prize may be added, nominations to which close 72 hours or more before starting.

(3) Claiming Race. A race in which any horse entered therein may be claimed in conformity with the rules established by the Board.

(4) Handicap Race. A race in which the weights to be carried by the entered horses are adjusted by a handicapper, board of handicappers or the racing secretary, to equalize their respective chances of winning.

(5) Overnight Race. A race in which entries close 72 hours or less, excluding Sundays, in advance of the first race of the day on which the race is to be run.

(6) Walkover. A stake race in which only one horse starts or in which all the starters are owned by the same interest.

(7) Invitational Stake Race. An invitational stake race or an invitational handicap race for which owners do not contribute to the purse, but which is advertised in the regular stakes program, shall also be considered a stake race.

(8) Non-wagering Race. A race contested without pari-mutuel wagering on its results including a race upon which pari-mutuel wagering is canceled.

(9) Match Race. A race contested between two horses under conditions of the contest agreed to by their owners.

(10) "Special Racing Event". A race of unique interest, magnitude or fame. "Special racing event" shall also mean an exhibition race when approved by the Board.

(11) "Exhibition Race". A race contested under conditions established by the association as a promotional event or to provide a special racing opportunity to a particular horse or class of horse or class of participants and to which the association contributes the purse or awards for the contest. No pari-mutuel wagering may be conducted on the results of an exhibition race.

(t) "Race on the Flat" means a race run over a course on which no jumps or other obstacles are placed.

(u) "Recognized Meeting," "Race Meeting," or "Authorized Meeting" means the entire period under the conduct of an association within the inclosure of the designated grounds, and for which a license has been granted by the Board. When the context in the rules applies, it may include a meeting conducted by an association in some other jurisdiction recognized by the Board.

(v) "Restricted Area" means those areas within the inclosure where admission can be obtained only upon presentation of authorized credentials, proper license or visitor's pass, including those areas designated as the stable area, receiving or detention barn, jockey room, saddling paddock, race course and pari-mutuel department.

(w) "Rules" means the Rules and Regulations of the California Horse Racing Board and the orders of the Board.

(x) "Starter" means a horse when it is in the starting gate stall, and, when the field is dispatched by the starter, the stall gate in front of the horse is opened.

(y) "Sulky" means a dual wheel racing vehicle with dual shafts not exceeding the height of the horses withers. Shafts must be hooked separately on each side.

(z) "Time of Race Meeting" means that period of time commencing at 12:01 A.M. on the first day of racing at a recognized meeting and concluding at 12:00 midnight after the final race of the last day of racing as allocated and licensed by the Board.

~~(aa) "Weight for Age" means the standard weight to be carried by a horse according to the scale established by the rules, and remains such though there be penalties or allowances.~~

(b) The official program shall separately designate the jockey's actual weight, the weight of the equipment from the withers to the rump as specified in subsection (a), and the combined total weight of the jockey and the equipment.

(c) "Jockey weight" means the weight of the jockey, nude, absent any riding gear or clothing, as recorded by the clerk of scales when the jockey is weighed. The clerk of scales will weigh and record jockey weight once each day when the jockey reports to the jockey's room in accordance with Rule 1680 of this division. If the jockey uses a robe to be weighed, its weight shall be deducted to arrive at the nude weight.

(d) The minimum jockey weight for a jockey riding an Arabian or Thoroughbred horse shall be no less than 116 pounds. The minimum jockey weight for a jockey

riding an Appaloosa, Paint, Quarter Horse or mule shall be no less than 121 pounds.

The minimum jockey weight in handicap races shall be no less than 112 pounds.

(e) Nothing in this rule shall affect or alter apprentice allowances. If the apprentice allowance is used, then the minimum weight may be reduced by the amount of such allowance.

(f) Male jockeys shall maintain a minimum body fat content of 5% and female jockeys a minimum body fat content of 10%. A jockey's body fat content shall be measured and recorded by the clerk of scales once each day of racing. A jockey whose body fat content measures within 1% below the minimum level under this Rule shall be placed on warning and suspended from riding if the minimum standard is not met within three calendar days of the date of the warning. A jockey whose body fat content measures more than 1% below the minimum level under this Rule shall disqualified from riding in any race.

(g) Compliance with subsection (f) of this rule is optional for 24 months, commencing June 1, 2005, for any jockey licensed in the United States before December 31, 2004.

**Background:**

At the October 2004 meeting, the Board asked Capitol Racing, LLC, (Capitol) to provide audited financial statements and a \$1 million bond or irrevocable letter of credit. While waiting for those items to be delivered, the California Harness Horsemen's Association (CHHA) sent the CHRB a letter in which they questioned the distribution of the harness handle with regard to three items: the excess SCOTWINC expense funds, the outs and refunds on imported races, and the splitting of the funds per Section 19605.7(c).

The disposition of the above items is as follows:

- The CHRB received an audited balance sheet from Capitol. However, there were several items on the balance sheet that in the opinion of the CHRB staff does not meet the test of valid assets. When adjusted for those items, the "members capital" in the LLC is essentially zero.
- An "irrevocable" letter of credit was delivered to the CHRB. However, in the opinion of the Board's counsel and staff, the letter of credit is revocable (see paragraph 3) and as such, does not satisfy the Board's October request. It should be replaced with an appropriate instrument that provides the Board and others with the proper financial protection.
- Per Horse Racing Law, the outstanding tickets and refunds on imported races are to be split equally between the association and purses. All other outs are to be split between the State of California and a harness backstretch welfare fund. Instead, Capital split all outs between the State and the welfare fund thus shortchanging themselves as well as the purses by about \$48,000 each in 2004. Staff will take steps to correct this matter for future distributions but it probably is not practical to make retroactive changes since the welfare fund is for the horsemen. However, it would be their decision if they wish to transfer money from the welfare fund to the purses.
- The Horse Racing Law allows for a simulcast expense fund that is fed by a percentage of the off-track handle. For harness meets, this fund generally has a sizeable surplus at the end of each year. SCOTWINC administers this fund and makes an annual reimbursement for the excess of expense money. This money is then split between Capitol and the purses. Staff has found that Capitol has properly distributed this money.
- Per Horse Racing Law .5% of the simulcast handle will be shared by the association and the purses. The split of these funds is to be in a written agreement for each meet per Section 19605.7(c). Although Capitol has maintained that they had an unwritten agreement with the horsemen that 100% of these funds would go to Capitol, the horsemen's association has

made it clear to CHRB staff that they had no such an agreement. The purse agreements between Capitol and the CHHA are the only written agreements between the two parties that staff has in hand for the race meets in Sacramento. These agreements indicate that all monies from simulcasting will be split 50-50. As such, it would appear that Capitol has incorrectly withheld approximately \$1.1 million from the harness purses over the last three years. Since there is an accumulated overpayment of purses at the Capitol meets of approximately \$2.1 million, this adjustment would reduce that overpayment by slightly more than half. Staff will work with Capitol to determine the exact amount of the misdirected funds and assure that the proper adjustment is made to the purse account.

**Recommendation:**

Staff recommends that the Board direct Capitol to work with staff to address the incomplete items outlined above and to make the necessary adjustments to the purse account.

Capitol Racing, LLC (the "Company") is a California limited liability company which engages in the operation of harness races and the transmission of television simulcasts of these races. The Company believes that, under legislation passed in 1999, they are not legally obligated to pay the impact fees. The matter was taken before an Administrative Law Judge (ALJ) who ruled in the Company's favor and denied the claim of Los Alamitos. The California Horse Racing Board (CHRB), despite the ALJ's ruling, subsequently directed the Company to pay impact fees to Los Alamitos.

The Company has taken exception and is currently litigating the CHRB's directive. The Company's legal counsel believes that the Company is likely to prevail and will not be obligated to pay the fees. Los Alamitos' claim for impact fees, as of December 31, 2003 is in excess of \$3,500,000. In the event the litigation is settled unfavorably to the Company, management contends that 50%, or approximately \$1,750,000 of this amount would be paid by the horsemen's purse pool. The amount of the impact fees liability has not been determined because it is contingent upon the outcome of the current litigation and is therefore not recorded on the Company's financial statements.

In conjunction with the pending litigation, the Company has deposited \$553,419 into a restricted cash account and the members of the Company have posted a \$1,000,000 bond. In February 2004, the CHRB ordered the Company to pay \$500,000 of this amount held in the restricted cash account to Los Alamitos so Los Alamitos could hold these funds until the impact fee matter is resolved. The CHRB also allowed Los Alamitos to retain amounts due to the California harness horsemen's purse pool related to unopposed imported races which amounts to \$1,382,718 as of December 31, 2003. In addition, commencing in March 2004, the CHRB required the Company to deposit amounts equal to 50% of potential future impact fees, based on the original formula, into an account held by the CHRB. All of these assets will be returned to the Company if the impact fee matter is resolved in favor of the Company or will be used to pay impact fees.

NOTE 6 - OVERPAID PURSES RECEIVABLE:

The Company has in many cases paid purses that were in excess of the amount paid by the horsemen's purse pool based on the pari-mutuel formula. At December 31, 2003, overpaid purses amounted to \$754,531. The Company has substantially collected this amount in 2004.

NOTE 7 - NOTES PAYABLE TO HORSEMEN:

At December 31, 2003 the Company holds notes payable to horsemen in the amount of \$126,000 which bear interest at 10%. The notes were entirely repaid during 2004.

NOTE 8 - LEASE AGREEMENTS:

The Company leases the racetrack at the California Exposition and State Fair (Cal Expo) from the State of California which expires on July 31, 2005. The lease calls for annual lease payments of \$2,100,000 and requires the Company to expend \$200,000 per year on capital improvements. The Company can terminate the lease if the California Horse Racing Board fails to grant the Company a license to hold its harness racing meets for a minimum number of days. The lease agreement also requires the Company to provide maintenance for the facility, carry certain minimum insurance, and provides rules for sharing concessions and gate revenue.

NOTE 10 - LINE OF CREDIT:


The Company maintains a line of credit with Merrill Lynch Business Financial Services, Inc. The agreement expires on March 31, 2005 and provides for borrowings up to \$600,000 at an interest rate equal to the "30 - Day Commercial Paper Rate" plus 3.15%. At December 31, 2003, the rate was 4.16%, and the Company had no outstanding borrowings. The agreement is guaranteed by the members of the Company.

NOTE 11 - CONCENTRATIONS OF CREDIT RISK:

The Company maintains its cash balances in two financial institutions in California. The balances are insured by the Federal Deposit Insurance Corporation up to \$100,000. As of December 31, 2003, the Company's uninsured balances were \$69,605.

NOTE 12 - COMMITMENTS AND CONTINGENCIES:

Besides the Impact Fee Litigation described in Note 5, the Company is subject to various legal proceedings and claims which arise in the ordinary course of business. In the opinion of management, and legal counsel where appropriate, the amount of ultimate liability with respect to these actions will not materially affect the financial position of the Company.

We hereby establish our Irrevocable Standby Letter of Credit in favor of the California Horse Racing Board ("CHRB") for the account of Capitol Racing LLC, a California limited liability company ("Capitol Racing"), 16935 W. Bernardo Drive, Suite 190, San Diego, CA 92127, in the amount of One Million and 00/100 (\$1,000,000.00) U. S. Dollars available at Rancho Bernardo Community Bank by payment against your drafts at sight to be accompanied by:

A signed statement by a representative of CHRB that the amount drawn under this Letter of Credit represents an amount owed to CHRB and unpaid by Capitol Racing, and that the special conditions detailed below have been met.

Partial drawings permitted.

This Letter of Credit shall expire on December 28, 2005, provided, however, that it shall be deemed automatically renewed without amendment for an additional 365 days from the present or any future expiration date hereof, unless thirty (30) days prior to any such date, CHRB shall have received notice by certified mail, return receipt requested, that we elect not to consider this letter of credit renewed for any such additional period.

**SPECIAL CONDITIONS:** Notwithstanding the above, this letter of credit shall be available by CHRB's drafts at sight accompanied by:

- (a) A final judgment or order against Capitol Racing in the litigation entitled *Capital Racing v. CHRB*, Superior Court of Sacramento County, Case No. 02CS01033 (the "Case"), where said final judgment or order requires Capitol Racing to pay monies to the Los Alamitos Quarter Horse Association ("LAQHRA") after all of Capitol Racing's appeals based on any of the issues presented in the Case are exhausted; and




- (b) The following sources of funds are not sufficient to satisfy the amount of the final monetary judgment or order against Capital Racing in the Case: (i) the \$500,000 previously deposited by Capitol Racing with LAQHRA as security for a potential final monetary judgment against Capital Racing; (ii) the approximately \$1.3 million that Los Alamitos Race Course currently owes the horsemen racing for Capitol Racing for reasons unrelated to the dispute that is the subject of the CHRB's May 12, 2003 Decision, or the issues in the Case; and (iii) the total amount of the weekly deposits Capitol Racing is paying to the CHRB pursuant to that certain agreement between Capitol Racing and CHRB, which was entered into between Capitol Racing and the CHRB at a meeting of the California Horse Racing Board on February 19, 2004 (which deposits CHRB is accumulating and holding in a trust account, the purpose of which is to pay a potential monetary judgment against Capitol Racing); and
- (c) Capital Racing fails to pay any remaining balance of a final monetary judgment against Capital Racing; and
- (d) 90 days have elapsed since CHRB provided Capitol Racing with written notice that the funds identified in "(b)" above are exhausted and insufficient to meet Capitol Racing's obligations.

We engage with you that drafts drawn and presented under and in compliance with the terms of this Letter of Credit will be duly honored.

This Letter of Credit is subject to the Uniform Customs and Practices for Documentary Credits (1983 Revision), published by the International Chamber of Commerce, ICC Publication 500, to the extent it is not inconsistent with applicable laws of the State of California.

I have appeared before the board and written a number of letters to the board representing clients who are harness horse owners and breeders with regard to Capitol Racing's license to operate harness horse meets at Cal Expo.

I request on behalf of my clients the following items be placed on the agenda for the upcoming January 20, 2005 CHRB meeting:

1. Capitol Racing's compliance or lack of compliance with CHRB's requirement that they file an audited financial statement for their operations for the year 2003;
2. Whether the CHRB needs to take action with regard to Capitol Racing's license if they failed to provide the board with an audited financial statement for the year 2003.
3. Capitol Racing's breach of their obligation to share the distribution of takeout in accordance with § 19605.7(c) of the California Horse Racing Law equally with the horsemen in accordance with the provisions of section XIII(b) of the agreement between Capitol Racing LLC and California Harness Horsemen's Association. See enclosed letter by Richard M. English.

4. Capitol Racing's obligation to share equally with the horsemen the amount of breakage and unclaimed tickets from simulcasted races. See the English letter;
5. Whether Capitol Racing has complied with its obligations to share equally with the horsemen the surplus refunded by Scotwinc. This surplus, as set forth in Mr. English's letter, is believed to be approximately \$3 million for the year ended September 30, 2004;
6. To investigate whether loans to horsemen set forth in the unaudited financial statements of Capitol Racing as being in excess of \$1 million are made to officers or directors of California Harness Horsemen's Association and, if so, whether such loans constitute a conflict of interest, making such loans prohibited.

At the request of Mr. Christo Bardis I have analyzed the Purse Account Activity reports prepared for Capitol Racing for the period December 2000 through July 2004. My analysis consisted of comparing the reported purses earned from perimutuel wagering, including Advanced Deposit Wagering, Notwinc revenues, and Scotwinc surpluses to information available from CHRIMS and Scotwinc. My analysis did not include any other possible sources of purses nor did it include any charges against the purses earned.

In the course of performing my analysis I noted the following items which I present for your consideration.

**Distribution of Take-out**

Section 19605.7 (c) of the California Horse Racing Law provides that, for harness meetings, 0.5% of the total amount handled by each satellite shall be distributed according to a written agreement for each race meeting between the association and the horsemen's organization. The agreements between Capitol Racing and California Harness Horsemen's Association do not specifically address this issue. The agreements do address simulcasting income. Section XIII (B) states "gross income derived from simulcasting of live racing shall be split equally as commissions and purses in accordance with California statutes."

Total satellite handle during the period was \$407,385,126 and the 0.5% discussed in 19605.7 (c) was \$2,036,926. Capital allocated 100% of these funds to commissions and nothing to purses. Details are provided on Exhibit A. The Quarter Horse industry is also covered by Section 19605.7 (c). Quarter Horses allocate 100% of these funds to purses.

**Unclaimed Tickets**

Section 19601.(d) provides, in part, that all breakage and unclaimed tickets from imported races shall be distributed equally between the association and the horsemen in

the form of purses. The Purses Account Activity reports do not reflect any provision for unclaimed tickets.

I estimate the purse portion of unclaimed tickets are approximately \$229,000. My estimate is based on the historic ratio of unclaimed tickets to handle on imported races experienced by Los Alamitos. My estimate is detailed in Exhibit B.

#### Scotwin Surplus

Section 19605.7(b) provides that satellite operations be funded by a deduction of 6% of satellite handle to be paid to Scotwin. At the conclusion Scotwin's year end, September 30, the surplus is refunded and is split equally between commissions and purses. Capitol's annual surplus is approximately \$3,000,000, half of which is due the horsemen. The surpluses are estimable and should be reflected on the purse schedule when generated.

Capitol generally uses the "cash" method of recognizing these proceeds when received. The cash method understates the purses earned and overstates the overpayment of purses.

As previously discussed, my analysis was limited to certain elements of the Purses Account Activity reports prepared by Capitol Racing and does not constitute an audit. Accordingly, I do not express an opinion on the aforementioned reports.

(c) In addition to the distributions specified in subdivision (a) and (b), for mixed breed meetings, 1 percent of the total amount handled by each satellite wagering facility shall be distributed to an organization described in Section 19608.2 for promotion of the program at satellite wagering facilities. For harness meetings, 0.5 percent of the total amount handled by each satellite wagering facility shall be distributed to an organization described in Section 19608.2 for the promotion of the program at satellite wagering facilities, and 0.5 percent of the total amount handled by each satellite wagering facility shall be distributed according to a written agreement for each race meeting between the licensed racing association and the organization representing the horsemen participating in the meeting. For quarter horse meetings 0.5 percent of the total amount handled by satellite wagering facility on races run in California shall be distributed to an organization described in Section 19608.2 for the promotion of the program at satellite wagering facilities, 0.5 percent of the total amount handled by each satellite wagering facility on out-of-state and out-of-country imported races shall be distributed to the official quarter horse registering agency for the purposes of Section 19617.75, and 0.5 percent of the total amount handled by each satellite wagering facility on all races shall be distributed according to a written agreement for each race meeting between the licensed racing association and the organization representing the horseman participating in the meeting.
