APPROVAL OF THE MINUTES OF JULY 18, 2013

Chairman Israel asked for approval of the minutes of the Regular Meeting of July 18, 2013.

Vice-Chairman Winner **motioned** to approve the minutes. Commissioner Rosenberg **seconded** the motion, which was **unanimously carried**.

PUBLIC COMMENT

Alan Balch, of the California Thoroughbred Trainers (CTT), stated that 50 trainers, representing 880 owners, were present to demonstrate who the CTT represented. He thanked the Board for involving the CTT in the discussions on the stabling issues. Mr. Balch asked the Board to make Fairplex Park the priority when considering the solution to preserve the industry's growth. He said this fragile growth was essential in sustaining the horse number levels needed to run meetings at the Los Angeles Turf Club, the Del Mar Thoroughbred Club, and elsewhere. Mr. Balch stated that it was critically important that horsemen had a fair stall application process and had the ability to choose where to split or where to stable when forced to go off-site. Francesca De La Flor, representing Oak Knoll Meadows Farm, stated as an owner she was concerned with the drop in the foal crop which was projected in 2014 to be the smallest since 1968. She said the

small foal crop would raise the price of horses in a state that was already an extremely expensive place to race. Ms. De La Flor said 80 percent of the owners won 20 percent of the purses with 52 percent of the horses in the starting gates. She said she had raced outside of California where it was cheaper and easier to win, but she lived in California and preferred to keep her horses in state. If the Board wanted to see further growth the owners needed to be taken care of because they were the ones that provided the racing program. Bob Leonard, a California Trainer, stated he had raced in 43 tracks throughout the United States and had observed that in the successful states the industry worked together. He was concerned that in California the different interests seemed to be at odds.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE BIG FRESNO FAIR (F) AT FRESNO, COMMENCING OCTOBER 2, 2013 THROUGH OCTOBER 14, 2013, INCLUSIVE.

John Alkire, representing the Big Fresno Fair (Fresno), stated Fresno would be trying new concepts such as a mascot race, a social media day, track handicappers, and on-track sales. He said that there would be improvements in social networking outreach including promotion using videos of customers. Chairman Israel asked why there was a two and a half million dollar reduction in handle between 2011 and 2012. Larry Swartzlander, representing Fresno, stated the difference in the handle was due to a decline in the horse population. He said Fresno, as the last fair of the season, relied on the other fairs succeeding and keeping the horsemen in California. Chairman Israel asked what was projected for 2013. Mr. Swartzlander stated in 2013 there were more out-of-state horsemen, possibly due to increased incentives. The California State Fair had an increase in horses per start and an increase in handle by \$300,000. He said the momentum would hopefully carry over to the Stockton Fair and then to Fresno. Commissioner Beneto

motioned to approve Fresno's application for license to conduct a horse racing meeting, commencing October 2, 2013 through October 14, 2013. Commissioner Krikorian **seconded** the motion, which was **unanimously carried**. Commissioner Krikorian commended Fresno for all of the improvements made on its backside.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE PACIFIC RACING ASSOCIATION (T) AT GOLDEN GATE FIELDS, COMMENCING OCTOBER 16, 2013 THROUGH DECEMBER 22, 2013, INCLUSIVE.

Calvin Rainey, representing Pacific Racing Association at Golden Gate Fields (GGF), stated GGF's spring 2013 handle was up two percent, and the summer 2013 meeting started off with a turf-racing festival and a Hispanic festival that resulted in the largest attendance numbers in years. He said the 2013 fall meet had one more race day and 10 more races than the 2012 fall meet; and purses were expected to stay strong. Chairman Israel asked if the article on Russell Baze in the New York Times increased local media interest in GGF. Dan Cirimele, representing GGF, stated that the Santa Rosa Press Democrat, a sister company of the New York Times ran the article; however, the Russel Baze story already had plenty of local media time and was somewhat of an "old story". He said the story was great exposure on a national level and had been submitted to ESPN. Chairman Israel asked where GGF stood on the outstanding paramedic certification, fire clearance, and the California Thoroughbred Trainers (CTT) agreement. Mr. Rainey stated GGF had one paramedic and one EMT at the track for training and live racing. Jacqueline Wagner, CHRB Assistant Executive Director, stated the certification received from Westmed stated there was only the EMT on site and that something was needed stating there was a paramedic as well. Mr. Rainey stated the Westmed certification was for the auxiliary stabling site at the Alameda County Fair (Alameda). Ms. Wagner said Alameda was the location of

concern. Mr. Rainey stated the CTT agreement had only been received two weeks earlier. He requested more time to review the 25 major changes proposed by CTT, and asked that GGF be allowed to run the fall 2013 meet under the existing CTT agreement that was used for the summer 2013 meet. Peter Tunney, representing GGF, stated previous CTT agreements covered the entire year, asking for so many changes at such a late date would require a considerable amount of time and effort. Chairman Israel stated the GGF CTT agreement was not a surprise considering the ongoing stabling issue in Southern California. He said the Board wanted to see an effort made to work through the issues. Commissioner Rosenberg asked if GGF had made any contact with the CTT after receiving the agreement. Mr. Tunney said GGF met with CTT every day to discuss the issues. Scott Daruty, representing GGF, stated the CTT agreement received by GGF mirrored the CTT agreement received by Los Angeles Turf Club (Santa Anita). He said he recently met with Alan Balch, and spoke with the CTT counsel on the phone; work had been done to reach an amicable agreement. Vice-Chairman Winner **motioned** to approve the GGF's application for license to conduct a horse racing meeting, commencing October 16, 2013 through December 22, 2013, contingent on receiving all outstanding items including the CTT agreement. Commissioner Choper **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF WATCH AND WAGER LLC (H) AT CAL EXPO, COMMENCING OCTOBER 5, 2013 THROUGH DECEMBER 21, 2013, INCLUSIVE.

Christopher Schick, representing Watch and Wager (WAW), stated the 2012 meet was very successful with no track fatalities and purses up 33 percent over the previous year. He said the 2013 fall meet had 4 more days and would start by racing one day a week in October. Commissioner Choper stated it appeared the daily average purse was down 20 percent from the

last meet. Mr. Schick said the daily average purse was lower because a number of high paying two year old sire stakes races had been moved from the fall to the winter meet. Chairman Israel asked why WAW's financial information was not with the application. Ed Cummings, representing WAW, stated a financial audit was taking place and would be completed and submitted in early September, 2013. Jim Perez, representing the California Harness Horsemen's Association (CHHA), stated the CHHA supported the application. He said the CHHA had a plan to assist with the living expenses for the grooms, who were no longer allowed to live in the tack rooms. Commissioner Beneto asked what needed to be done to satisfy the State Fire Marshal so that grooms could live in the tack rooms. Mr. Schick stated it was WAW's responsibility to decide how to improve the site and then submit plans to the State Fire Marshall for approval. Dave Elliot, representing Cal Expo, stated the tack rooms were in good shape, safe, and well maintained, just not up to code as a residential space. Chairman Israel asked if a consultant was hired to assist with planning improvements. Mr. Elliot stated Cal Expo and WAW had hired a consultant to assist with getting approval from the State Fire Marshall. Commissioner Rosenberg asked how the State Fair was affected by this. Mr. Elliot said the State Fire Marshall inspected daily, preventing the use of appliances such as air conditioners or refrigerators. Chairman Rosenberg asked how many horses WAW anticipated having for the fall meet. Mr. Schick stated WAW had applications for 290 horses and would need at least 400 horses to run. Commissioner Choper **motioned** to approve WAW's application for license to conduct a horse racing meeting, commencing October 5, 2013 through December 21, 2013, contingent on receiving WAW's financials. Commissioner Beneto **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD REGARDING AUTHORIZED BLEEDER MEDICATION POLICIES FOR BREEDER'S CUP RACES TO 1) LIMIT TWO YEAR OLD RACES TO HORSES NOT ON THE CHRB AUTHORIZED BLEEDER MEDICATION LIST AND TO 2) LIMIT AUTHORIZED BLEEDER MEDICATION IN OTHER BREEDER'S CUP RACES TO FUROSEMIDE ADMINISTERED BY CHRB LICENSED VETERINARIANS APPROVED BY THE BREEDER'S CUP, WHO ARE NOT OTHERWISE ATTENDING HORSES OR PROVIDING VETERINARY SERVICES TO TRAINERS COMPETING IN THE BREEDER'S CUP RACES.

Dr. Rick Arthur, CHRB Equine Medical Director, stated the proposed authorized bleeder medication policies were the same policies used at the 2012 Breeders' Cup. Steve Schwartz, representing the Breeders' Cup, stated the Breeders' Cup had no preference whether or not the veterinarians approved to administer bleeder medication were also attending horses competing in Breeders' Cup races. Dr. Arthur stated the proposed policy was the one the Breeders' Cup wanted in 2012; if the Breeders' Cup wanted to allow veterinarians to administer bleeder medication to their own horses in 2013 that was alright with him. Mr. Schwartz stated the Breeders' Cup did not have a preference regarding which veterinarians administered bleeder medications; it was up to the Board. Commissioner Derek asked where the Breeders' Cup stood on adjunct medications. Mr. Schwartz stated that question had not come up and he had no answer. Dr. Arthur stated if veterinarians were allowed to administer bleeder medications to their own horses it would be difficult to control the possible administration of estrogen which was not technically authorized, but more or less allowed as an adjunct bleeder medication. Commissioner Choper asked what Dr. Arthur thought about changing the Breeders' Cup bleeder medication policy back to the current California horseracing policy. Dr. Arthur stated it would be a step backwards. Commissioner Choper stated that the Breeders' Cup did not have a preference, which allowed the Board to do it either way. Dr. Arthur stated the Board could not insist on using a third party veterinarian unless the Breeders' Cup demanded it as a condition to host. He said if the Board attempted to enforce such a condition on its own, it would be an

underground regulation, and opposed by both trainers and veterinarians. Mr. Schwartz stated Craig Fravel called from Lexington to inform the Board that the Breeders' Cup did want third party veterinarians administering bleeder medications. Vice-Chairman Winner asked if the Breeders' Cup was saying it supported the proposed policy. Mr. Schwartz stated it was. Chairman Israel asked if there were expenses incurred in having a third party veterinarian administer bleeder medications. Dr. Arthur stated there were, but in 2012 they were paid directly to the third party veterinarians by the Breeders' Cup. Michael Wellman, a California horse owner, asked if there were plans to do research on the effects of bleeder medications on two-year-olds. Dr. Arthur stated there were no plans for research beyond the usual monitoring of horses for epistaxis. Tom Ludt, representing the Breeders' Cup, stated that subjecting the horses to invasive procedures for research was very controversial; research was being done but it remained voluntary and therefore involved a smaller sample group. Chairman Israel stated the research was important; maybe it could be made a requirement to enter the Breeders' Cup. Robert Miller, CHRB General Counsel, stated the Board could not require such a procedure under the current rules. Vice-Chairman Winner stated there were owners and trainers who did not want their horses scoped and some horses who reacted badly to being scoped. Dr. Arthur said that was correct. Mr. Ludt stated the Breeders' Cup was asking for volunteer participation from all types of horses not just two-year-olds. Commissioner Krikorian stated having horses run without bleeder medications and not conducting research was a missed opportunity. Chairman Israel stated the Board was not forcing the horses to run without bleeder medications, it was a requirement of the Breeders' Cup, and the testing could also be a Breeders' Cup requirement. Joe Morris, representing the Thoroughbred Owners of California (TOC), stated the TOC was in favor of scoping the two-year-olds after racing, but believed it should be on a voluntary basis only. He said this was the last year to do such a study as the two-year-olds

would be running with bleeder medications in 2014. Dr. Arthur stated there was a large amount of research on the subject, and that testing the Breeders' Cup two-year-olds would be more for curiosity than science. Commissioner Krikorian said if the use of bleeder medication was so controversial it should be left to owners and trainers to make the decision for its administration. Commissioner Choper **motioned** to authorize bleeder medication policies for Breeder's Cup races to 1) limit two year old races to horses not on the CHRB Authorized Bleeder Medication List and to 2) limit authorized bleeder medication in other Breeder's cup races to furosemide administered by CHRB licensed veterinarians approved by the Breeder's Cup, who were not otherwise attending horses or providing veterinary services to trainers competing in the Breeder's Cup races, provided the Breeders' Cup reimbursed in full for services of those third-party veterinarians, and Breeders' Cup provided opportunity to volunteer for endoscopic examination to collect data on the use of furosemide. Vice-Chairman Winner **seconded** the motion, which was **carried**, with Commissioner Krikorian **abstaining**.

DISCUSSION AND ACTION BY THE BOARD REGARDING AN UPDATE FROM THE LOS ANGELES TURF CLUB II (T), ON ITS MARKETING PLAN FOR ITS RACE MEETING AT SANTA ANITA, COMMENCING SEPTEMBER 25, 2013 THROUGH NOVEMBER 3, 2013, INCLUSIVE.

Tom Ludt, representing the Los Angeles Turf Club (LATC), stated LATC was making many renovations at its facility to attract and cater to high-end clientele. He said the internship program had started off well with eight of 15 interns chosen so far. Commissioner Choper asked if there were any plans to have rebates. Mr. Ludt stated rebates came from a different budget; however, there would be a new player rewards program. He said LATC was working on a new card and ticketing system which would better track the handle. Commissioner Rosenberg asked what type of audience the chandelier room was being renovated to attract. Mr. Ludt said it was

designed to cater to the highest of high-end customers. Commissioner Beneto asked if the millions spent on renovations would have been better spent ensuring the stabling of horses. Mr. Ludt stated that the Stronach Group deserved more credit for the improvements made to the backside. Vice-Chairman Winner stated the marketing objectives were positive; however, the report was missing specifics on how LATC was going to achieve its objectives. He asked how LATC planned on using social media to achieve its marketing goals. Mr. Ludt stated that was not his expertise. Vice-Chairman Winner stated social media marketing was only effective if a young customer base already existed. Mr. Ludt said he agreed. Vice-Chairman Winner asked why the 2014 marketing budget was down from 2013. Mr. Ludt said the report referred to the fall meet only; the 2014 total would be comparable to 2013. Chairman Israel asked why the football promotion was only on Sundays when Los Angeles had popular college teams that played Saturdays. Mr. Ludt stated LATC was turning Sireno's Bar into a dedicated football room that would play Saturday games as well. Commissioner Krikorian stated there should be televisions playing football throughout the facility. Mr. Ludt said there were plans to install more televisions in the mezzanine as well as a new bar. Chairman Israel stated the report fulfilled one of the contingencies for the LATC race meet application. Vice-Chairman Winner stated the Board would like the details on the 2014 marketing plan as they became available.

DISCUSSION AND ACTION BY THE BOARD REGARDING AN INDUSTRY REPORT ON THE ISSUES RELATED TO CONDITIONS PLACED ON THE ALLOCATION OF THE 2014/2015 SOUTHERN CALIFORNIA RACING CALENDAR AND THE BOARD'S RATIFICATION OF THE CALENDAR.

Chairman Israel stated items eight and nine would be combined and heard concurrently.

DISCUSSION AND ACTION BY THE BOARD REGARDING AN INDUSTRY UPDATE ON THE STATUS OF THE DISCUSSIONS REGARDING THE SOUTHERN CALIFORNIA AUXILIARY OFF-TRACK STABLING ISSUE FOR 2014/2015.

Chairman Israel stated the ad-hoc meetings resulted in some progress on the stabling issue. He said Hollywood Park agreed to stay open for training at least until January 31, 2014 and maybe beyond, depending on the direction of its development venture. Chairman Israel stated one long term solution being considered was to expand Del Mar into a year round training facility. Joe Harper, representing Del Mar, stated the expanded use of Del Mar would be in the best interest of thoroughbred racing in California; however, there were many potential issues with its landlord and local agency. Commissioner Rosenberg stated the Del Mar expansion would not help with the immediate stabling issue. Chairman Israel stated the Thoroughbred Owners of California (TOC), and the California Thoroughbred Trainers (CTT) had agreed that Fairplex Park would be one of the alternative sites considered for stabling in the short term. He said he and Vice-Chairman Winner were presented with a line-item budget and had begun to get a better understanding of the money side of the issues. Chairman Israel stated Los Alamitos presented a plan for expanding its racetrack to a full mile which would improve its site for training and for possible thoroughbred race meets. Vice-Chairman Winner asked if Los Alamitos had an agreement with Hollywood Park to run a thoroughbred race meeting. Brad McKinzie, representing Los Alamitos, stated Los Alamitos planned on running its own thoroughbred meets, unless industry circumstances dictated otherwise. He also said he was aware there was a rumor that Mike Pegram had a stake in thoroughbred racing at Los Alamitos and it was not true. Commissioner Rosenberg stated Dr. Edward Aldred, the owner of Los Alamitos, spoke at the Pari-mutuel/ADW and Simulcast Committee Meeting stating there had not yet been an agreement for Los Alamitos to have a thoroughbred race meet. Mr. McKinzie stated after the committee meeting Dr. Aldred met with representatives from Los Angeles Turf Club (LATC).

Santa Anita agreed to give up a week allowing Los Alamitos the opportunity to run a two week meet in the summer and a three week meet in the winter. Commissioner Rosenberg asked if the proposed thoroughbred meetings would alter any conditions, such as the claiming price, for existing thoroughbred races. Mr. McKinzie stated there were no planned changes; however, Los Alamitos may look for industry agreement to extend the four and a half furlong races due to the expansion of the race track. Chairman Israel asked what the daytime race card would look like. Mr. McKinzie stated it depended on how many thoroughbred races Los Alamitos could fill; but the plan was to have 12 races, and fill out the end of the card with quarter horse races. Commissioner Krikorian asked what was the stabling situation for the proposed race dates. Mr. McKinzie said Los Alamitos was prepared to house up to 700 thoroughbreds, in existing stables separate from the quarter horses, for year round training. Chairman Israel stated the turns on the planned one mile track would be significantly wider. Mr. McKinzie said the proposed design had a 340 foot radius on the far turn and a 310 foot radius on the clubhouse turn. Commissioner Krikorian asked if thoroughbreds and quarter horses would train together. Mr. McKinzie stated there would be hours where thoroughbreds only would be allowed to train, hours where quarter horses only would be allowed to train and hours where both would be allowed to train. Commissioner Beneto asked if there was a timeline for the expansion plan. Mr. McKinzie stated Los Alamitos was working on getting approvals from the City of Cypress, and should complete the track expansion and barn renovation by January 1, 2014. Commissioner Beneto asked if there was progress on the other contingencies for allocation of race dates. Vice-Chairman Winner stated there was commendable progress, but that the remaining issues needed to be discussed at the September 19, 2013 Regular Board Meeting allowing the parties more time to negotiate. Joe Morris, representing the TOC, stated the Board should approve the five weeks of thoroughbred racing allocated to Los Alamitos. Chairman Israel stated the Board had already

approved the allotted race dates contingent upon resolving the remaining issues and that approval of the Los Alamitos race dates would require a formal request for an agenda item. Chairman Israel asked about the progress on renovations at San Luis Rey Downs (SLRD). Scott Daruty, representing LATC, stated the renovations were near completion and were on schedule for a December opening. He said the main track had fresh material mixed in under the direction of Dr. Nick Peterson, a new safety rail had been installed and the barns were undergoing complete renovation. Once completed, there would be housing for 100 people. Mr. Daruty stated that there were plans to make room in the existing building for a minisatellite that would be open to the public but cater to the horsemen. He said the plans for a seven furlong, 40 foot wide turf course were complete. There were some engineering issues mostly related to drainage, but the Stronach Group was committed to building the turf course and expected to start construction on it in 60 to 90 days. Mr. McKinzie stated Los Alamitos was willing to consider Hollywood Park as a licensee for one of its race meets if Hollywood Park agreed to stay open past January 1, 2014. Commissioner Beneto stated it was time to forget Hollywood Park and prevent it from influencing further negotiations, especially for just one month of training. Vice-Chairman Winner stated he disagreed; keeping Hollywood Park open for training beyond January 1, 2014 was worth some negotiated concessions on the part of the industry; he stated the offer from Hollywood Park was for a minimum of one month. Chairman Israel stated the people at Hollywood Park wanted to stay there as long as they could, that was the preferable thing to do. Commissioner Rosenberg asked what Hollywood Park gained by being a licensee for a race meet at Los Alamitos. Vice-Chairman Winner stated it was not part of the discussion. Chairman Israel said it would be more appropriate to discuss the issue if and when Hollywood Park applied for a license. Commissioner Krikorian asked if Los Alamitos was depending on Hollywood Park getting involved. Commissioner Rosenberg stated Hollywood Park refused to stay open unless it

got to license a meeting at Los Alamitos. Commissioner Krikorian asked what the contingency plan was if Hollywood Park did not stay open past January 1, 2014. Vice-Chairman Winner stated there would be more demand for stables at Fairplex, which recently resolved its storm water issue for 2014. Mike Seeder, representing Fairplex, stated an existing storm water drainage permit had been administratively extended through 2014. He said it had no cap on the number of horses allowed so there was flexibility for at least all of 2014; Fairplex would only require a reasonable notice. Commissioner Rosenberg asked where CTT stood on the arrangement. Jim Cassidy, representing CTT, stated keeping Hollywood Park open was a positive step, but it could not be depended on. Keeping Fairplex available, without interruption, was essential. He stated CTT would like Santa Anita to stay open for training in the summer during Del Mar's race meet. Mr. Daruty said Santa Anita closed for seven weeks during Del Mar's meet to maintain its facility. Chairman Israel stated the three other alternatives would cover for Santa Anita during the seven weeks. Mr. Cassidy stated CTT could agree as long as Fairplex remained one of the options. Commissioner Beneto stated he felt as though keeping Hollywood Park open was being forced on the rest of the Board. Chairman Israel stated keeping Hollywood Park open as long as possible was the preferred option for all of the parties involved. Commissioner Choper said the Board needed to give the final decision one more month. Commissioner Beneto stated he would agree to wait one more month as long as the issue was resolved. Alan Balch, representing CTT, stated if SLRD stable capacity was 500 horses, there would be a need to house around 223 workers; its housing plan for 100 workers was not adequate. Mr. Balch stated the Board should also be aware the number of horses in California peaked during the Del Mar meeting, as it had a big draw for out of state horses. Chairman Israel asked if the TOC would like to state its opinion on the option of Hollywood Park staying open for training. Mr. Morris stated it would be the plan with the least disruption and the TOC was in

favor of keeping Hollywood Park open as long as possible. He said the TOC was not concerned with the number of available stalls, but it was concerned about how they would be paid for. Mr. Daruty stated he was concerned about postponing the stabling issue for one more month. He said more and more industry decisions were being based on the dates decided upon in May 2013 and the more time passed the more nervous Santa Anita was getting without guaranteed race dates for 2014. Chairman Israel stated the only changes he foresaw in the dates decided upon in May 2013 were to allow for race meets at Los Alamitos in December and July. Commissioner Beneto asked what would happen if Hollywood Park decided not to close and requested its race dates. Chairman Israel stated that would be a decision of the Board. Mr. Cassidy asked why it was such a problem to pay Fairplex \$13,000 a day but no one had complained about the \$17-18,000 a day it would cost to keep Hollywood Park open for training. Chairman Israel stated the issue would need to be further discussed during the one month extension. Commissioner Krikorian stated in order to make an informed decision it would be helpful to see a proposal with a cost breakdown from each of the stabling facilities. Chairman Israel asked for stabling proposals from Fairplex, Hollywood Park, LATC, Del Mar, Los Alamitos, and SLRD. Robert Miller, CHRB General Counsel, said the proposals could not be made public record. He said the Commissioners could ask questions based on the proposals as long as it was understood the answers involving any of the proposed financials would be given on a voluntary basis. Vice-Chairman Winner **motioned** to delay further discussion of the issues of stabling and the allocation of race dates for 2014/2015 until the September 19, 2013 Regular Board Meeting. Commissioner Choper **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD REGARDING A PRESENTATION FROM THE THOROUGHBRED RACING PROTECTIVE BUREAU (TRPB) AND ITS TOTE SECURITY SYSTEM.

J. Curtis Linnell, representing the Thoroughbred Racing Protective Bureau (TRPB), stated 41 tracks in the U.S. and Canada were under contract with Tote Security System (TSS). He said the three features of TSS were to identify guest totes joining the host track, to close all betting when the host track closes, and to transmit an audit file of transactions within minutes. He said TSS was the solution for the existing latency issues, providing real-time odds. Commissioner Choper asked what real-time meant. Mr. Linnell said the TSS system refreshed every two seconds; however, the speed to the customer was delayed by how often the video stream was refreshed, which could be as fast as ten seconds. Commissioner Choper asked if this would prevent odds from changing after betting closed. Mr. Linnell stated current systems had as much as a 45 second lag, where as much as 40 percent of the win pool appeared after betting closed. He said TSS with its 2 seconds of lag would have much more stability in the final minute of betting. Mr. Linnell stated this type of display management was similar to what financial markets used, which would be perfect as California began to implement exchange wagering. Vice-Chairman Winner stated the next step was for TRPB to meet with the stewards and update them on the workings of the TSS.

REPORT AND UPDATE BY THE UNIVERSITY OF CALIFORNIA, DAVIS ON THE CHRB/CALIFORNIA ANIMAL HEALTH AND FOOD SAFETY LABORATORY SYSTEM (CAHFS) UNIVERSITY OF CALIFORNIA, DAVIS NECROPSY PROGRAM FOR FISCAL YEAR 2011-2012 AND PRELIMINARY FISCAL YEAR 2012-2013 RESULTS.

Dr. Francisco Uzal, representing University of California Davis, gave a brief history and overview of the CHRB/California Animal Health and Food Safety Laboratory System (CAHFS) University of California, Davis Necropsy Program. He presented a slideshow of the postmortem

procedures with examples of catastrophic breakdowns resulting in the horse being put down. Dr. Uzal said a large percentage of the catastrophic breakdowns occurred over pre-existing lesions. The presentation showed a higher number of thoroughbred injuries compared to quarter horse injuries; however, Dr. Rick Arthur, CHRB Equine Medical Director, stated that was due to the higher number of thoroughbred horses, the rate of injury was similar. Dr. Uzal stated part of the postmortem was a toxicology screening. He said the screening was a series of tests that looked for a particular toxic substance; there was no single comprehensive test that identified all toxics present. Dr. Uzal reviewed the causes of sudden death and the bodily systems that were the cause. Commissioner Rosenberg asked if the pre-existing conditions leading to catastrophic breakdowns could be identified before the breakdown. Dr. Arthur said yes, using nuclear scintigraphy. He said since Santa Anita had nuclear scintigraphy available, there had been only two humeral stress fractures that died in his care. Dr. Arthur stated part of the effectiveness of any preventive system was to educate the trainers on when to take a horse to a veterinarian for further evaluation. Commissioner Rosenberg stated he was surprised that 43 percent of sudden deaths had no known cause. Dr. Uzal stated that it was similar in human pathology where it was only assumed there was heart failure caused by an electrical conductive issue. Commissioner Krikorian asked for the cost of the nuclear scintigraphy device. Dr. Arthur stated the one installed in Santa Anita cost about \$300,000 and had completed 10,000 scans. Commissioner Rosenberg asked how much the scans cost. Dr. Arthur said a whole body scan was around \$800 and a limb was around \$500.

REPORT AND UPDATE REGARDING THE CHRB TRACK SAFETY PROGRAM, INCLUDING THE ENHANCED NECROPSY PROGRAM AND THE RACING SAFETY PROGRAMS.

Dr. Sue Stover, representing University California Davis, stated since 1990 6,000 racehorses had died on California race tracks; one thoroughbred for every 24 that make it to the track, and one quarterhorse for every 44 that make it to the track. She said jockey injuries had accounted for six and a half million dollars in workman's compensation claims in the last five years; 50 percent of these injuries were related to horse injury or horse sudden death. Dr. Stover stated there was no way of knowing the cost for the public perception caused by the injuries to both the horse and jockey. However, when the industry identified a negative issue and responded aggressively it could become a positive public relations event, exemplified by the recent Dreamliner battery issue. Dr. Stover reviewed discoveries in patterns of injury, new methods of prevention, and the subsequent improvement in rate of injury. She said this was just a beginning in the understanding of these types of injuries; there was much more to do in finding risk factors and devising preventative methodology. Dr. Stover stated over the last 20 years there had been a rise in equine fatality rates; however, in the last two years there had been a 25 percent rate reduction in thoroughbreds and a 54 percent rate reduction in quarter horses. She said in 2012 this reduction in fatality rate equated to a two million dollar positive impact on the industry, double the return for the cost of the program.

REPORT FROM THE MEDICATION AND TRACK SAFETY COMMITTEE.

Commissioner Derek stated there was discussion on the revised claiming rule (1658, Vesting of Title to Claimed Horse) with five speakers in support and five in opposition. The critics cited several concerns particularly where to official veterinarian determines if the horse should be

placed on the Veterinarian's List. In support were those in the industry concerned about the health of the horse. Commissioner Derek said she personally felt the remarks of Dr. Dana Stead, Del Mar Track Veterinarian, were important. Dr. Stead told the Committee that after eight weeks only two of the horses whose claims had been voided on the southern thoroughbred circuit had come back to work. Commissioner Derek stated this suggested that the program was working the way it was intended, protecting both the horses and the riders. She stated the Committee believed one suggested change should be implemented right away and that was to allow a claimant to keep the horse even after it was placed on the Veterinarian's List. Commissioner Derek stated that Dr. Rick Arthur, CHRB Equine Medical Director, updated the Committee on matters still in process including an evaluation of heat related incidents to help determine if the Board should establish a heat-stress index, a possible revision of rules pertaining to the administration of bleeder medications, and a few issues pertaining to the Veterinarian's List.

DISCUSSION AND ACTION BY THE BOARD REGARDING THE PROPOSED AMENDMENT TO CHRB RULE 1658, VESTING OF TITLE TO CLAIMED HORSE, TO PROVIDE THAT A CLAIM SHALL NOT BE VOIDED BY THE STEWARDS IF PRIOR TO THE RACE THE CLAIMANT ELECTS TO CLAIM THE HORSE REGARDLESS OF WHETHER THE RACING OR OFFICIAL VETERINARIAN DETERMINES THE HORSE WILL BE PLACED ON THE VETERINARIAN'S LIST AS UNSOUND OR LAME.

Commissioner Derek stated the proposed amendment to Rule 1658, Vesting of Title to Claimed Horse, was based on suggestions coming from many people in the industry who had a desire to claim a horse whether the horse was determined to be sound or unsound. She said the previous understanding was if a horse was desired after it was placed on the veterinarian's list a private deal could be sought; however, there were complaints the price became higher when such a private deal was pursued. Commissioner Derek said this gave the claimant an option to opt out

of the veterinarian examination by checking a box on the claim form. She said if the horse died prior to being unsaddled the claim was still voided. Chairman Israel asked if it was less safe to be able to opt out of the examination as his opinion was the more horses were examined the more injuries could be prevented. Vice-Chairman Winner stated if the claimant was only interested in the horse as a brood mare or other like purpose then it posed no extra risk. Dr. Arthur confirmed if there was any other reason outside of the claim to examine the horse it would still be done. Commissioner Krikorian **motioned** to direct staff to initiate a 45-day public comment period regarding the proposed amendment to CHRB Rule 1658, Vesting of Title to Claimed Horse. Commissioner Rosenberg **seconded** the motion, which was **carried** with Commissioner Beneto **abstaining**.

REPORT FROM THE JOCKEY AND DRIVER WELFARE COMMITTEE.

Vice-Chairman Winner stated there was progress in the development of a rule for random drug testing of exercise riders and all others who handle the horses. He said there was discussion of the proposed Rule 1500.3, which subjected jockeys to breath alcohol testing prior to each race program in which he or she participated; and proposed Rule 1536, which would require a report of training accidents to be attached to the stewards' minutes. Vice-Chairman Winner stated there was discussion to propose a rule that would require exercise riders to undergo an annual physical examination, which was already a requirement for jockeys. He said there was also discussion on how to improve the requirements to become an exercise rider, as well as the safety conditions in the stable area, in the hope to reduce accidents. Vice-Chairman Winner said some of the issues may come before the Board, but some may be taken care of within horsemen's agreements or at the association level.

DISCUSSION AND ACTION BY THE BOARD REGARDING THE **PROPOSED AMENDMENT TO CHRB RULE 1536, STEWARDS MINUTES**, TO REQUIRE THE NEW CHRB FORM REPORT OF TRAINING ACCIDENTS (CHRB 201A), TO BE ATTACHED TO THE STEWARDS' MINUTES.

Vice-Chairman Winner **motioned** to direct staff to initiate a 45-day public comment period regarding the proposed amendment to CHRB Rule 1536, Stewards minutes. Chairman Israel **seconded** the motion, which was unanimously **carried**.

DISCUSSION AND ACTION BY THE BOARD REGARDING THE **PROPOSED ADDITION OF CHRB RULE 1500.3, JOCKEY BREATH ALCOHOL TESTING**, TO PROVIDE THAT EVERY JOCKEY OR APPRENTICE JOCKEY IS SUBJECT TO A BREATH ALCOHOL TEST PRIOR TO EACH RACE PROGRAM IN WHICH HE OR SHE PARTICIPATES.

Commissioner Krikorian asked if the proposed rule was consistent with other sports policy and what position the Jockeys' Guild was taking on it. Commissioner Derek stated the proposed addition of Rule 1500.3, Jockey Breath Alcohol Testing, corrected an oversight which occurred when the Board decided on its policy for drug testing. She said the rule was consistent with the agreement with the Jockeys' Guild. Darrell Haire, representing the Jockeys' Guild, stated the Jockeys' Guild supported the rule and hoped it was approved. Vice-Chairman Winner **motioned** to direct staff to initiate a 45-day public comment period regarding the proposed addition of Rule 1500.3, Jockey Breath Alcohol Testing. Commissioner Derek **seconded** the motion, which was unanimously **carried**.

REPORT FROM THE PARI-MUTUEL/ADW AND SIMULCAST COMMITTEE.

Commissioner Rosenberg stated the Pari-mutuel/ADW and Simulcast Committee discussed the division of funds between harness and quarter horse interests on night racing advance deposit

wagering. He said the parties asked to postpone the issue for one month. Commissioner Rosenberg said there were presentations from both Southern California Off-Track Wagering Incorporated (SCOTWINC) and Northern California Off-Track Wagering Incorporated (NOTWINC) as to their history and how they operated. He said NOTWINC had a general manager but SCOTWINC instead relied on the mutual managers from each of the racetracks as they were open, making for a much less efficient system. There was hope with additional funding recently received they would name a general manager.

REPORT FROM THE LEGISLATIVE, LEGAL AND REGULATIONS COMMITTEE.

Chairman Israel stated the item would be held over.

DISCUSSION AND ACTION BY THE BOARD REGARDING APPROVAL OF THE REVISED CHRB GOVERNING PROCEDURES NOTICE FOR DISCIPLINARY HEARING.

Chairman Israel stated the item would be held over.

Issue: APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE HOLLYWOOD PARK FALL RACING ASSOCIATION, LLC AT BETFAIR HOLLYWOOD PARK NOVEMBER 4, 2013 THROUGH DECEMBER 24, 2013.

Hollywood Park Fall Racing Association (HPFRA), LLC filed its application to conduct a thoroughbred horse racing meeting at Betfair Hollywood Park:

May 9, 2013 Hollywood Park Racing Association announced that it would not seek live racing dates for 2014, thus ending horse racing at the Hollywood Park racetrack. The following 2013 race meet application is for the last approved race dates [November through December] assigned to Hollywood Park Racing Association.

Live racing will commence November 7, 2013 through December 22, 2013, for 27 days, 3 more than 2012. The association proposes to race a total of 242 races, or 8.96 per day. In 2012 they raced 9.13 races per day with an average of 8.15 runners per race. HPFRA will host simulcast only wagering for Southern California November 4 through December 24th on days when live racing is not presented. The (actual) average daily purse for the fall 2012 meet was \$425,691. The (estimated) average daily purse for this meet is \$441,290.

- Racing 4 days per week, Thursday through Sunday in November with the exception of Monday - November 11th, Thursday - November 14th and December 19th. 8 races on Thursdays and Fridays on a selected basis on holidays. 9 or 10 and races on a selected basis on Saturdays and Sundays. 10 races Friday, November 29th, Saturday November 30th and Sunday, December 1st.

Business and Professions Code section 19464(b) specifies no application for license to conduct a horse racing meeting shall be granted unless the applicant has deposited with the Board a surety bond in the amount of \$100,000, or a greater amount, as determined by the Board, which is sufficient to ensure payment of employees wages and benefits including, but not limited to, health, welfare and pension plans. The surety bond shall be maintained during the period of the meeting that all payments are made. In the event of a dispute over the amount owed, the dispute shall be resolved through the grievance procedures set forth in the labor agreement of the union representing the class of employees affected.

This subdivision does not apply to any person or association licensed to operate a horse race meeting prior to January 1, 2001, which has conducted a race meeting in each of the immediate three previous consecutive calendar years.

- Hollywood Park Fall Racing Association, LLC's initial race meeting was conducted after 2001. Therefore, it is subject to the provisions of the Business and Professions Code section 19464(b).
- Pursuant to Business and Professions Code 19464(b) Hollywood Park Fall Racing Association is required to submit a \$100,000 surety bond payable to the Treasurer of the State of California to ensure payment of employee wages and benefits. The Hollywood Park \$100,000 surety bond on file will expire October 29, 2014.
- Request Jennifer Paige be appointed horse identifier pursuant to CHRB Rule 1525, Racing Officials Appointed by the Board.
- A track safety inspection has been requested and will be completed before the beginning of the race meet.
- Wagering program will use CHRB and ARCI rules.
 - Early wagering 8:30 a.m. on the day of and advance-day wagering.
 - ¢.50 pick 5 will be offered on the first five races with a 14% takeout. This major share of the pool will be designated as 100%.
 - Pick 6 on last 6 races - 70% of net pool to be retained for the jackpot and no cap be set.
 - ¢.50 Pick 4 on races 2 through 5 races and last 4 races.
 - Offering option of an alternate selection in the place pick all, pick 5, pick 6 and pick 4.
 - Super High Five on the last race in accordance with ARCI Pick(n) Position(x) pools rules.
- The Advance Deposit Wagering (ADW) providers are TVG, Xpressbet and Twinpires the television provider will be TVG.

Pursuant to Business and Professions Code section 19604, specific provisions must be met before an ADW provider can accept wagers.

Summary of B&P code 19604

To accept wagers on races conducted in California from a resident of California.

- The ADW provider must be licensed by the Board.
- A written agreement allowing those wagers exists with the racing association or fair conducting the races on which the wagers are made.

This Agreement is entered into this 12th day of July, 2013 by and between Hollywood Park Fall Racing Association ("HPRA") and Thoroughbred Owners of California ("TOC") with reference to the following:

- A. Pursuant to Section 19601.01 (all Sections herein referred to are part of the California Horse Racing Law), and subject to the approval of the California Horse Racing Board (the "Board"), HPRA and TOC are empowered to reduce the take-out on a Pick 5 wager to 14% at the upcoming 2013 Hollywood Park Fall Meet (the "Meet").
- B. HPRA and TOC desire, on an experimental basis, to reduce the take-out on a Pick 5 wager to 14% solely for the Meet (the "Pick 5 Wager"). The Pick 5 Wager will have a fifty cent minimum, and will commence on the first race each day of such Meet.
- C. Reference to a 14% take-out is intended to encompass the entire amount withheld from wagers on the Pick 5 Wager, plus breakage.
- D. The amounts retained from Pick 5 Wagers made in California shall be distributed as prescribed in Chapter 4 of California Horse Racing Law (the "Law"), including the distribution prescribed in Section 19601.02 (b) (i. e. , SB1072 - 3% allocable to purses shall be protected).
- E. The amount retained by HPRA from wagers placed by out-of-state customers, including through ADW Providers, on the Pick 5 Wager shall be distributed in the same manner as is the case with respect to other types of wagers placed by out-of-state customers. The host fee rate and purse fee rate (i.e., SB 1072) on the Pick 5 Wager shall not be less than those rates listed on the approved Simulcast/ADW rate sheet for the meet.
- F. Monarch, the firm retained to sell to out-of-state locations the audio-visual signal of the races conducted at Hollywood Park, has advised that it does not believe the introduction of the Pick 5 Wager will adversely impact the Host Fees, Workers' Compensation and Purse Funds provided for in HPRA's existing simulcast contracts.
- G. This Agreement is intended to constitute the requisite "written notice" required by Section 19601.01.







Subject: Emergency Medical Action Plan for Injured Jockeys

Since May 1, 2003 we at Hollywood Park have had in place an emergency medical action-plan for injured jockeys. There is now a new law requiring such an action plan. Pursuant to the Business and Professions Code section 19481.3 (b) each racing association shall adopt and maintain an emergency medical action plan for injured jockeys and shall be posted in English and Spanish within the jockeys room.

The system we have in effect follows the exact guidelines required by the above statute. The emergency action plan we deploy goes as follows:

“Upon the observed or reported injury of a jockey, medical assistance will be immediate. The responding medical technician, track doctor or security will contact communications (via hand held radio or calling 310 4191555). Security will then activate the emergency contact procedure. This procedure will be the responsibility of the Safety Director or his designee. The Safety Director will contact the Chief of Medical Staff at Centinela Hospital and prepare for the injured jockeys arrival. The phone number of Centinela Hospital is 310- 4198636 and is located at 555 East Hardy Street, Inglewood.

The Chief of Staff will ensure that his personnel are standing by to receive the injured jockey. The Chief of Staff will also contact any specialists who are contracted for the care of an injured jockey. This will lay the foundation for a rapid admittance and treatment of the injured Jockey. A Security Agent will also be dispatched to respond to the emergency room to assist family members of the injured jockey and to also maintain the integrity of the injured jockeys needs. It will also be the responsibility of the Security Agent to keep the Director of Safety informed as to the condition and progress of the injured jockey. It will be the responsibility of the Security Agent to obtain a copy of the accident from the T.V. department. The Security Agent will prepare a report as to the accident and treatment. The agent will also ensure that all workers compensation information pertaining to the jockey is accurate and current.”

Absent natural disasters or causes beyond the control of the association, its service contractors, concessionaires or horsemen participating at the meeting, no reasons are believed to exist that may result in a stoppage to racing at the meeting or the withholding of any vital service to the association except as follows (if no exceptions, so state): **No exceptions.**



BACKGROUND

At its July 2013 Regular Meeting the Board approved the application for license to conduct a horse racing meeting of the Los Angeles Turf Club II (T), at Santa Anita Park Race Track (SA), commencing September 25, 2013 through November 3, 2013. During its race meeting SA will host the 30th annual Breeders' Cup World Championship, Friday, November 1 and Saturday, November 2, 2013.

The Los Angeles Turf Club (LATC) has requested that it be allowed to amend its license application to permit the conduct of a non-thoroughbred race on the Breeders' Cup undercard on Friday, November 1, 2013.

ANALYSIS

The Business and Professions Code currently does not provide for the conduct of a non-thoroughbred race at a thoroughbred race meeting. However, Senate Bill 819, which is currently being considered by the California Legislature, has been amended to provide that on days during which the Breeders' Cup races are conducted in California, the Board may authorize pari-mutuel wagering on Breeders' Cup races to be run at the host venue and on one non-thoroughbred race specified in the host venue's license application approved by the Board. SB 819 has an urgency clause, which would cause the bill to take effect immediately. If the Board approves the request by LATC to amend its license application, the action would be contingent on the passage of SB 819.

RECOMMENDATION

This item is presented for Board discussion and action. Any approval of the request by LATC would be contingent on the passage of SB 819.

BACKGROUND

Business and Professions Code section 19420 provides that the Board shall have jurisdiction and supervision over meetings in California where horse races with wagering on their results are held or conducted, and over all persons or things having to do with the operation of such meetings. Business and Professions Code section 19440 states the Board shall have all powers necessary and proper to enable it to carry out fully and effectually the purposes of Chapter 4, Business and Professions Code. Responsibilities of the Board shall include, but not be limited to, adopting rules and regulations for the protection of the public and the control of horse racing and pari-mutuel wagering. Business and Professions Code section 19590 provides that the Board shall adopt rules governing, permitting, and regulating pari-mutuel wagering on horse races under the system known as the pari-mutuel method of wagering. Business and Professions Code section 19605.25 authorizes the Board to license up to 15 minisatellite wagering facilities in both the northern zone and the southern zone.

Senate Bill 305, Chapter 334, Statutes of 2011, amended Business and Professions Code section 19605.25, subsection (a), to change the term of license for minisatellite wagering facilities from two years to up to five years.

In accordance with the change to the enabling statute the Board has been approving five-year minisatellite licenses. Santa Clarita Lanes, OC Tavern, Commerce Casino, Twisted Kilt, Sammy's of Lake Forrest and Silky Sullivan's applications for license to operate a minisatellite facility were all approved for five years.

The amendment to Rule 2066 went before the Board at the June 20, 2013 Regular Board Meeting. The Board directed staff to initiate a 45 day comment period which closed September 16, 2013. No comments were received during the 45-day comment period.

ANALYSIS

Pursuant to Business and Professions Code section 19605.25, the proposed amendment to Rule 2066 would increase the term for a minisatellite wagering facility license from two to five years. This amendment is required for Rule 2066 to reflect the change in statute, as well as current Board practice of approving minisatellite applications for license for a period of five years.

RECOMMENDATION

This item is presented for Board discussion and action. Staff recommends the Board adopt the proposed amendment to Rule 2066 as presented.

2066. Application for License to Operate a Minisatellite Wagering Facility.

(a) An applicant for license to operate a minisatellite wagering facility shall complete an Application for License to Operate a Minisatellite Wagering Facility CHRB-228 (New 11/08), hereby incorporated by reference, which is available at the Board's headquarters office. Note: CHRB-228 incorporates by reference the Personal History Record form CHRB-25A (Rev. 11/08). The application must be filed not later than 90 days in advance of the scheduled start date of operation. The application must include a certified check in the amount of \$500.00 payable to the Treasurer of the State of California for a nonrefundable application fee. The term of the license shall be ~~two~~ five years from the date the license is issued.

(b) The Board may conduct investigations, inspections or request additional information from the applicant, as it deems appropriate in determining whether to approve the license.

(1) Upon the written request of the applicant the Board may waive the requirement for submission of a Full Disclosure Statement and CHRB-25A for persons who have a current valid state gambling license and/or finding of suitability issued by the California Gambling Control Commission.

(c) The Board, or its designee, shall be given access for review and audit of all records. The applicant shall, at its location during hours of operation, make such information available. The Board may require the applicant to annually submit audited financial statements.

(d) All advertisements shall contain a statement that persons under 21 are not allowed access to the minisatellite wagering site. All advertisements shall contain contact information for a recognized problem-gambling support organization.

(e) The Board shall notify the applicant in writing within 30 calendar days from the date the application is received by the Board's administrative office if the application is complete or deficient. If the application is deficient, the notice shall include:

(1) Instructions as to what is required of the applicant to complete the application.

(2) Instructions for requesting additional time to satisfy the requirements listed in the notification, if needed.

(f) The Board shall approve or deny an application within 90 calendar days from the date it is received by the Board unless the applicant requests and is granted additional time to supply information.

(g) If the Board denies an application, the applicant has 30 calendar days from the date of receipt of the Board's denial notification to request a reconsideration of the Board's decision. The request must be in writing and sent to the Board's headquarters office. The Board shall respond in writing to the reconsideration request within 30 working days from the date of receipt of the request. If reconsideration is denied, the applicant may file for judicial review in accordance with Business and Professions Code section 19463.

(h) After a license to operate a minisatellite wagering facility is issued under this article, changes or amendments to information or operating procedures contained in the application for the license will be permitted by order of the Board or by Board approval of a request submitted in writing by the applicant.

BACKGROUND

In May 2013 Hollywood Park Race Track announced it would permanently close upon the completion of its fall 2013 race meeting, which opens November 7, 2013 and ends December 22, 2013. The closure of Hollywood Park will cause the industry to lose approximately 1,000 stalls that would normally be available when the facility is not hosting live racing. At the June 2013 Regular Board Meeting industry representatives made a presentation regarding the status of discussions regarding southern California auxiliary off-track stabling. Thoroughbred Owners of California (TOC) President Joe Morris reported the Vanning and Stabling Committee voted to fund the relocation of horses displaced by the pending closure of Hollywood Park to three auxiliary stabling locations: Santa Anita with 1,900 stalls, San Luis Rey Downs training center with 500 stalls, and Los Alamitos with 500 stalls. Following the presentation the Board requested that the industry return to provide an update on the auxiliary off-track stabling issue.

At the July 2013 Regular Board Meeting Mr. Morris reported the Vanning and Stabling Committee was still considering the use of Santa Anita, San Luis Rey Downs and Los Alamitos for the purposes of auxiliary stabling. However, the committee was also considering other options, including Fairplex Park Pomona (Fairplex). Mr. Morris stated in addition to location of stalls, there were issues that would affect how many stalls were needed and/or available. The issues included the number of horses in southern California and the requirements of the Water Quality Control Board for Fairplex and Santa Anita. The parties also discussed the possible use of an industry fund created in response to the stabling issue. Industry representatives agreed to meet informally with Chairman Israel in an effort to reach a compromise regarding stabling issues.

At the August 22, 2013 Regular Board Meeting stakeholders reported there had been progress in resolving stabling issues for the southern California thoroughbred circuit. Santa Anita, San Luis Rey Downs and Los Alamitos would be used for auxiliary stabling and training. Hollywood Park Race Track stated it agreed to remain open for auxiliary stabling until at least January 31, 2014.

Business and Professions Code section 19530 provides the Board the authority to allocate racing weeks to an applicant pursuant to the provisions of the horse racing law and to specify such racing days, dates, and hours for horse racing meetings as will be in the public interest, and will subserve the purposes of the law. Business and Professions Code section 19531 states the Board shall make allocations for racing weeks, including simultaneous racing between zones as it deems appropriate. The maximum number of racing weeks that may be allocated for horse racing other than at fairs, shall be as follows: (a) For thoroughbred racing: 44 weeks per year in the northern zone; 42 weeks per year in the central zone; and seven weeks per year in the southern zone. (b) For harness racing: 25 weeks per year in the northern zone. (c) For quarter horse racing: 25 weeks per year in the northern zone. (d) For harness racing and quarter horse racing: a total of 77 weeks per year in the combined central and southern zones. Business and Professions Code section 19532(a) specifies any association licensed to conduct thoroughbred racing in the northern zone may receive no more than 35 weeks of that racing. (b) Any association licensed to conduct thoroughbred racing in the central zone may receive no more than 17 weeks of that racing, except that any association which conducts a split meeting may receive up to 20 weeks of that racing. No more than one such split meeting may be licensed in any one year. Business and Professions Code section 19549 provides the maximum number of racing weeks that may be allocated to a fair shall be four weeks each, except under specified conditions.

Board Rule 1430, Allocation of Racing Weeks and Dates, states the Board shall allocate racing weeks and dates for the conduct of horse racing in this State for such time periods and at such racing facilities as the Board determines will best subserve the purposes of the Horse Racing Law and which will be in the best interests of the people of California in accord with the intent of the Horse Racing Law.

ANALYSIS

At the June 20, 2013 Regular meeting the Board allocated the following 2014/2015 quarterhorse race dates to the Los Alamitos Racing Association, with the actual live race dates to be determined at the time applications are submitted to the Board:

2014 ALLOCATED RACE DATES**LOS ALAMITOS RACING ASSOCIATION**

- LARA at Los Alamitos - December 27, 2013 through December 21, 2014

LARA will apply to race 3 days per week (Friday through Sunday) except for Sunday February 9, 2014.

2015 ALLOCATED RACE DATES

- LARA at Los Alamitos - December 26, 2014 through December 21, 2015

LARA will apply to race 3 days per week (Friday through Sunday) except for Sunday February 9, 2015.

Los Alamitos has submitted a proposal to operate thoroughbred race meetings in 2014 and 2015.

2014 REQUESTED THOROUGHBRED RACE DATES

LARA submitted its request for the following 2014 thoroughbred race dates

- LARA at Los Alamitos - July 3, 2014 through July 13, 2014
- LARA at Los Alamitos - December 4, 2014 through December 21, 2014.

2015 REQUESTED THOROUGHBRED RACE DATES

LARA submitted its request for the following 2015 thoroughbred race dates

- LARA at Los Alamitos - July 2, 2015 through July 12, 2015
- LARA at Los Alamitos - December 3, 2015 through December 20, 2015.

RECOMMENDATION

Staff recommends the Board hear from the parties.

Any allocation of thoroughbred race dates to the Los Alamitos Racing Association will need to be contingent on the signing of AB 1074, Statutes of 2013, which amends the horse racing law to allow the Board to allocate a maximum of five weeks per year to a thoroughbred racing association to conduct thoroughbred racing at a racetrack in the southern that was not used to conduct a thoroughbred race meeting in the southern zone prior to 2012.

Los Alamitos to request summer dates for 2014

Los Alamitos will ask the California Horse Racing Board at its meeting next Thursday for as many as three weeks of Thoroughbred racing next summer, and also plans to expand its racetrack, a track official said Wednesday.

The plan revives a project shelved in the spring by the Orange County, Calif., track, and will include a previously assigned two-week Thoroughbred meeting in December 2014 which follows the fall meeting at Del Mar and precedes the start of the Santa Anita winter meeting.

Track consultant Brad McKinzie said Los Alamitos officials have held discussions with their counterparts at Santa Anita and with representatives from horsemen's groups about conducting a meeting that would run from late June until mid-July.

The first two weeks of the meeting would replace dates assigned to Santa Anita, which is currently scheduled to race into July. The final week of the proposed meet would come after the close of the currently scheduled Santa Anita meeting and before the start of the Del Mar summer meeting.

The racing board is scheduled to discuss the 2014 racing calendar at its monthly meeting next Thursday.

The dates Los Alamitos is planning to run have been part of race meetings at Betfair Hollywood Park for more than 30 years. Hollywood Park is scheduled to close at the end of this year.

In addition to two proposed race meetings, Los Alamitos plans to expand its racetrack from its current five-eighths of a mile circumference to a mile, McKinzie said. Los Alamitos does not have plans for a turf course.

The track is expected to be able to stable up to 700 Thoroughbreds displaced by the closure of Hollywood Park.

“We have plans to build a mile racetrack and offer stalls to 700 horses,” McKinzie said. “Our hope is to have five or six weeks of Thoroughbred racing at Los Alamitos to justify it.”

Los Alamitos currently conducts a mixed meeting for Quarter Horses and lower-level Thoroughbreds.

Last March, McKinzie said the track would not seek to expand its racetrack or seek further racing dates to avoid a showdown with Barretts Racing and Sales at Fairplex Park, which had stated a desire to expand its track.

But at the racing board’s May meeting, Los Alamitos requested racing dates in December. Fairplex Park did not seek racing dates beyond its traditional meeting in September, nor did it advance plans for expansion.

The current Los Alamitos plan would make the final turn wider than in previous proposals, something the California Thoroughbred Trainers had been requesting.

The issue of offtrack stabling in the absence of Hollywood in 2014 remains unresolved and is expected to be part of lengthy discussion at Thursday’s racing board meeting unless a late resolution is reached between the California Thoroughbred Trainers and the Thoroughbred Owners of California. The two sides have disagreed on where offtrack stabling should be conducted among Fairplex Park, Los Alamitos, and San Luis Rey Downs in northern San Diego County.

BACKGROUND

At the May 23, 2013, Regular Board Meeting, representatives of the Thoroughbred Owners of California (TOC), Santa Anita Park, Del Mar Race Track, and Fairplex Park expressed agreement in general on proposed racing calendars for 2014 and 2015. Hollywood Park was not included in the proposed calendars because Hollywood Park's owners previously announced their intention to close the racetrack at the end of 2013 to develop the property. The closure of Hollywood Park releases racing dates historically allocated to that facility. In 2013, these racing dates are April 24 through July 14 and November 6 through December 22. Following a three-hour discussion, the Board conditionally, or tentatively, allocated the requested racing dates as follow (beginning with the 2014 racing-year calendar):

12-26-13 to 7-6-14, Santa Anita Park

7-16-14 to 9-3-14, Del Mar

9-4-14 to 9-23-14, Fairplex

9-25-14 to 11-2-14, Santa Anita

11-5-14 to 12-7-14, Del Mar

(continuing with the 2015 racing-year calendar)

12-26-14 to 7-5-15, Santa Anita

7-15-15 to 9-7-15, Del Mar

9-10-15 to 9-25-15, Fairplex

9-26-15 to 10-15-15, Santa Anita

10-28-15 to 12-6-15, Del Mar

There have been a number of unresolved issues pertaining to the 2014 and 2015 racing calendars and the future of thoroughbred horse racing in Southern California, as discussed at the May 23 and the June 20 Regular Board Meetings. Principal among these issues is arranging for adequate stabling for horses normally stabled at Hollywood Park that will be displaced after January 1, 2014. At the May 2013 Regular Board Meeting individual racing commissioners expressed their concerns about a variety of issues, some of which were expressly cited as conditions for the allocation of 2014 and 2015 racing dates. The Board determined that representatives of Del Mar must agree in writing to relinquish the 2015 Breeders' Cup dates to Santa Anita if the 2015 Breeders' Cup is awarded to Santa Anita. In addition, Del Mar and Santa Anita must agree in writing to properly compensate Fairplex for the loss of two weekend dates in 2015.

The issue of the conditions placed on the allocation of the 2014/2015 Southern California racing calendar was again discussed at the July 18, 2013 Regular Board Meeting. As the parties had not reached an agreement, Chairman Israel agreed to meet with representatives of Santa Anita and the CTT to resolve differences that were delaying a signed agreement for the Santa Anita fall meeting.

The conditions placed on the allocation of 2014/2015 Southern California racing calendar was discussed at the Board's August 22, 2013 Regular Meeting. The issue was put over to the September 2013 Regular Meeting primarily because an agreement on auxiliary stabling had not been finalized.

ANALYSIS

Among the many issues related to the allocation of the 2014/2015 Southern California racing calendar, four stood out as conditions for the allocation of racing dates:

- 1) The industry must agree on a stabling and vanning plan to meet the future needs of an adequate inventory of horses to maintain the Southern California thoroughbred racing circuit. The Board is insistent that the California Thoroughbred Trainers be allowed input on this decision.
- 2) There must be an agreement on an industry fund to provide a permanent solution for stabling and vanning.
- 3) There must be an agreement between TVG and HRTV allowing both horse racing networks to continue showing races at all racetracks in the state.
- 4) As the principal beneficiary of the racing dates vacated by Hollywood Park, and given the CHRB's long and consistent demand that the stable area, in Arcadia be vastly improved, Santa Anita must submit a backstretch improvement plan to the Board.

RECOMMENDATION

Based on the progress reports from the industry in meeting the expressed conditions, the Board may consider making permanent the temporary allocations of 2014/2015 Southern California race dates made at the May 23 Regular Meeting.

Proposals for Northern California race dates were received from Pacific Racing Association (PRA); Santa Rosa County Fair at Sonoma, California Authority of Racing Fairs (CARF), on behalf of the Northern California CARF fairs; California Exposition and State Fair (State Fair and harness; Watch and Wager LLC.) (Cal Expo).

The allocation of the 2014/2015 Northern California thoroughbred and fair circuit was postponed to allow the stakeholders an opportunity to meet and resolve any potential issues and return to the Board with proposals for the 2014/2015 race year.

Subsequent to the May 23, 2013 Board meeting, the Northern California 2014/2015 racing calendar proposals were received and presented at the June 20, 2013 and July 18, 2013 meetings of the Board.

The following Northern California race dates requests are identical to those submitted at the Board's May, June and July regular meetings.

2014 NORTHERN CALIFORNIA RACING CALENDAR PROPOSALS

PACIFIC RACING ASSOCIATION

PRA submitted its request for the following 2014 race dates:

- PRA at Golden Gate Fields - December 26, 2013 to June 29, 2014 (Winter/spring race meeting)

- PRA at Golden Gate Fields – October 13, 2014 to December 14, 2014 (Fall race meeting)

SONOMA COUNTY FAIR AT SANTA ROSA

- Sonoma County Fair at Santa Rosa- July 23, 2014 – August 3, 2014
- PRA at Golden Gate Fields – December 26, 2013 to June 15, 2014
- PRA at Golden Gate Fields – August 20, 2014 to September 14, 2014
- PRA at Golden Gate Fields – October 16, 2014 to December 21, 2014

In July CARF submitted that in order to continue discussion of multiple-year calendars and to allow for the transitional planning which would be required for fairs, they respectfully requested that the Board approve the following race dates for GGF:

- December 26, 2013 through June 15, 2014
- October 16, 2014 through December 21, 2014

In addition, CARF requested that the Board defer a decision on 2014 summer racing dates until the Board's September 2013 regular meeting, by which time the Sonoma County Fair in Santa Rosa and Humboldt County Fair in Ferndale would have concluded their 2013 race meetings.

CARF believed that this approach would allow for an initial decision confirming most of the dates that GGF has requested for 2014. These non-summer dates represent a large segment of the annual racing calendar in Northern California, so approval of those dates would allow GGF to plan ahead for most of 2014. At the same time, this approach would give Fair Boards a chance to consider potential changes to the summer fair racing calendar in Northern California for 2014 and 2015.

In conjunction with CARF's request to defer a decision on 2014 summer racing dates until the Board's September 2013 regular meeting, the California Exposition and State Fair, also requested that the Board's discussion and decision regarding 2014 and 2015 Northern California Fairs race dates be continued until the end of the summer fair season. The request was based on a number of factors including the impending opening of the State Fair and the Alameda County Fairs. Both fairs have new CEO's that were working to produce successful face meetings. In addition there were significant changes this summer at the Sonoma County and San Joaquin County fairs. Given the amount of change, Cal Expo submitted that it seemed prudent to get through the bulk of the Northern California Fair Race meetings this summer so that all parties can better evaluate the fairs future.

Cal Expo also submitted that in order for GGF to plan appropriately for the first half of 2014, the Board could approve the 2014 spring race dates at GGF up to June 15, 2014.

Cal Expo also submitted its request for the following 2014 race dates for state fair racing:

- Cal Expo (State Fair) - July 9, 2014 – July 22, 2014

Cal Expo requested approval to readdress its request after a determination of the Southern California dates allocation has been approved.

POSSIBLE THOROUGHBRED RACING AT CAL EXPO

Cal Expo is open to discussing additional racing dates at Cal Expo outside of the annual State Fair. It has been suggested that the dates of August 13, 2014 through September 3, 2014 should be considered. These dates might consist of 10 live racing days and 12 simulcast days. However, Cal Exp submits that such racing would need the input and support of California's racing industry.

Although it plans to operate the 2015 State Fair in July of 2015, it has been approached by members of the racing industry, suggesting that the State Fair shift its fair dates back to the end of the summer to encompass the Labor Day weekend. While the State Fair is open to prudently dialoguing with industry leaders on this item, such discussion could not be adequately held until much later in the year. Discussion would need to be broad based to include the racing industry, as well as other fair industry partners that would be impacted by such date changes. In addition the timing and possible impacts of Cal Expo's Renewal Plan would also need to be carefully considered.

RECOMMENDATION

Staff recommends the Board hear from the parties.
