MINUTES

Chairman Brackpool asked for approval of the minutes of the regular meeting of July 22, 2010. Commissioner Rosenberg **motioned** to approve the minutes. Commissioner Moss **seconded** the motion, which was **unanimously carried**.

PUBLIC COMMENT

Richard Castro, representing Local 280, said the issue of his licensure and access to the restricted area of the inclosure had not been resolved. CHR B staff counsel, Robert Miller, stated a letter would be sent to the legal firm that represented Local 280. The CHR B would not require Mr. Castro to obtain an occupational license. However, Mr. Miller noted Mr. Castro previously stated he would obtain a license regardless. Mr. Castro acknowledged that he intended to apply for a CHR B license. Mark Russo, an interested party, spoke about his concerns regarding the age at which horses begin to race. Richard and Helen Nielsen-Eckfield of Savvy Seniors at the Track spoke about two of Savvy Seniors at the Track's projects to improve the Del Mar Race Track facility.

Richard Castro spoke about a wagering kiosk that was included in his organization's labor agreement, but had yet to be opened. He stated he was confident the employer would follow through with the kiosk, but if not, Local 280 was prepared to take action. Mr. Castro said he was providing verbal notice, and would follow up with written notice.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE OAK TREE RACING ASSOCIATION (T) AT SANTA ANITA PARK RACE TRACK, COMMENCING SEPTEMBER 29, 2010 THROUGH OCTOBER 31, 2010, INCLUSIVE.

Chairman Brackpool said it was common knowledge that there were concerns over the condition of the racing surface at Santa Anita Park Race Track (SA), and whether it would be in a condition to host the Oak Tree Racing Association (OTRA) meeting commencing September 29, 2010. The CHRB retained the services of Dr. Michael Peterson of the University of Maine to examine the SA track. Dr. Peterson was prepared to make a report to the Board regarding his findings. Dr. Peterson said he was a professor at the University of Maine and the Executive Director of the Racing Surfaces Testing Laboratory, a nonprofit consortium that developed standardized testing for the racing industry. Dr. Peterson stated he had knowledge of dirt and synthetic surfaces, and he had tested approximately 60 racetracks and major training centers across the United States. Dr. Peterson said the goal of his work was to measure the performance of the racetrack. Towards that end, he had developed a Biomechanical Hoof Tester, and he used laboratory tests to determine the performance of racetrack materials. He added there was a lot of judgment involved, and he relied on trainers, owners and others involved in the industry to interpret his findings. Dr. Peterson stated his underlying philosophy was

that consistency should lead to safer track surfaces. Understanding racing surfaces was a long term project because racing had relatively few fatalities per thousand starts, so more starts were required to develop statistically meaningful data. However, on a short-term basis, it was possible to evaluate if a track was consistent and if it matched the performance of other tracks. Dr. Peterson said he used the Biomechanical Hoof Tester at SA and found the peak loads on the hoof, as well as the shear strength was within the normal range. The surface consistency was also good. Dr. Peterson stated measurements of 7 and 14 feet off the rail were taken to look at the consistency of the surface, which was good. Another part of the equation was what the horse felt as it moved forward. The typical synthetic track had a cushion on top with the same composition as the pad. Underneath the top cushion was a pad that was reset daily or weekly. Under the pad was porous asphalt, or a geo-textile, which would allow water to drain into the base with rock and a drainage system. The top cushion was fluffed multiple times a day with a harrow, and the pad was reset daily (at most racetracks) with a power harrow or a cultivator. The SA track design and maintenance was unlike other synthetic tracks. The surface was a separated fiber and fine material with a waxy hardpan layer underneath. The membrane was a plastic variation of a geo-textile; the base was rock and drains. In the case of the SA track the waxy hardpan was like a false base. Dr. Peterson said to look at the racetrack he used ground penetrating radar that allowed one to look down into the track, and that provided a cross section. The radar showed that the SA track was deep on the turns and shallow around the finish line. There were also issues associated with unevenness in the chute. Dr. Peterson stated he also checked the hardness of the base. Ideally, there should be little variation in the surface, and consistent hardness. However,

at the quarter pole, half pole and three-quarter pole there was quite a bit of difference. Another issue associated with the SA track was a comparison of the size of the sand particles. Within the SA track there were big particles of sand and little particles. This resulted in compaction, especially with the wax polymer. Dr. Peterson said another issue with the SA track was moisture. The SA track could hold quite a bit of moisture, and a number of persons had observed that it was like a sponge. This issue was particularly important during the winter race meetings because the track could hold as much as 22 percent moisture content. Even with a warm synthetic racetrack, one would not expect more than 16 percent, so the difference was significant. Finally, rocks in the surface were a concern. From one 8-foot-wide path 30 feet around the oval the number of rocks that were picked were a significant concern. Dr. Peterson commented an important caveat was that the SA surface was very safe in the winter of 2010. The number of catastrophic injuries was low. However, the concerns were that the track should be consistent as the horse traveled around the oval, and that it should not be significantly different from other tracks. The primary issue with the SA track was that it did vary significantly around the track. Chairman Brackpool asked Dr. Peterson if the SA track was safe to run a race meeting on. Dr. Peterson said he could not answer the question; however, he could state that given the inconsistency of the false base, he had significant concerns about the track. Commissioner Rosenberg asked Dr. Peterson if he had any information on what had changed at the SA track since the end of the last meeting. Dr. Peterson said he did not have such information, which was a major limitation. He stated at Churchill Downs he was able to conduct a complete evaluation of the surface at the beginning of every race meet, and at intervals during every race meet, which provided a picture of how conditions

changed over time. Vice-Chairman Israel asked if surveys done with incremental testing allowed Dr. Peterson to extrapolate going forward. Might the exemplary SA winter meeting have been a prologue for an OTRA meeting at SA? Dr. Peterson said the scientific answer was "no." However, it was known that the tests correlated to performance issues, and over time the tracks changed. That was the philosophy behind constant monitoring. The goal was to find problems before horses were injured. One did not want to keep adapting the racing surface based on tracking injuries. Commissioner Harris asked if the rocks in the racing surface were working their way up from the base, or were rocks present in other tracks. Dr. Peterson stated he rarely saw as many large rocks. He commented there was a mathematical problem that demonstrated why the rocks were present. In a mixed bag objects will rise related to their size. Commissioner Choper asked if within the next six weeks there was anything that could be accomplished to bring the track to a model condition. Dr. Peterson said the options were to create a pad on the surface, which the presence of the sand made difficult, or to level the hardpan layer, which was currently not level and consistent. He added the challenge at SA was that there were no other similar tracks. Commissioner Choper stated if the SA maintenance crew could accomplish Dr. Peterson's proposals, the apparent problems would be significantly addressed. Dr. Peterson said that was correct. Commissioner Rosenberg asked if Dr. Peterson could make a determination as to whether synthetic tracks were more or less safe than dirt surfaces. Dr. Peterson stated the safety issue was best addressed by injury, death and career-ending did-not-finish data. He could say synthetic tracks removed the moisture content variability. Instead of variation in the track due to moisture, one saw variation due to temperature. Synthetic tracks also

resulted in a repaired base, which was a huge advantage. Removing the moisture variability and repairing the base were huge improvements; one only had to look at the catastrophic injury rates. There were a lot of challenges with synthetic tracks and there were outstanding dirt tracks, but the consistency of the synthetic tracks – when properly constructed – was better than dirt tracks. Vice-Chairman Israel asked if there was an expiration date that applied to synthetic tracks. Dr. Peterson said everything on the synthetic tracks could be fixed except the sand. When the sand started to wear out, the track was expired. Vice-Chairman Israel asked if Dr. Peterson owned a \$3 million horse, would he enter it in an October 2010 stakes race at OTRA. Dr. Peterson said there were statistical risks and individual risks. If he had such a horse, he would defer to someone who knew the horse and the track. Frank Stronach of MI Developments, Inc. (MID) stated he had been involved in all aspects of horse racing, and had observed that it was crucial for a dirt track to have a solid base with good drainage. Synthetic tracks that use wax and oil were futile, as there was no way to achieve consistency. Mr. Stronach commented he had a fruitful meeting with horsemen, owners and trainer on August 18, 2010. He stated he informed the horsemen that SA was committed to immediately start the engineering and gathering materials for a new racing surface. It was up to OTRA and the horsemen to decide if it wished to run at SA despite the safety issues. MID would be happy if OTRA decided to run at SA, but if not, there would be no problem. Chairman Brackpool stated there was currently a mandate in place for synthetic racing surfaces under specific conditions. If SA wished to change its racing surface, it would have to make an application to the Board. The application would have to include the Board's specific requirements, such as expert opinions, methods for safety, bonding requirements

and other items. MID would work with the CHRB executive staff to fulfill the Board's requirements and to ensure that the change in racing surface would be better than the current track. Chairman Brackpool asked if MID would honor its commitment to lease SA to OTRA if the horsemen and OTRA determined they wished to run at SA. Mr. Stronach said MID would honor its commitment. Vice-Chairman Israel asked if SA was sure its calendar could be met: it would be open for training a couple of weeks before December 26, 2010, and for racing on December 26, 2010. Mr. Stronach stated he was personally involved and he was sure SA would be open the second weekend in December 2010 at the latest. Commissioner Harris asked how soon work on the SA track would begin. Mr. Stronach stated if OTRA decided to run at SA work would begin the day after the last race of the meeting. If OTRA did not run at SA, work would begin as soon as the materials were on hand. Chairman Brackpool said that in speaking with SA management he understood there was no real difference if OTRA ran at SA, or not, because much of the pre-work was non-construction, such as permits and ordering the soil. So, what was the earliest date SA could reasonably begin physical construction? Mr. Stronach stated he believed that construction could begin the day after the last OTRA race. That was assuming SA received permits to construct the track within two or three weeks. Sherwood Chillingworth of OTRA stated his organization had been concerned with the welfare of the horse for 42 years, and it would not be asking for race dates at SA unless it thought the SA racing surface was safe. He stated that in speaking with SA track maintenance he learned the track had not been dressed for racing for over two months, so it deteriorated a bit. It would take maybe two or three weeks to rework the track and get it into a consistent state. In the interim, OTRA wished to meet separately with trainers

and owners and return with a more specific statement. Chairman Brackpool said that was an excellent idea, as the Board wished to have as much agreement as possible. Its' main concern, however, was safety. Mr. Chillingworth stated OTRA was on a bit of a rollercoaster ride, as its intended venue continually changed. Its latest venue was SA, and it had concluded contracts and promotional agreements worth \$200,000 that would disappear if OTRA had to move. Commissioner Rosenberg said a report on the safety of the SA track was just heard, and the OTRA directors had not had time to discuss the findings. So, what was the purpose of meeting with the horsemen and the owners if OTRA did not have a position on the track? Mr. Chillingworth stated the purpose of the meeting was to reach a consensus. (Interested parties retire for a meeting in a separate room) Mr. Chillingworth stated OTRA ran at SA for 41 years and 2010 was its last year at that facility. He said he understood the protection of the horse was paramount, so OTRA asked Rick Tedesco, the SA track superintendent, to describe his plans for the track that he believed would make it perfectly safe. Mr. Chillingworth added OTRA had signed multiple contracts and had taken in between \$750,000 and \$1 million in receipts. Much of that money was in advance sales, which would have to be returned if OTRA were to move its meeting. Mr. Chillingworth stated OTRA did not believe the track was a hazard, and there were steps that could be taken to address Dr. Peterson's report. Mr. Tedesco said SA was currently addressing Dr. Peterson's concerns, and described the work that was occurring at the racetrack. He also talked about the rocks in the racetrack surface and the steps SA took to mitigate the problem. Mr. Tedesco said he believed the track was safe. Commissioner Choper asked if Mr. Tedesco noticed any differences in the SA racing surface after the track was reworked by Pro-Ride. Mr. Tedesco said when

Pro-Ride replenished the track there were fewer polymers. However, that had not contributed to the unevenness because it could be controlled with water. Vice-Chairman Israel said Dr. Peterson indicated the reaction of the sand was a larger issue than rocks in the track surface. He asked how SA was dealing with the sand. Mr. Tedesco stated when SA first realized it had a problem with the racetrack it brought in multiple parties as consultants. The composition of the track was changed to such a degree that it currently could not be reproduced; no one knew what was in the track. Larger particles of sand were added for percolation, but that did not work. Mr. Tedesco stated he had learned how to work with the SA track. The membrane formed because the fine particles of sand shifted to the bottom, so maintenance was performed weekly to mix up the track materials. Arnold Zetcher of Thoroughbred Owners of California (TOC) stated he also represented the leadership of the California Thoroughbred Trainers (CTT). He stated his organization welcomed SA's move to resolve its track surface problems. TOC and CTT would also like to formalize the horsemen's group that was working with SA to ensure all parties were comfortable with a new racing surface; however, that was a long-term issue. Mr. Zetcher briefly reviewed the sequence of actions taken by TOC and CTT regarding the condition of the SA track. He commented that when the horsemen heard the CHRB would bring in Dr. Peterson, they decided to reserve judgment until a report was presented to the Board. The conclusion of TOC and CTT was that there was no guarantee that over the next three or four weeks the SA track could be corrected and ready for racing. Mr. Zetcher added the owners were not experts, and they had to rely on the opinions of trainers and experts to reach a conclusion; however, TOC did not believe the racetrack was worth the risk. TOC would recommend that the OTRA race meeting be

moved to Hollywood Park. TOC was aware of the history of the issues, and it knew how much OTRA desired to run at SA, but none of that made a difference. The only thing that mattered was the safety of the racetrack and the health and welfare of the horses and jockeys. Mr. Zetcher stated TOC was aware that SA believed the new track could be put in place in a short period of time, but if SA had four months as opposed to two months, it would benefit all parties. This was a secondary issue, but combined with the safety concerns, it made sense to TOC to move the OTRA meeting. Chairman Brackpool said he disagreed with the TOC's secondary position. The issue with replacing the SA track was the timing, not the physical construction. He stated a working group would be set up. The CHRB would hire its own expert, and put together a working group with SA. John Sadler of CTT stated his organization was working with TOC, and it agreed that the OTRA race meeting should be moved to Hollywood Park. Mr. Sadler added that Dr. Peterson also tested the Hollywood Park track, and he did not have the same concerns as he did with the SA track. Commissioner Rosenberg asked if CTT or TOC was concerned that statistically the SA meeting was safer than the Hollywood Park meeting. He added there were a number of trainers who worked horses at SA through the end of its meeting, and who felt the track was safe. The SA track was sitting unused for some time before it was examined by Dr. Peterson; why did the CTT and TOC believe it could not be made whole before the OTRA meeting would open? Mr. Sadler stated the SA track changed since the winter of 2009. A lot was done to the track to make it drain properly, and the impression was given that a new track would be installed. The horsemen simply did not believe some of the core issues could be resolved in a short period of time. Commissioner Harris asked if Dr. Peterson had any quantifiable data that could be used

to compare the SA and Hollywood Park tracks. Dr. Peterson said he had not prepared data for discussion. However, the primary difference between the tracks was that Hollywood Park's track was more of a standard synthetic track, and the hardpan layering did not exist. Hollywood Park did not have the inconsistency in depth and cushion that existed at SA. In addition, the Hollywood Park track did not have the same sensitivity to moisture. Commissioner Harris asked if there was an issue with rocks at Hollywood Park. Dr. Peterson said he never saw any rocks at Hollywood Park. Vice-Chairman Israel asked if it was possible that the condition of the SA track deteriorated significantly since April 20, 2010. Dr. Peterson said he could not address that question as he was not at SA over that period of time. Vice-Chairman Israel stated the issue was that during December 26, 2009 through April 20, 2010 race meeting the SA track was exceedingly safe. During the last two Breeders' Cup events the SA track was safe. However, there now seemed to be questions as to whether the use of the track, its treatment and the various attempts to fix it over time have resulted in it being less safe than it was six months ago, and he was trying to understand the reasons. Dr. Peterson stated he did not have data from before the race meeting, or after. All he could say was that he currently had definite concerns. Chairman Brackpool asked if there was work done on the SA track over the past two months that would have changed the track. Mr. Tedesco stated he was consistent in his maintenance routine. He performed maintenance every Monday, and he informed the trainers of what he did. There was nothing changed in the SA maintenance operation in the past two years. Chairman Brackpool asked if Mr. Tedesco thought the problem areas identified by Dr. Peterson were present during the last SA winter meeting. Mr. Tedesco stated the chute was the same. The track received an

enormous amount of wear, so over a period of time there would be a difference. Commissioner Rosenberg asked if the SA track was maintained after April 20, 2010. Mr. Tedesco stated the track was maintained as it was used until the Del Mar meeting opened. Vice-Chairman Israel asked if any maintenance activity over the winter might have resulted in a change of the subterranean construction and composition that might have caused further erosion and inconsistency in the track. Mr. Tedesco said when there was a chance of rain he would punch holes in the track over the entire oval to aid drainage. Vice-Chairman Israel asked if the maintenance activity might have caused damage that was subsequently made worse over the summer. Mr. Tedesco stated the only damage he was aware of was at the finish line on the upper side. It would not drain, so machines were used in an attempt to open it up. Finally, pumps were used to drain the track, and it was covered with tarps. Chairman Brackpool asked what percentage of trainers was in favor of moving the OTRA meeting. Mr. Sadler said the trainers were of varied opinions, but the CTT board, who was elected by the membership, was in favor of moving the meeting. Commissioner Rosenberg asked how many trainers were complaining about the safety of the SA track prior to Del Mar opening. Mr. Sadler stated the trainers had a lot of issues, and saw every day what the track did to their horses. There were a lot of career ending injuries. On the other hand, some trainers loved the track, and some loved it one week and changed their minds the next week. Overall, the CTT believed there were problems. Commissioner Moss said Mr. Sadler had gone out of his way to get the opinion of all the trainers. There were a lot of comments about the safety of the SA track, and if there was a perception of a lack of safety, it concerned him and a lot of owners. Chairman Brackpool asked if the regular track and the turf course at Hollywood Park was

prepared if the OTRA meeting was moved. Jack Liebau of Hollywood Park said his organization believed its tracks were safe. Dr. Peterson was continually engaged to monitor the tracks, and there did not seem to be any complaints. The turf course would probably be in prime condition during the OTRA meeting, as the weather was warmer. Chairman Brackpool asked if Hollywood Park would be in a position to host the OTRA meeting on short notice. Mr. Liebau stated Hollywood Park would do whatever was in the best interests of horse racing. Hollywood Park realized there may be a little bit of difficulty, but it would do its best. Chairman Brackpool said the Board was considering an application to run the OTRA meeting at SA. The Board could vote on the application, or OTRA could withdraw it and make a new application to run at Hollywood Park. He stated a meeting to consider a new application would have to be noticed to the public because the Board could not authorize a race meeting without an application. Commissioner Harris commented OTRA would need time to negotiate a new horsemen's agreement so it would have a complete application. Chairman Brackpool asked if OTRA still wished to have a vote on its current application. Mr. Chillingworth said it would be better for OTRA to apply for the dates at SA and have the Board deny them. That would preclude the problem of breaking its contract with SA. Chairman Brackpool commented that MID was on record as stating what ever the result there would be no breach of contract. Commissioner Rosenberg asked if the TOC and CTT would agree to run at SA if the Board approved the application. Mr. Zetcher said the TOC could represent itself and give its opinions. Some owners may chose to run at an SA meeting, others would not. Chairman Brackpool asked if there had to be a TOC agreement. Robert Miller, CHRB Staff Counsel, said the statute provided that if there were no agreement, the Board

would make the ultimate determination. Chairman Brackpool stated the item could be held open while the OTRA board decided whether it wished to have the current application acted on by the Board, or withdraw the application and return with a new one at a later date. Mr. Chillingworth asked if OTRA stated it wished to run at SA and the Board voted to deny the request, could OTRA come back and request to run at Hollywood Park. Chairman Brackpool said OTRA could submit a new application for an alternate venue. (The parties retire for a meeting in a separate room.) Peter Miller, a trainer, spoke about his belief that the SA track was safe, and that moving the OTRA meeting to Hollywood Park would be a mistake. Howard Zucker, a trainer, spoke in favor of keeping the OTRA meeting at SA. Matthew Chu, a trainer, spoke in favor of keeping the OTRA meeting at SA. Mr. Chillingworth stated the OTRA directors determined they would not withdraw the OTRA application for license to operate a race meeting at SA. Richard Mandella, a trainer spoke in favor of keeping the OTRA meeting at SA. Commissioner Moss stated the industry rushed to install synthetic tracks, but they never delivered on their promise, and when MID announced it was going to install a dirt track many people celebrated. There needed to be some time to get a good base for a new track at SA, and the prospect of allowing SA four months to get a base and ensure the dirt track was operating well was beneficial. Moving OTRA to Hollywood Park for one year could be a spark for that facility. If SA is given four months to reinvent itself it would open on December 26, 2010 with great excitement and enthusiasm. The meeting would probably be the best seen in years with East Coast participation. Mr. Mandella said there would be over 3,000 horses trying to fit into Hollywood Park, which could hold up to 2,400 horses. The remainder would be at Pomona, not SA, so that in alone

would present dangers. Chairman Brackpool said the issue would exist whether or not OTRA ran at SA. Commissioner Choper stated the Board was not holding a hearing on the safety of the SA track. It was obvious that many persons were passionate about the issue, but the CTT and TOC made a decision on behalf of their members, which the Board could not ignore simply by hearing new testimony. Vice-Chairman Israel said the safety issue was paramount. The Board engaged Dr. Peterson to provide it with an objective analysis and from his presentation it would not be unfair to state there were some misgivings. The Board had to accept the doctor's findings, which appeared to direct it in how it would make a decision. There were hardships in moving the OTRA meeting, and it might not perform as well, but the information provided to the Board indicated there were concerns about the SA track, and if something untoward happened it would be on the Board's head. Chairman Brackpool asked if OTRA wanted the Board to vote on its application. Mr. Chillingworth stated SA gave OTRA a chance to run, and it simply could not state it wished to go elsewhere. Chairman Brackpool said there appeared to be disagreement about who represented the horsemen in the discussion. The Board was never asked to make a determination about the safety of the SA track. The OTRA was telling the Board that it would like to race where the TOC and CTT would not run. The staff recommendation indicated the horsemen's agreements were not in place and without the documents the Board should not approve the application. If OTRA wished the Board to take action on the application, it would. However the real questions would be answered at a Special Meeting once OTRA indicated it was ready to carry on the discussions. Chairman Brackpool stated he could not vote to approve the application given that the TOC and CTT would not agree to run at SA. If that were to change, that

would be a different matter. The vote was not a determination on the safety issue; it was determined by the positions of the horsemen's elected representatives. Jack Liebau stated Hollywood Park had gone the extra mile on the issue. Every day of delay made the prospect of a successful meeting at Hollywood Park more remote. In fairness to Hollywood Park the issue should be decided because dragging it out jeopardized the meeting. If OTRA withdrew its application, no decision on a venue would be made until OTRA could talk to all parties and change minds. There would also have to be another Board Meeting at some point in time. Mr. Chillingworth stated OTRA was not going to drag its feet. The meeting started September 29, 2010, and OTRA could not afford to dillydally. OTRA was just waiting for the hearing to determine if its application would be accepted or turned down. Mr. Chillingworth stated it would be better for the application to be turned down by the Board, as it would be cleaner, and OTRA could immediately proceed to talks with Hollywood Park. Commissioner Derek stated OTRA had contracts it already signed. If the Board turned down the application it would help OTRA renegotiate those contracts. Mr. Chillingworth said that was correct. If the Board turned down its application, OTRA could return to the parties and renegotiate. Chairman Brackpool **motioned** to deny the application to operate a horse racing meeting of OTRA because it did not have the required horsemen's agreement, and the TOC and the CTT would not be prepared to sign such agreements. Commissioner Moss **seconded** the motion, which was carried with Commissioner Rosenberg **abstaining**.

DISCUSSION AND ACTION BY THE BOARD REGARDING THE DISTRIBUTION OF RACE DAY CHARITY PROCEEDS OF THE DEL MAR THOROUGHBRED CLUB IN THE AMOUNT OF \$148,843, TO 18 BENEFICIARIES.

Chairman Brackpool stated the Del Mar Thoroughbred Club (DMTC) was requesting to distribute race day charity proceeds in the amount of \$148,843 to 18 beneficiaries. The staff analysis indicated over 90 percent of the proceeds would go to horse racing related charities. Staff recommended the Board approve the request as presented. Commissioner Choper **motioned** to approve the request of DMTC to distribute race day charity proceeds. Vice-Chairman Israel **seconded** the motion, which was **unanimously carried**.

REPORT AND UPDATE REGARDING THE DEVELOPMENT OF THE PROPOSED AMENDMENT TO CHRB RULE 2057, INITIAL APPLICATION AND APPROVAL OF A SIMULCAST FACILITY, AND THE ADDITION OF CHRB RULE 2057.1, GENERAL REQUIREMENTS FOR SIMULCAST WAGERING FACILITIES, AND RULE 2057.2, SIMULCAST WAGERING FACILITY INSPECTION REQUIRED, TO ESTABLISH FACILITY STANDARDS FOR CALIFORNIA'S SIMULCAST WAGERING FACILITIES.

Jacqueline Wagner, CHRB staff, stated the item was an update regarding the status of development of standards for simulcast wagering facility. The object was to establish a set of minimum standards to address conditions at simulcast facilities and to establish a minimum timeline to address any problems. Ms. Wagner said staff developed drafts of proposed regulations in conjunction with industry representatives. Providing feedback to staff were Thoroughbred Owners of California; California Authority of Racing Fairs (CARF); Southern California Off-Track Wagering, Inc.; Northern California Off-Track Wagering, Inc.; and CHRIMS. It was anticipated that a final proposal would be presented to the Board at a future Regular Meeting. Chairman Brackpool stated the draft texts of the proposed regulations, which were included in the Board's package, were the

direction in which the Board wished to go. He added he agreed with some of the suggestions put forth by the industry. The balance needed was between objective criteria and the subjective decisions that would be in the mix. Chairman Brackpool stated he wondered if there needed to be others involved in the process, as some would have a slightly different point of view. Commissioner Rosenberg asked if the proposal for a biannual license would grandfather in existing satellite facilities. Ms. Wagner said that once the regulations were in place existing satellites would be invited to submit applications to update the Board regarding their facilities. The original licenses were issued in the 1980s, and the applications no longer existed. Commissioner Rosenberg asked if the Board had authority to request new applications. Ms. Wagner said the original regulations and enabling statute did not contain terms of license, so the issue would have to be researched. Commissioner Rosenberg asked if the satellites would be treated as a whole, or individually? Ms. Wagner said the satellites would be looked at individually. Commissioner Rosenberg asked if there would be requirements regarding the numbers of patrons served. The satellites occupied a 20-mile buffer zone, and did not serve a lot of patrons. Perhaps there could be conditions of license that involved numbers of patrons served in the past as compared to present physical facilities and performance. Chairman Brackpool commented he did not know if the statutes permitted the Board to take that approach. The satellites already existed and there was a 20-mile radius. However, if there were established criteria that a satellite did not meet, they could be closed. Commissioner Harris asked if additional regulations were really needed. Would something actually be accomplished, or was the Board just making life more cumbersome for those who might be able to muddle along without new rules? Chairman

Brackpool commented the problem was that the satellite wagering facilities were just muddling along and they were stopping other enterprises from opening. Chairman Harris stated the 20-mile radius was not addressed by the new regulations. Chairman Brackpool said the issue would be resolved if a satellite lost its license because it could not meet the minimum standards. One did not have to perform if one had a monopoly. If one could not perform, one would be closed and lose the monopoly. Commissioner Harris said the satellite that did not seem to be cooperating was San Mateo, which actually had a very nice facility. The problem might not be standards so much as a spirit of cooperation in opening new satellites. Chris Korby of CARF stated CARF believed it was appropriate to periodically update standards and was open to working with the industry on the issues. John Bucalo of the Barona Casino spoke about his organizations role in the process of creating standards for satellite wagering facilities. Commissioner Harris asked if the proposed regulations impacted minisatellite wagering facilities. He stated he was concerned the regulations might hamper the ability of a minisatellite to open. Chairman Brackpool said minisatellites might have an advantage as they were new facilities. The aim was to have uniform standards regarding the quality of audio and video equipment and services.

DISCUSSION AND ACTION BY THE BOARD REGARDING THE PROPOSED ADDITION OF CHRB RULE 1500.1, JOCKEY SUBJECT TO TESTING, TO ALLOW RANDOM DRUG TESTING OF JOCKEYS AND APPRENTICE JOCKEYS.

Jacqueline Wagner, CHRB staff, said the proposed addition of Rule 1500.1, Jockey Subject to Testing, would provide the framework under which California jockeys and apprentice jockeys would be subject to random drug testing. The proposed regulation

was still a working document. Staff also received a request from the harness industry to include harness drivers in the regulation. Under the proposed regulation jockeys, apprentice jockeys and harness drivers would be prohibited from having in their body or from possessing on the grounds of a facility under the jurisdiction of the Board any illegal drugs. The regulation also sets out the parameters under which a drug testing program would be run. In addition to the testing of urine, the regulation provides for testing of blood. Ms. Wagner commented the proposed regulation was based on regulations currently in place in other racing jurisdictions. Commissioner Harris said he would like to see a drug screening requirement included in the annual jockey physicals, as well as the random opportunities. Commissioner Rosenberg said the staff analysis stated the Board needed to determine what it meant by "random" and how it wished to apply the regulation. Ms. Wagner said various racing jurisdictions state specifically when they will take random test samples, and how many samples will be taken. Those issues have not been addressed in the proposed regulation. The number and frequency of tests will have an impact, as the testing will have an associated cost. Commissioner Rosenberg said staff might draw on the experience of jurisdictions currently conducting such testing. Chairman Brackpool stated the issue would be brought back in a completed form at a future Regular Meeting.

DISCUSSION AND ACTION BY THE BOARD REGARDING A REPORT FROM THE THOROUGHBRED OWNERS OF CALIFORNIA (TOC) REGARDING THE RESULTS OF ITS RECENT ELECTION FOR OFFICERS OF THE BOARD.

Guy Lamothe of Thoroughbred Owners of California (TOC) said the newly appointed officers of the TOC board were: Arnold Zetcher, Chairman; Brain Boudreau, southern

Vice-Chairman; Keith Pronske, northern Vice-Chairman; Pete Parrella, Treasurer; Pablo Suarez, Secretary; and Mike Pegram, At-Large Member. The remainder of the TOC board was: Madeline Auerbach; Marty Bach; Bob Baffert; David Bloom; Ron Ellis; Cal Fischer; Billy Koch; Ed Moser; and Don Valpredo.

REPORT FROM MEDICATION AND TRACK SAFETY COMMITTEE.

Commissioner Derek stated the Medication and Track Safety Committee (committee) met on August 6, 2010 at the Del Mar Surfside Race Place. The committee heard an update and discussion on the use of safety reins. Safety standards were being developed for safety reins, and then a regulation could be considered. The committee also heard a report on the track safety program from Executive Director Kirk Breed. The CHRB obtained track surface testing equipment and personnel to conduct testing. The CHRB was also working with Dr. Rick Peterson of the University of Maine. The testing of the racetrack surfaces will be used to develop performance parameters for California racetracks. Commissioner Derek said the committee discussed creating continuing education for licensees responsible for equine health and welfare to include trainers and veterinarians. In the spirit of continuing education of licensees, Safety Stewards Luis Jaregui and Darrel Haire committed to a program for apprentice jockeys. The program was based on a successful European program. The committee also heard a discussion regarding the transferability of veterinary records. There was a lot of resistance from trainers, but also a lot of benefits to the horse in assuring medical records of the horse go with the new trainer. The committee also discussed medications prior to the sale of horses at a horse auction conducted at CHRB inclosures; the feasibility of amending

whipping rules; and an update from CARMA the Thoroughbred Owners of California race horse retirement program. Commissioner Derek thanked the many persons who participated in the committee meeting and who provided important information on the various topics. Commissioner Harris stated the meeting was excellent. There were several items that needed to be pursued, including transparency of veterinarian records. It was clear that the records should follow the horse because it was a way to develop data to help understand health and safety issues. Vice-Chairman Israel commented that a recent study demonstrated that horses that started racing at two years did better and were healthy as they got older and continued racing. CHRFB Equine Medical Director, Dr. Rick Arthur, said that was correct. Chairman Brackpool stated the committee discussed many ideas. Those that were ready to be acted on should be moved along, and perhaps the Board could hear about actions being taken by other jurisdictions. The Canadian rules on whipping were an example of issues that were of interest. Dr. Arthur stated the Canadian rules were in the July 2010 Regular Board Meeting package, and were otherwise available. He said the safety of the horse and jockey was paramount, and the committee had a lot on its agenda. Chairman Brackpool asked how the amendment of Rule 1689, Safety Helmets Required, was progressing. Jacqueline Wagner, CHRFB staff, said the amendment was approved by the Office of Administrative Law on August 16, 2010, and would become effective September 15, 2010. Notification would be sent to interested parties. Cory Wellman, a horse owner and breeder, spoke about her concerns regarding the completeness of race horse injury and death statistics. Dr. Arthur said the committee had extensive discussion on obtaining information regarding non-fatal

injuries. In addition, the Jockey Club Research Foundation provided a grant to look at ways to monitor non-fatal injuries.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE BIG FRESNO FAIR (F) AT FRESNO, COMMENCING OCTOBER 6, 2010 THROUGH OCTOBER 17, 2010, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said the Big Fresno Fair (BFF) proposed to run from October 6, 2010 through October 17, 2010, or ten days, the same number of days as in 2009. The BFF would run currently with Oak Tree Racing Association. The first post time was 12:15 p.m. Saturdays and Sundays and 1:15 p.m. Monday, Wednesday, Thursday and Friday. The BFF wagering program would utilize CHRB regulations and Association of Racing Commissioner International rules. The advance deposit wagering (ADW) providers were TVG, Twin Spires, XpressBet and Youbet. Ms. Wagner said the fire clearance was completed, so the application was complete, and staff recommended the Board approve the application as presented. John Alkire of the BFF spoke about changes to the BFF satellite wagering facility, and the various promotions and marketing strategies for the upcoming race meeting. Chairman Brackpool **motioned** to approve the application for license to conduct a horse racing meeting of the BFF. Commissioner Harris **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE PACIFIC RACING ASSOCIATION (T) AT GOLDEN GATE FIELDS, COMMENCING OCTOBER 20, 2010 THROUGH DECEMBER 19, 2010, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said at the July 2010 Regular Meeting the Board approved a motion extending the current license of Pacific Racing Association (PRA) until December 26, 2010. This meant no action needed to be taken on the application before the Board because the license period was from October 20, 2010 through December 19, 2010; therefore the application was being presented for information purposes. Commissioner Harris asked if the horsemen's agreement was in place. Ms. Wagner stated the California Thoroughbred Trainers (CTT) agreement was received by staff on August 16, 2010. Robert Hartman of PRA stated a CTT agreement and the Thoroughbred Owners of California (TOC) agreement were in place. The stakes program was still an issue with the TOC but there was a 60 day period before the start of the meeting in which to work out the issues. Commissioner Harris said he was concerned with the overall future of Northern California racing because the stakes program was substantially changed and was down to five stakes in a two month period. He stated he believed the needs of the state were better served with more valued stakes. Mr. Hartman said PRA was offering more in stakes money compared to its last meeting. The issue of the amount of purse money was a challenge, but it would be worked out with the TOC. Commissioner Harris asked if MID guaranteed PRA, as PRA did not seem to have a very deep financial statement. Chairman Brackpool said that question would be answered at the Board's September 2010 Regular Meeting. Commissioner Harris commented PRA would run continually through December 2010 and there needed to be some assurance that there was financial stability. Chairman Brackpool stated that was correct and would

come up in the overall waiver discussion. Commissioner Choper said the PRA application had more race days and a higher average daily purse. He asked how that was calculated. Mr. Hartman said PRA would run an August 2010 meeting with an underpayment of \$300,000 – which would be applied to purse increases at the meeting to begin in October 2010. Mr. Hartman cautioned that depending on how the August 2010 meeting turned out, some adjustment to purses might be made. Commissioner Harris commented the application indicated PRA would run five-days-a-week. He said it seemed the meetings were starting with five days, and then went to four when it did not work. Perhaps the industry might think of running four good days rather than trying to stretch out the week. Mr. Hartman stated PRA had an influx horses from Emerald Down and Hastings Park when they closed, and it expected the same to happen in 2010. It appeared PRA would have no problems going to five days. If there were a problem it could reduce its race days, but PRA wished to give owners and trainers the maximum opportunity to run. Ms. Wagner stated the Board did not need to take action on the application, but it would decide on a waiver concerning the MID ownership at its September 2010 Regular Meeting. The waiver would determine if the PRA meeting would take place. Chairman Brackpool said the waiver was originally set through September 16, 2010. However, the September Regular Board Meeting was being moved to September 23, 2010. He asked if the Board could extend the waiver. Staff Counsel Robert Miller said “yes” the Board could extend the waiver. Commissioner Choper **motioned** to extend the waiver to September 23, 2010. Vice-Chairman Israel **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO OPERATE A MINISATELLITE WAGERING FACILITY AT FARRINGTON'S BAR IN PLEASANT HILL, CALIFORNIA, FOR A PERIOD OF UP TO TWO YEARS.

Jacqueline Wagner, CHRB staff, said Farrington's Bar (Farrington's), in collaboration with Pacific Racing Association (PRA) and Northern California Off-Track Wagering, Inc., was applying to operate a minisatellite wagering facility. Farrington's was proposing to begin operations on August 25, 2010, and to run through August 25, 2012. Farrington's was located in the northern zone and was within the 20-mile exclusion zone for the Solano County Fair (SCF). However, SCF granted a waiver as required by law. Ms. Wagner stated all of Farrington's agreements were in place. Doug McCann of Farrington's stated his organization recently spent about \$350,000 to renovate its facility. It had 25 flat screen televisions and was a true sports bar. Farrington's did research in Arizona to determine how a bar could run a successful pari-mutuel concern, so it modeled its efforts towards that environment. The facility was 6,630 square feet. Mr. McCann stated Farrington's wanted to expand the market beyond the normal horse racing ban base to the general market. It wanted to be a bar where the public could come in and discover they could wager on horse racing. Commissioner Moss asked if SCF was receiving any compensation for its waiver. Mr. McCann said SCF was not receiving compensation. Mr. Hartman said he wished to thank SCF for stepping up to the plate and acting in the best interests of horse racing. He commented in the past PRA had problems with other satellite venues, but the SCF board of directors showed a lot of leadership. Commissioner Choper asked if there would be any promotion of the facility. Mr. McCann stated Farrington's had a web presence with a website; it was on Facebook; it worked with Barspace.tv; it paid Google to be on the top of any search for bars in its

geographic area; and it did print and other types of advertising. Chairman Brackpool asked how far Farrington's was from PRA. Mr. Hartman stated Farrington's was a little over 20 miles from PRA. He added there were no satellites in Contra Costa County, with a little over a million in population, so Farrington's would serve a need. Commissioner Choper motioned to approve the application for license to conduct a minisatellite facility at Farrington's. Commissioner Moss seconded the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD REGARDING THE 2011 RACE DATE ALLOCATION PROCEDURES.

Jacqueline Wagner, CHRB staff, said the item was placed on the agenda to notify the industry of the procedures for the allocation of the 2011 race dates. Executive Director Kirk Breed stated the racing associations would present their proposed dates at the next Regular Board Meeting. The dates must be provided in writing to staff not later than September 12, 2010. Chairman Brackpool motioned to hold a Race Dates Committee meeting on September 22, 2010 and the Regular Board Meeting on September 23, 2010. In addition, the racing association's proposals for 2011 race dates must be delivered to staff not later than September 12, 2010. Commissioner Rosenberg seconded the motion, which was **unanimously carried**.

REPORT FROM THE CHAIRMAN OF THE BOARD REGARDING LEGISLATIVE INDUSTRY DEVELOPMENTS.

Chairman Brackpool stated substantial progress was made regarding legislation that would benefit the industry. There were ten days left in the legislative session, but there

were still a couple of groups that had issue with the legislation. It was not yet possible to determine if the legislation would be voted on. Chairman Brackpool said the process was useful, and if the legislation was passed, it would be a tremendous boon to the industry. John Bucalo of the Barona Casino stated his organization would like to be part of exchange wagering if the exchange wagering act were approved.

MEETING ADJOURNED AT 2:00 P.M.

PUBLIC HEARING AND ACTION BY THE BOARD REGARDING THE PROPOSED
AMENDMENT TO RULE 1844, AUTHORIZED MEDICATION,
TO MODIFY THE LEVELS PERMITTED FOR
PROCAINE SUBSEQUENT TO PROCAINE PENICILLIN ADMINISTRATION

Regular Board Meeting
September 23, 2010

BACKGROUND

Business and Professions Code section 19440 provides that the Board shall have all powers necessary and proper to enable it to carry out fully and effectually the purposes of this chapter. Responsibilities of the Board shall include adopting rules and regulations for the protection of the public and the control of horse racing and pari-mutuel wagering. Business and Professions Code section 19562 states the Board may prescribe rules, regulations and conditions under which all horse races with wagering on their results shall be conducted in California. Business and Professions Code section 19580 requires the Board to adopt regulations to establish policies, guidelines, and penalties relating to equine medication to preserve and enhance the integrity of horse racing in California. Business and Professions Code section 19581 provides that no substance of any kind shall be administered by any means to a horse after it has been entered to race, unless the Board has, by regulation, specifically authorized the use of the substance and the quantity and composition thereof. Board Rule 1844, Authorized Medication, names drug substances and medications authorized by the Board that may be administered to safeguard the health of the horse entered to race. The rule lists the drug substances that may be found in official test samples and the level at which such drugs may occur.

A proposal to amend Board Rule 1844 was discussed at the May 19, 2010 Medication and Track Safety Committee (committee) meeting. The committee determined it would recommend to the Board that staff be directed to initiate the process to amend Rule 1844. The proposed amendment to Rule 1844 was discussed at the June 2010 Regular Board Meeting. The Board voted to direct staff to initiate a 45-day public comment period regarding the proposed amendment.

ANALYSIS

The proposed amendment to Rule 1844 would increase the amount of procaine that may be present in an official urine test sample from 10 nanograms per milliliter to 50 nanograms per milliliter. The proposed amendment also adds a new subsection 1844(h), which states procaine, following administration of procaine penicillin, is an authorized medication. There may be no more than 25 nanograms per milliliter in the official blood test sample, and the procaine penicillin administrations have to have been reported pursuant to Rule 1842, Veterinarian Report. In addition, the procaine penicillin can not have been administered after entry to race, and the horse has to have been under surveillance for a minimum of six hours prior to racing. The required surveillance would likely be provided and billed in a manner similar to current detention barn surveillance. All expenses related to surveillance and testing for procaine shall be paid by the owner of the horse. The owners will pay the costs because the program requires special test tubes and unique testing. The proposed amendment will allow the use of an inexpensive and effective antibiotic: procaine penicillin, which will save owners money.

RECOMMENDATION

Staff recommends the Board adopt the amendment to Rule 1844 as presented. No comments were received during the 45-day public comment period.

RULE 1844. AUTHORIZED MEDICATION

Regular Board Meeting
September 23, 2010

1844. Authorized Medication.

Consistent with the intent of these rules, drug substances and medications authorized by the Board for use may be administered to safeguard the health of the horse entered to race provided that:

(a) No person shall administer a drug substance to any horse entered to race except upon authorization of the official veterinarian in conformance with these rules.

(b) No drug substance, other than authorized bleeder medication, shall be administered to a horse entered to race within 24 hours of the race in which entered.

(c) Not more than one approved non-steroidal anti-inflammatory drug substance (NSAID) may be administered to a horse that is entered to race and shall be only one of the following authorized drug substances:

(1) Phenylbutazone in a dosage amount that the test sample shall contain not more than 5 micrograms of the drug substance per milliliter of blood plasma or serum.

(2) Flunixin in a dosage amount that the test sample shall contain not more than 50 nanograms of the drug substance per milliliter of blood plasma or serum.

(3) Ketoprofen in a dosage amount that the test sample shall contain not more than 10 nanograms of the drug substance per milliliter of blood plasma or serum.

(4) Metabolites or analogues of approved NSAIDs may be present in post race test samples.

(d) If the official chemist reports that a blood test sample contains an authorized NSAID in excess of the limit for that drug substance under this rule, the official veterinarian shall, in conjunction with the veterinarian who administered or prescribed

the authorized drug substance, establish a dosage amount or time of administration of the drug substance that will comply with the limits under this rule; or the official veterinarian may, if in his/her judgment no such reduced dosage amount or amendment to time of administration will result in a test sample level within the limits of this rule, withdraw authorization for the use of any one NSAID.

(e) Official urine test samples may contain one of the following drug substances, their metabolites or analogs, in an amount that does not exceed the specified levels:

(1) Acepromazine; 25 nanograms per milliliter

(2) Mepivacaine; 10 nanograms per milliliter

(3) Promazine; 25 nanograms per milliliter

(4) Albuterol; 1 nanograms per milliliter

(5) Atropine; 10 nanograms per milliliter

(6) Benzocaine; 50 nanograms per milliliter

(7) Procaine; ~~10~~ 50 nanograms per milliliter

(8) Salicylates; 750 micrograms per milliliter

(9) Clenbuterol; 5 nanograms per milliliter

(10) Stanzolol; 1 nanograms per milliliter

(11) Nandrolone; 1 nanograms per milliliter for geldings, fillies and mares; 45 nanograms for males other than geldings.

(12) Boldenone; 15 nanograms per milliliter in males other than geldings.

(13) Testosterone; 20 nanograms per milliliter in geldings.

(A) Testosterone at any level in males other than geldings is not a violation of this regulation.

(14) Testosterone; 55 nanograms per milliliter in fillies or mares

(f) Official blood test samples may contain clenbuterol in an amount not to exceed 25 picograms per milliliter of serum or plasma.

(g) Official blood test samples shall not contain any of the drug substances, or their metabolites or analogs listed in subsection (e)(1)-(8), and (e)(10)-(14).

(h) Procaine, following administration of procaine penicillin, is an authorized medication provided:

(1) Official blood test samples shall not contain any procaine, or its metabolites or analogs in excess of 25 nanograms per milliliter.

(2) all procaine penicillin administrations have been reported pursuant to Rule 1842 of this division.

(3) procaine penicillin was not administered after entry to race,

(4) the horse was under surveillance for a minimum of six hours prior to racing.

(i) All expenses related to surveillance and testing for procaine under subsection (h) of this regulation shall be paid by the owner of the horse.

COMPENSATION FOR SERVICES RENDERED FROM MONIES ALREADY RECEIVED
FROM THE WAGERING PUBLIC

BACKGROUND

The state budget has reached its latest point ever. State law precludes payments for current year expenses (other than staff salaries and wages and some health and safety exceptions) in the absence of a signed budget. Without budgetary authority, as evidenced by an appropriation registered with the State Controller's Office, no payments can be made. At the same time, the racing associations have made their required distributions of the takeout from parimutuel wagering that has taken place since July 1, 2010. The CHRB has collected its share of those distributions for the current fiscal year to date and deposited them to the Horse Racing Fund awaiting authority to expend.

The CHRB's contractors – stewards, veterinarians, safety study managers, etc. – have worked in good faith, recognizing that the “budget dance” is an annual event that delays their payment. Their contracts include the following clause:

“...It is mutually agreed that if the Budget Act of the current year and/or any subsequent years covered under this Agreement does not appropriate sufficient funds for the program, this Agreement shall be of no further force and effect. In this event, the State shall have no liability to pay any funds whatsoever to Contractor or to furnish any other considerations under this Agreement and Contractor shall not be obligated to perform any provisions of this Agreement.”

Moreover, the California Constitution specifies that payments are precluded without an appropriation made by law.

With the time of non-payment having reached nearly three months, the potential for significant suffering by those contractors has now achieved a pressing reality.

ANALYSIS

By the end of September, our contractors will have earned just over \$500,000 for their mission critical services. We anticipate that the amount will continue to accrue at approximately \$170,000 per month throughout the fiscal year. As noted above, the racing associations and fairs that collect the takeout from the parimutuel handle have been forwarding the CHRB share to the Horse Racing Fund. As a result, the CHRB has sufficient cash balance to pay its contractors without impacting any other state fund in any way.

RECOMMENDATION

Staff recommends the Board adopt the following motion:

“It is the will of the California Horse Racing Board that critical independent contractors be paid for work they have already performed from monies already generated by the wagering public of California and presently held in accounts of the Board. This action is necessary to ensure the fair, safe and continued conduct of pari-mutuel horse racing in California while the State of California lacks an approved, signed Budget Act for Fiscal Year 2010-2011. The California Horse Racing Board hereby acts to convey this message to the Office of the Governor and the Legislative bodies of the State of California”.

Issue: APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE HOLLYWOOD PARK FALL RACING ASSOCIATION, LLC AT HOLLYWOOD PARK NOVEMBER 3, 2010 THROUGH DECEMBER 19, 2010.

Hollywood Park Fall Racing Association, LLC filed its application to conduct a thoroughbred horse racing meeting at Hollywood Park:

November 3 through December 19, 2010, or 31 days, 4 more than 2009. The association proposes to race a total of 267 races, or 8.61 per day. In 2009 they raced 8.67 races per day with an average of 7.53 runners per race. The (actual) average daily purse for the fall 2009 meet was \$336,675. The (estimated) average daily purse for this meet is \$321,327.

- Hollywood Park was allocated 35 race days for 2010. The association is requesting to offer simulcast wagering with no live racing November 3, 10 and December 17 and 24, 2010. The changes would reduce their race days to 31.

- Racing 4 to 5 days per week, Thursday through Sunday in November and Wednesday through Sunday in December, with 8 races on Wednesdays, Thursdays, Fridays and 9 or 10 races on a selected basis on Saturdays, Sundays and Friday, November 5 and 26th.
- First post 12:30 p.m. daily.
 - 7:05 p.m. post Friday, November 12 and 19.
 - 11:00 a.m. post November 6, Breeders Cup Day.

Business and Professions Code section 19464(b) specifies no application for license to conduct a horse racing meeting shall be granted unless the applicant has deposited with the Board a surety bond in the amount of \$100,000, or a greater amount, as determined by the Board, which is sufficient to ensure payment of employees wages and benefits including, but not limited to, health, welfare and pension plans. The surety bond shall be maintained during the period of the meeting that all payments are made. In the event of a dispute over the amount owed, the dispute shall be resolved through the grievance procedures set forth in the labor agreement of the union representing the class of employees affected.

This subdivision does not apply to any person or association licensed to operate a horse race meeting prior to January 1, 2001, which has conducted a race meeting in each of the immediate three previous consecutive calendar years.

- Hollywood Park Racing Association, LLC's initial race meeting was conducted after 2001. Therefore, it is subject to the provisions of the Business and Professions Code section 19464(b).
- Pursuant to Business and Profession Code 19464(b) Hollywood Park Fall Racing Association is required to submit a \$100,000 surety bond payable to the Treasurer of the State of California to ensure payment of employee wages and benefits. The Hollywood Park \$100,000 surety bond on file will expire October 29, 2011.
- Request Jennifer Paige be appointed horse identifier pursuant to CHRB Rule 1525.
- A track safety inspection has been requested and will be completed before the beginning of the race meet.
- Wagering program will use CHRB and ARCI rules.
 - Early wagering 8:30 a.m. on the day of and advance-day wagering.
 - \$1 trifecta in any race that complies with Rule 1979 and a \$.10 superfecta in any race that complies with Rule 1979.1.
 - Pick 6 on last 6 races - 70% of net pool to be retained for the jackpot and no cap be set.
 - Pick 4 on first 4 races and last 4 races - designate the major share as 0%.
 - Offering option of an alternate selection in the place pick all, pick 6 and pick 4.
 - Super High Five on the last race in accordance with ARCI Pick(n) Position(x) pools rules.
- The Advance Deposit Wagering (ADW) providers are TVG, Youbet, Xpressbet and Twinspires.

Pursuant to Business and Profession Code section 19604, specific provisions must be met before an ADW provider can accept wagers.

Summary of B&P code 19604

To accept wagers on races conducted in California from a resident of California.

- The ADW provider must be licensed by the Board.
- A written agreement allowing those wagers exists with the racing association or fair conducting the races on which the wagers are made.
- The agreement shall have been approved in writing by the horsemen's organization responsible for negotiating purse agreements for the breed on which the wagers are made.

To accept wagers on races conducted outside of California from a resident of California.

- The ADW provider must be licensed by the Board.
- There is a hub agreement between the ADW provider and one or both of (i) one or more racing associations or fairs that together conduct no fewer than five weeks of live racing on the breed on which wagering is conducted during the calendar year during which the wager is placed, and (ii) the horsemen's organization responsible for negotiating purse agreements for the breed on which wagering is conducted.



During training hours two certified EMTs are stationed in an ambulance located on the backstretch just off the main track. They have access to the first aid facility should the need arise. During racing hours two certified EMTs staff and maintain the first aid facility with an addition team of two EMTs stationed in an ambulance on the race track. Also during racing hours there is a medical doctor on duty who provided through Kerlan-Jobe clinic.

The facility is equipped with the following: beds, stethoscope, otoscope, flash light, forceps, clamps, scissors, scalpel, tourniquet, sterile syringes, blood pressure kit, oxygen, eye flushes, splints, bandages, trauma dressing, hydrogen peroxide etc., nasal packing, topical anesthetic, thermometer, Silver nitrate sticks (AgNO₃), ice packs, backboards for spinal precautions, cervical collars, immobilization straps hare traction splints for closed femur fractures, KED splints, bag valve mask for CPR, Automated external defibrillator., oxygen masks, cannula tubing and a variety of addition supplies and over the counter drugs (aspirin etc.)

A qualified and licensed physician shall be on duty at all times during live racing, except that this provision shall not apply to any quarter horse racing at the racetrack if there is a hospital situated no more than 1.5 miles from the racetrack and the racetrack has an agreement with the hospital to provide emergency medical services to jockeys and riders. An ambulance licensed to operate on public highways provided by the track shall be available at all times during live racing and shall be staffed by two emergency medical technicians licensed in accordance with Division 2.5 (commencing with Section 1797) of the Health And Safety Code, one of whom may be an Emergency Medical Technician Paramedic, as defined in Section 1797.84 of the Health and Safety Code. (b) Each racing association and racing fair shall adopt and maintain an emergency medical plan detailing the procedures that shall be used in the event of an on-track injury. The plan shall be posted in each jockey room in English and Spanish. (c) Prior to every race meeting, the racing association or racing fair shall contact area hospitals to coordinate procedures for the rapid admittance and treatment of emergency injuries. (d) Each racing association or racing fair shall designate a health and safety manager and assistant manager, who shall be responsible for compliance with the provisions of this section and one of whom shall be on duty at all times when live racing is conducted. The health and safety manager may, at the discretion of the racing association, be the person designated to perform risk management duties on behalf of the association.

Subject: Emergency Medical Action Plan for Injured Jockeys

Since May 1, 2003 we at Hollywood Park have had in place an emergency medical action-plan for injured jockeys. There is now a new law requiring such an action plan. Pursuant to the Business and Professions Code section 19481.3 (b) each racing association shall adopt and maintain an emergency medical action plan for injured jockeys and shall be posted in English and Spanish within the jockeys room.

The system we have in effect follows the exact guidelines required by the above statute. The emergency action plan we deploy goes as follows:

“Upon the observed or reported injury of a jockey, medical assistance will be immediate. The responding medical technician, track doctor or security will contact communications (via hand held radio or calling 310 4191555). Security will then activate the emergency contact procedure. This procedure will be the responsibility of the Safety Director or his designee. The Safety Director will contact the Chief of Medical Staff at Centinela Hospital and prepare for the injured jockeys arrival. The phone number of Centinela Hospital is 310- 4198636 and is located at 555 East Hardy Street, Inglewood.

The Chief of Staff will ensure that his personnel are standing by to receive the injured jockey. The Chief of Staff will also contact any specialists who are contracted for the care of an injured jockey. This will lay the foundation for a rapid admittance and treatment of the injured Jockey. A Security Agent will also be dispatched to respond to the emergency room to assist family members of the injured jockey and to also maintain the integrity of the injured jockeys needs. It will also be the responsibility of the Security Agent to keep the Director of Safety informed as to the condition and progress of the injured jockey. It will be the responsibility of the Security Agent to obtain a copy of the accident from the T.V. department. The Security Agent will prepare a report as to the accident and treatment. The agent will also ensure that all workers compensation information pertaining to the jockey is accurate and current.”



Un agente de seguridad sera despachado al cuarto de Emergencia para asistir a la familia y mantener la integridad y necesidades de el jinete herido. 

Issue: APPLICATION FOR AUTHORIZATION TO OPERATE A SIMULCAST WAGERING FACILITY AT THE FRESNO DISTRICT FAIR FOR THE PURPOSE OF RELOCATION OF THE SIMULCAST FACILITY.

The Fresno District Fair at Fresno has submitted its "Application to Operate a Simulcast Wagering Facility" to relocate its simulcast wagering facility. The Fresno simulcast wagering facility (SWF) has experienced a decline in attendance and a rise in operating cost. They have indicated the downturn in their simulcast business may be contributed to competition from tribal casinos in the surrounding area, current economic climate and a migration in handle to advance deposit wagering. Fresno provides that the relocation is necessary in order to keep the satellite wagering operations viable. The Fresno District Fair at Fresno opened its simulcast wagering facility December 18, 1985.

The current SWF occupies approximately 20,000 square feet. The proposed simulcast wagering facility interior space is 3,500 square feet and 1200 square feet of exterior space. The facility is scheduled to be used as the primary simulcast wagering facility on November 10, 2010.

Pursuant to the "Proposed Fresno Fair Satellite Wagering Facility Re-Location" document provided by the California Authority of Racing Fairs (excerpt below). The applicant is requesting approval to operate two (overlapping) simulcast wagering facilities during September 29 through October 17, 2010. The Grandstand (old SWF) would continue to operate until November 6, 2010 serving the public. The Horsemen Café (new SWF) would operate September 29 through October 17, 2010 as a café and provide access to two auto tote terminals serving licensed personnel only.

The applicant is additionally requesting to conduct wagering at the Grandstand facility (old SWF) during the Triple Crown, Breeder's Cup, fair meets and special events in the future. The request would be submitted 60 days in advance of the scheduled dates.

"Since the new facility is located in the Fresno Fair Stable Area, a secured area of the race track enclosure, the Fair is requesting approval to open it for licensed personnel only during the run of this year's Fair. In this role, the new facility will serve as a functional expansion of the Horsemen's Cafe, with more floor space, more tables, more tote terminals and more viewing displays.

The Fair is requesting approval to commence operations as an upgraded Horsemen's Café on Sept 29, 2010, and continue to function in that capacity until October 17, when the Fresno Fair meet concludes. The upgrades in amenities and space will be a significant backstretch enhancement for owners, trainers and licensed employees during this year's Fresno Fair meeting.

If the CHRB approves this plan, the Grandstand will continue as the primary Fresno Fair satellite facility right up until the Fair begins this year on October 6. After the Fair concludes, beginning on October 20, Fresno Fair satellite wagering operations will resume in the Grandstand and continue in that location through Breeders' Cup events on November 5 & 6, 2010.

When the Fresno Fair ends on Oct. 17, the Butler Avenue facility will close as a Horsemen's Café. After Breeders' Cup, with CHRB approval, on November 10, 2010, the Fair will open the new Butler Avenue facility to the public as its primary satellite wagering operation."

PROPOSED FRESNO FAIR SATELLITE WAGERING FACILITY RE-LOCATION

Background

Fresno Fair has operated a satellite wagering facility in its race track Grandstand since the mid-1980's. In fact, Fresno Fair was the first operational satellite in the California intrastate simulcast network when it served as a pilot satellite facility in the Spring of 1984 for wagering on races from Golden Gate Fields.

More recently, the downturn in simulcast business has created challenges for the continuation of satellite operations in the Fresno race track Grandstand. This downturn in business has been driven by a combined impact of 1) competition from tribal casinos, of which there are three in the Fresno market; 2) the current economic climate, with sharp declines in the housing market and elevated levels of unemployment; and 3) a migration in handle to ADW. Attendance in the Grandstand location has declined. Utility costs, always a factor in operating a Grandstand, have continued to rise to a level that has made the Grandstand location no longer economically viable for satellite wagering. After a review of all these circumstances, the Fresno Fair has determined that it must re-locate its satellite facility in order to keep satellite wagering operations viable.

The Fair has identified another building on the Fairgrounds that is more conveniently located and more appropriately scaled for its current satellite operations. In prior years, this building has served as the Horsemen's Café during the Fair race meeting, featuring TV's and wagering terminals for the convenience of owners and trainers in the backstretch area. The building is located on Butler Avenue a perimeter street for the Fairgrounds.

The Fair has completely renovated the building, expanded the available floor space by adding an additional dining area and installed an entirely new HVAC system. The location has convenient parking in an adjacent lot that can accommodate 500 cars, along with plentiful street parking and a curbside entrance on Butler Avenue. To support simulcast operations, California Authority of Racing Fairs (CARF) and the Fair are installing satellite downlinks, twenty-five flat screen video displays and a sound system, all new and state-of-the-art. With respect to the totalisator system, the facility will have capacity for thirty wagering terminals, as has been recommended by the NCOTWInc Mutuel Manager.

Since the new facility is located in the Fresno Fair Stable Area, a secured area of the race track enclosure, the Fair is requesting approval to open it for licensed personnel only during the run of this year's Fair. In this role, the new facility will serve as a functional expansion of the Horsemen's Cafe, with more floor space, more tables, more tote terminals and more viewing displays.

The Fair is requesting approval to commence operations as an upgraded Horsemen's Café on Sept 29, 2010, and continue to function in that capacity until October 17, when the Fresno Fair meet concludes. The upgrades in amenities and space will be a significant backstretch enhancement for owners, trainers and licensed employees during this year's Fresno Fair meeting.

If the CHRB approves this plan, the Grandstand will continue as the primary Fresno Fair satellite facility right up until the Fair begins this year on October 6. After the Fair concludes, beginning on October 20, Fresno Fair satellite wagering operations will resume in the Grandstand and continue in that location through Breeders' Cup events on November 5 & 6, 2010.

When the Fresno Fair ends on Oct. 17, the Butler Avenue facility will close as a Horsemen's Café. After Breeders' Cup, with CHRB approval, on November 10, 2010, the Fair will open the new Butler Avenue facility to the public as its primary satellite wagering operation.

We respectfully request the Board's approval of this plan and approval of the Fresno Fair's application to re-locate satellite wagering operations to the Butler Avenue Fair facility following 2010 Breeders' Cup events.



ASSEMBLY BILLS

AB 1152(Anderson) Horse racing

Horse racing. (C-07/09/2010)

Introduced: 02/27/2009

Last Amend: 06/03/2010

Status: 07/09/2010-Chaptered by Secretary of State - Chapter 53, Statutes of 2010.

Location: 07/09/2010-A CHAPTERED

Summary: Existing law, effective January 1, 2011, requires an outrider to be licensed by the California Horse Racing Board pursuant to certain provisions of law relating to stewards and racing officials. This bill would delete the requirement that outriders be licensed under those provisions. This bill contains other related provisions and other existing laws.

Specifically this bill would 1) Authorize, under specified conditions, the CHRB to allocate racing dates to be run in the central zone or the southern zone to a thoroughbred racing association that conducted a live race meeting in the central zone in 2009; 2) Delete the outrider from the definition of "racing official"; 3) Allow the CHRB to adopt regulations to establish a written and oral outrider examination; 4) Allow the CHRB to delegate to the outrider duties and authorities as prescribed by the horse racing law; 5) Delete the minimum pari-mutuel mount requirement for California jockeys participating in the California Jockey Retirement Fund; 6) Exempt harness racing meetings from distributing funds, generated at its meetings, to the California Jockey Retirement Fund.

AB 1792(Silva) Horse racing: license fee reduction: quarter horse racing. (C-08/27/2010)

Introduced: 02/10/2010

Last Amend: 06/22/2010

Status: 08/27/2010-Chaptered by the Secretary of State, Chapter Number 193, Statutes of 2010

Location: 08/27/2010-A CHAPTERED

Summary: Existing law provides that, notwithstanding any other law and in lieu of any license fee payable to the state prescribed for or referred to in specified provisions of the Horse Racing Law, any association or fair that conducts a racing meeting shall pay its proportional amount, as determined by the formula devised by the California Horse Racing Board in consultation with the industry, as a license fee to the state to fund the board and the equine drug testing program, as provided. Existing law provides that the license fee reductions resulting from these provisions, after payments to fund the board and the equine drug testing program, shall be distributed as specified for thoroughbred racing, quarter horse racing, harness racing, and all other breeds. For quarter horse racing, 2.5% of the amount of the reduction is required to be deposited with the official registering agency and distributed as provided.

This bill would increase to 3% the amount of the reduction for quarter horse racing that is to be deposited with the official registering agency for distribution.

AB 2790(Committee on Governmental Organization) Horse racing: out-of-state thoroughbred races: the Arlington Million. (C-08/13/2010)

Introduced: 03/17/2010

Status: 08/13/2010-Chaptered by the Secretary of State, Chapter Number 141, Statutes of 2010

Location: 08/13/2010-A CHAPTERED

Summary: Existing law authorizes a thoroughbred horse racing association or fair to distribute the audiovisual signal and accept wagers on the results of out-of-state thoroughbred races conducted in the United States during the calendar period the association or fair is conducting a race meeting, including days on which there is no live racing being conducted by the association or fair, without the consent of the organization that represents horsemen participating in the race meeting and without regard to the amount of purse. Existing law prohibits the total number of thoroughbred races imported by associations or fairs on a statewide basis from exceeding 32 per day on days when live thoroughbred or fair racing is being conducted in the state. However, that limitation excludes imported races that are part of the race card of the Kentucky Derby, Kentucky Oaks, and other specified races.

This bill would add races that are part of the race card of the Arlington Million to the list of imported races not subject to the limitation of 32 races per day.

SENATE BILLS

SB 1486 (Committee on Governmental Organization) Horse racing law intent: backstretch personnel housing: jockey riding fees. (C-08/13/2010)

Introduced: 03/08/2010

Status: 08/13/2010-Chaptered by the Secretary of State, Chapter Number 127, Statutes of 2010

Location: 08/13/2010-S CHAPTERED

Summary: Existing law provides that the intent of the Horse Racing Law is to allow parimutuel wagering on horse races while, among other things, supporting the network of California fairs.

This bill would delete from that statement of intent supporting the network of California fairs. This bill contains other related provisions and other existing laws.

Specifically t.

his bill would 1) delete the Horse Racing Law's expression of intent of supporting the network of California fairs; 2) delete any reference to adopting emergency regulations pertaining to backstretch employee housing at racetracks, for which compliance was mandated by January 1, 2004, rendering the language obsolete; 3) delete obsolete language from the provisions related to jockey riding fees.

AB 2201(Coto) Horse racing: harness racing: the Cane Pace. (E-08/26/2010)

Location: 08/26/2010-A ENROLLED

Summary: Existing law provides that the California Horse Racing Board may authorize a California harness racing association conducting a live racing meeting to accept wagers on the full card of races conducted by another racing association on the day that other association conducts the Breeder's Crown Stakes, the Meadowlands Pace, the Hambletonian, the Kentucky Futurity, or the North American Cup.

This bill would authorize the board to permit a California harness racing association conducting a live racing meeting to accept wagers on the full card of races conducted by another racing association on the day that other association conducts the Cane Pace.

AB 2215(Fuentes) Horse racing: advance deposit wagering: minisatellite wagering facilities. (E-08/26/2010)

Introduced: 02/18/2010

Last Amend: 08/05/2010

Status: 08/26/2010-Enrolled and to the Governor at 4:45 p.m.

Location: 08/26/2010-A ENROLLED

Summary: Existing law authorizes advance deposit wagering to be conducted, with the approval of the California Horse Racing Board. Existing law requires the board to develop and adopt rules to license and regulate all phases of operation of advance deposit wagering for advance deposit wagering providers operating in California. Existing law authorizes a racing association, a fair, or a satellite wagering facility to enter into an agreement with an advance deposit wagering provider to accept and facilitate the placement of any wager at its facility that a California resident could make through that advance deposit wagering provider.

This bill would authorize a minisatellite wagering facility to enter into an agreement with an advance deposit wagering provider to accept and facilitate the placement of any wager at its facility that a California resident could make through that advance deposit wagering provider. The bill would specify that the board must develop and adopt rules to license and regulate advance deposit wagering activity that takes place in a minisatellite wagering facility. The bill would authorize the board to recover any costs associated with the licensing or regulation of advance deposit wagering activity in a minisatellite wagering facility, as provided.

AB 2414(John A. Perez) Horse racing: exchange wagering. (A-08/31/2010

Status: 08/31/2010-In Assembly. Concurrence in Senate amendments pending. Senate amendments concurred in. To enrollment.

Location: 08/31/2010-A ENROLLMENT

Summary: SB 1072 of the 2009-10 Regular Session would enact provisions relating to exchange wagering, as defined.

This bill would make those provisions inoperative on May 1, 2016, and would repeal them on January 1, 2017. This bill contains other related provisions.

AB 2792 (Committee on Governmental Organization) Horse racing. (E-09/13/2010)

Introduced: 03/17/2010

Last Amend: 08/20/2010

Status: 09/13/2010-Enrolled and to the Governor at 5 p.m.

Location: 09/13/2010-A ENROLLED

Summary: (1) Existing law, the Horse Racing Law, generally regulates horse racing and vests the administration and enforcement of the Horse Racing Law in the California Horse Racing Board.

This bill would delete supporting the network of California fairs from that statement of intent.

SENATE BILLS

SB 899(Denham) Horse racing: satellite wagering: out-of-country thoroughbred races. (E-09/02/2010

Introduced: 01/26/2010

Last Amend: 06/28/2010

Status: 09/02/2010-Enrolled. To Governor at 4 p.m.

Location: 09/02/2010-S ENROLLED

Summary: Existing law authorizes a thoroughbred racing association or fair to distribute the audiovisual signal and accept wagers on the results of out-of-country thoroughbred races during the calendar period the association or fair is conducting a race meeting, without the consent of the participating horsemen's organization. These imported races are subject to specified conditions, including the condition that the total number of out-of-country thoroughbred races on which wagers are allowed to be accepted statewide in any given year does not exceed the total number of out-of-country thoroughbred races on which wagers were accepted in 1998.

This bill would delete that condition that limits the total number of out-of-country thoroughbred races on which wagers are allowed to be accepted statewide in any given year.

SB 1072(Calderon) Horse racing: statewide marketing organization: Breeders' Cup promotion: wagering deduction: exchange wagering. (E-09/02/2010)
Introduced: 02/17/2010
Last Amend: 08/30/2010
Location: 08/31/2010-S ENROLLMENT

Summary: Existing law authorizes a thoroughbred association or fair, subject to approval by the California Horse Racing Board, to deduct from the pari-mutuel pool for any type of wager, a specified percentage for the meeting of the thoroughbred association or fair that accepts the wager.

This bill would: 1) authorize exchange wagering in California, effective May 1, 2012; 2) increase the takeout at thoroughbred and fair race meetings on exotic wagers requiring the selection of 2 wagering interests by 2 percent and 3 percent on exotic wagers requiring the selection of 3 or more wagering interests for distribution to the purse account to augment thoroughbred and racing fair overnight purses; 3) extend the sunset date from January 1, 2011 to January 1, 2014, for the thoroughbred statewide marketing organization; 4) changes the amount distributed to the statewide marketing organization from 0.4 percent of the amount handled at each satellite wagering facility to an amount not to exceed 0.25 percent; 5) requires statewide marketing organization to establish a website and a player's incentive program; 6) provides that promotional activities at satellite wagering facilities be implemented and coordinated by representatives of the satellite wagering facilities and thoroughbred racing associations or fair conducting a live race meeting; 7) requires the statewide marketing organization to annually submit to the CHRB, written and verbal reports on the statewide marketing and promotion plan for the upcoming calendar year; 8) distributes an amount not to exceed 0.05 percent of the total amount handled by each satellite wagering facility to a nonprofit organization designated by the CHRB for the purposes of maintaining a database of horse racing information.

BACKGROUND

Business and Professions Code section 19483 provides as follows: "Unless the board finds that the purpose of this chapter will be better served thereby, no license to conduct a horseracing meeting at any track shall be issued to any person or held by any person having any financial interest in the conduct of any horseracing meeting by any other person at any other track in this State. Ownership of stock in one corporation by another corporation constitutes a financial interest within the meaning of this section."

Business and Professions Code section 19484 provides as follows: "Unless the board finds that the purpose of this chapter will be better served thereby, no person licensed under this article to conduct a horseracing meeting at any place, track or inclosure shall own or acquire any stock or hold or obtain any other financial interest in any other track of another such licensee or in the operation thereof, or in the operation of authorized wagering on the results of horse races at any such other track."

On March 5, 2009, Magna Entertainment Corporation (MEC) filed voluntary petitions for relief under Chapter 11 of the United States Bankruptcy Code. In April, 2010, MI Developments, Inc. (MID) acquired control of Santa Anita Park Race Track (SA), Golden Gate Fields (GGF) and XpressBet (XB) by putting into effect the Plan of Reorganization for the assets of MEC, which was previously confirmed by the US Bankruptcy Court.

The Board at its July 22, 2010 adopted a motion to extend the existing licenses of the Los Angeles Turf Club (LATC), the Pacific Racing Association (PRA), and XB advance deposit wagering (ADW) entity until December 26, 2010, and the existing waiver of Business and Professions Code sections 19483 and 19484, prohibiting common ownership, only until the September 16, 2010 in order for their parent company MID, to prepare and submit to the Board, on or before September 1, 2010, a comprehensive plan setting forth its intended business practices and procedures for operation of SA and GGF thoroughbred horse racing venues with the utilization of XB as an advance deposit wagering platform, all under common ownership. (The Board, at its August 10, 2010 regular meeting, extended the date of the waiver to September 23, 2010).

MID has submitted its request for wavier of Section 19483 and 19584 of the Business and Professions Code pursuant to the Boards July 22, 2010 resolution.

The exemption waiver request includes information addressing MID's ownership structure, management, financial assurances and intended business operations for SA and GGF.

In support of its request MID submits: that on April 30, 2010 MID became the owner of SA, GGF and XB. The three businesses are owned by MID through various wholly-owned subsidiaries. LATC, PRA and XB are all wholly-owned subsidiaries of MI Developments Investments Inc. The operations of SA are directed by George Haines, GGF is directed by Robert Hartman and XB's director is Ron Luniewski. Together, these individuals bring over 64 years of experience in the horse racing industry. In addition, Scott Daruty is actively involved in the strategic operation of SA, GGF and XB. He is currently the Chief Operation Officer of MI Developments Investments Inc.

Business and Professions Code section 19597.5. specifies that a person licensed under this chapter to conduct a horse racing meeting shall hold in trust the distributions required to be made pursuant to this chapter until the funds are paid to the various distributees. These required deductions, except for those that enure to the benefit of the racing association, are trust funds and shall not be used by the racing association for any purpose other than for payment to those distributees as directed by this chapter. These funds are not the property of the racing association, but are merely held in trust for the benefit of the statutory distributees until the funds are distributed to them in accordance with this chapter. These funds shall be held in a separate depository account until they are actually distributed as provided for in this chapter.

SA and GGF to be in compliance with section 19596.5 of the Business and Professions Code, have each entered into a common law business trust with Wells Fargo Bank. Pursuant to the terms of each trust, all statutory distribution money which ultimately is to be paid to the betting public and other statutory distributees is impounded in trust accounts with Wells Fargo Bank. Money can only be released from the trust account to the third party beneficiaries specifically named therein, which beneficiaries are the statutory distributees of such proceeds as designated by California Horse Racing Law, Business and Professions Code section 19400 et seq. Accordingly, all applicable statutory payments required to be made by SA and GGF, pursuant to California Horse Racing Law are secured by money in the trust accounts. Additionally, XB has on file with the Board a \$500,000 bond which fulfills the financial security requirement of advance deposit providers licensed by the Board.

MID's intended business operation of SA and GGF include a new racing surface at SA, the construction of two barns at SA and the development of new bonus stakes programs and wagers designed to benefit SA, GGF, racing fans, trainers, jockeys and owners.

MID requests that when the Board considers whether or not to grant the requested waivers, the Board take into account the benefits to the California racing industry that result from MID's ownership of the three entities. These benefits are a result of the synergies created by joint ownership of different racing venues, and from the positive impact other MID assets will have on the three horse racing related entities and the California horse racing industry as a whole. MID submits the racing industry is in a consolidating mode as evidenced by BetFairs acquisition of TVG (consolidation of a foreign exchange wagering business, a traditional domestic account wagering business and a television business), Churchill Downs recent acquisition of Youbet, thus consolidating the operation of four thoroughbred racetrack (Churchill Downs, Arlington Park, Fairgrounds, and Calder), two account wagering companies (Twin Spires and Youbet) and the rights to the Kentucky Derby. In the state of New York consideration is being given to consolidating the operation of the New York Racing Association with the operations of the New York City OTB system. MID submits it would be injurious public policy for the CHRB to ignore the trend of consolidation, and prohibit joint ownership of racing assets in California, particularly under the present economic circumstances where joint ownership results in significant benefits to the California racing industry. MID respectfully requests that the CHRB grant a MID a permanent waiver of section 19483 and 19484 of the Business and Professions Code.

BACKGROUND

Business and Professions Code section 19440 (a) states the Board shall have all powers necessary and proper to enable it to carry out fully and effectually the purposes of this chapter. Responsibilities of the Board shall include allocation of racing dates to qualified associations in accordance with law.

Board Rule 1430, Allocation of Racing Weeks and Dates, states the Board shall allocate racing weeks and dates for the conduct of horse racing in this State for such time periods and at such racing facilities as the Board determines will best subserve the purposes of the Horse Racing Law and which will be in the best interests of the people of California in accord with the intent of the Horse Racing Law.

In preparation for discussion regarding 2011 race date allocations, the industry was asked to submit proposed 2011 race dates. Proposals for southern California thoroughbred race dates have been received from the Los Angeles Turf Club (LATC); Hollywood Park Racing Association (HPRA); Del Mar Thoroughbred Club (DMTC); Oak Tree Racing Association (OTRA) and Fairplex Park Pomona (Pomona). The Los Alamitos Race Course has submitted its proposed 2011 race dates.

HPRA submitted a calendar that reflects calendar periods in which southern California tracks would operate rather than specific days on which live racing would be conducted. HPRA submits that in this regard, the number of days that a given association conducts live racing should be reflective of industry conditions, including the horse population. LATC also submitted a calendar that reflects the calendar periods for southern California thoroughbred racing, rather than specific days on which live racing would be conducted. Both associations reserve the right to resubmit their requests for 2011 racing dates should a racing association in 2011 seek an alteration of the historic calendar periods in which the racing association has operated.

HPRA and LATC's proposed southern California calendars are identical with the exception that LATC proposes the dates of September 28, 2011 through November 8, 2011 be allocated to LATC; while the calendar submitted by HPRA proposes that these dates be allocated to the OTRA.

Pacific Racing Association (PRA) submitted a Northern California's 2011 proposed racing calendar in conjunction with the Thoroughbred Owners of California (TOC) and California Thoroughbred Trainers (CTT).

A Northern California 2011 proposed racing calendar was also submitted by the California Authority of Racing Fairs.

In 2011 Cal Expo Harness proposes to race 129 days - December 30, 2010 through June 18, 2011 and August 12, 2011 through December 17, 2011.

Cal Expo submits it will market, promote, and advertise its racing meeting in the overall State Fair by which exceeds \$900,000 per year. They will also have a separate budget of approximately \$100,000 additional marketing, promotion, and advertising of the harness race meeting.
