#### ANALYSIS

The California Authority of Racing Fairs (CARF) board may vote to opt out of Stabling and Vanning for 2018. Should this occur, CARF has submitted a stabling plan for 2018 (see attachment). Under the plan, Pleasanton would act as auxiliary stabling during the month of May through June 3, and again during the months of July and August. Sacramento would act as auxiliary stabling June 14 through July 1, and from July 31 through August 12. Fresno would be open for training August 28 through September 23.

**Notes and Assumptions:** CARF BOD votes to opt out of Stabling and Vanning for 2018. Pleasanton's backside opens May 1-June 3 (10 days prior to live racing) for stabling 6 days each week, 30 days. Sacramento opens for full training 6 days a week from June 14 to July 1 (10 days prior to live racing) 16 days and July 31-Aug 12 days, 12 days. Pleasanton remains open for full training following live racing, 6 days a week during Sacramento July 12-29, 16 days and 6 days a week during Santa Rosa July 31-Aug 12, 12 days. Fresno opens for training 6 days a week following the end of Ferndale Aug 28 - Sept 23, (10 days prior to live racing) 24 days.
