

## COMPLAINT

CASE NUMBER: **14GG0096**

The CHRB hereby files a complaint against **Genaro Ornelas Vallejo** for violation of CHRB Rule **1843(a),(c) & (d), 1843.1(b), 1844(e)(1), 1844(g) & 1887(a)**. The person named in this complaint holds a license as a **Trainer**, license number **265292 Exp. 3/2017**. The offense alleged occurred on or about **August 28th, 2014** and is as follows:

**The official blood and urine samples #GG19907 taken on August 28<sup>th</sup>, 2014 at Golden Gate Fields was reported to contain 2-(hydroxylethyl) promazine, a metabolite of acepromazine. The urine sample was reported at 593 ng/ml of (hydroxylethyl) promazine and the blood sample was reported to contain 2.2ng/ml. This sample was obtained from the horse Techwood which ran in the 4th race at Golden Gate Fields finishing 3<sup>rd</sup>. The trainer of record is Genaro Ornelas Vallejo. Aceprpomazine is a Class 3 drug with a category B penalty.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
