The CHRB hereby files a complaint against **Luis Elias Mariscal** for violation of CHRB Rule 1843(a),(b),(d), 1843.1(a), 1844(a), 1844(e)(6), 1887(a), 1902(c), 1859.5. The person named in this complaint holds a license as a **Owner**, license number **261658 Exp. 10/2017**. The offense alleged occurred on or about **9/12/2015** and is as follows:

Owner Luis E. Mariscal medicated/injected his horse "Snowy Gaddafy" with Clenbuterol for three days prior to racing him at the San Joaquin County Fairgrounds in Stockton. On 9/12/2015, Snowy Gaddafy finished 1st in the 3rd race at Stockton, and subsequently tested positive for Clenbuterol in urine sample #F13644 at the Maddy Lab. This is a Class 3 Drug with a Category B Penalty.

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.

The person named in this complaint holds a license as a **Trainer**, license number **310667 Exp. 3/2018**. The offense alleged occurred on or about **September 12th, 2015** and

is as follows:

Trainer Adolfo Ortiz allowed a horse owner, Luis Elias Mariscal, to enter the horse Snowy Gaddafy under his name at the San Joaquin County Fairgrounds in Stockton without him actually training the horse. Snowy Gaddafy finished 1st in the 3rd race in Stockton, and subsequently tested positive for Clenbuterol in urine sample #F13644 at the Maddy Lab. This is a Class 3 Drug with a Category B Penalty.

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules.
