

# COMPLAINT

The CHRB hereby files a complaint against **MIKE MUDARIS** for violation of CHRB Rule **1843(A)(D)**, **1843.1(A)**, **1887**. The person named in this complaint holds a license as a **TRAINER**, license number **255448**.

The offense alleged occurred on or about **AUGUST 12<sup>TH</sup>, 2016** and

is as follows:

**ON AUGUST 12<sup>TH</sup>, 2016 THE HORSE "SHAKEITUPBETTY" TRAINED BY MIKE MUDARIS FINISHED 5<sup>TH</sup> IN THE 4<sup>TH</sup> RACE AT DEL MAR RACE TRACK. POST RACE SAMPLE # DM13181 WAS ANALYZED BY U.C. DAVIS LABORATORY AND WAS FOUND TO CONTAIN THE CLASS 3 DRUG "SILDENAFIL" (5.2 NG/ML IN BLOOD AND 14 NG/ML IN URINE).**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
