

COMPLAINT

CASE NUMBER: **17SW0015**

The CHRB hereby files a complaint against **Gerald Longo** for violation of CHRB Rule **1843(a)(d), 1843.1(a), 1859.5 & 1887**. The person named in this complaint holds a license as a **Trainer**, license number **072755, 4/19**.

The offense alleged occurred on or about **May 5, 2017** and

is as follows:

The official urine sample #CE27553 taken on May 5, 2017 at Cal Expo was reported by the Maddy Laboratory to contain Cocaine and its metabolites, benzoylecgonine, and ecgonine methyl ester. This sample was obtained from "Caress of Steel" trained by Gerald Longo. "Caress of Steel" ran in the 11th race at Cal Expo finishing 1st. The Maddy Lab findings were confirmed by the Texas Veterinary Medical Diagnostic Laboratory. This is a Class 1 prohibited drug substance with Category B penalty.

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
