

# COMPLAINT

The CHRB hereby files a complaint against **BRIAN KORINER** for violation of CHRB Rule **1844 (E) (4) / 1887 / 1843 (A)(D) / 1843.1(B) / .** The person named in this complaint holds a license as a **TRAINER**, license number **105117**. The offense alleged occurred on or about **AUGUST 18<sup>TH</sup>, 2018** and is as follows:

**ON AUGUST 18<sup>TH</sup>, 2018 THE HORSE "MR. VARGAS" TRAINED BY BRIAN KORINER FINISHED 1<sup>ST</sup> IN THE 7<sup>TH</sup> RACE AT DEL MAR RACE TRACK. POST RACE URINE SAMPLE # DM 14398 WAS ANALYZED BY U.C. DAVIS LABORATORY AND WAS FOUND TO CONTAIN THE CLASS 3 DRUG "PROCAINE" (2,932 NG/ML). PERMITTED LEVEL IS 25 NG/ML. NO SPLIT REQUESTED.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
