

COMPLAINT

The CHRB hereby files a complaint against **Larry A. Meriwether** for violation of CHRB Rule **1843(a), (b) & (d), 1843.1(a), 1887(a)**. The person named in this complaint holds a license as a **Owner**, license number **239962 Exp. 7/2019**. The offense alleged occurred on or about **April 28th, 2018** and is as follows:

The official blood sample #CE28757 taken on April 28th, 2018 at Cal Expo was reported by Ben Moeller, PhD of University California Davis Laboratories, to contain 323 ng/mL of Caffeine. This sample was obtained from the horse "Feeling Fancy Free" which ran in the 6th race at Cal Expo finishing 2nd. The trainer of record is Lester Smith. Larry A. Meriwether is a co-owner and responsible for the violation. Caffeine is a Class 2, Penalty Class B Violation.

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
