

# COMPLAINT

CASE NUMBER: **19LA0109**

The CHRB hereby files a complaint against **Jose Flores** for violation of CHRB Rule **1843(a,b&d), 1843.1(a), 1887(a) & 1902**. The person named in this complaint holds a license as a **Trainer**, license number **244643 - 09/2021**. The offense alleged occurred on or about **5/17/2019** and is as follows:

**Official blood sample #LA43731 taken on 5/17/2019 at LARC from horse, "Look of Love MV" was reported by Ben Moeller, PhD of the Maddy EACL at UC Davis contained d-methamphetamine. Official urine sample #LA43731 taken on 5/17/2019 at LARC from horse, "Look of Love MV" was reported by Ben Moeller, PhD of the Maddy EACL at UC Davis contained Amphetamine. D-amphetamine and amphetamine are Class 1, penalty Category A prohibited drug substances. The horse, "Look of Love MV" ran in the 5<sup>th</sup> race finishing 1<sup>st</sup>. A split sample analysis confirmed the violation. Jose Flores is the trainer of record.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
