### Wednesday

#### 10-02-13<sup>1</sup> ENTRIES / SCRATCHES

The racing office was open today accepting entries for Saturday, Oct. 5. The draw was completed by 12:00 p.m. Ten (10) races will be carded and the program will be headlined by the \$50,000 added Charlie Palmer Futurity for two year olds going one mile. This race is named after the late longtime Big Fresno Fair Racing Secretary Charlie Palmer who lived in Ferndale, California for fifteen years before retiring to Railroad Flat, California. He served well here in many capacities over three decades.

Scratch time was also held this morning in the racing office. There was one (1) scratch and two (2) jockey changes. All changes were disseminated after today's 9:00 a.m. deadline. Steward Paul Nicolo was on duty.

### Thursday

#### 10-03-13<sup>1</sup> JOCKEY MEETING

The stewards held a pre-meet assembly with the Big Fresno Fair rider's colony prior to today's first race. Several topics were covered, including timely attendance to the jockey's room/paddock and protocol for exchanging information with racing officials. It was stressed that racing safety is of paramount importance as is communication with the track veterinarian. Race riding safeguards and correct use of the riding crop were also reviewed. All in all, a good session was had.

#### 10-03-13<sup>2</sup> RACE #1 - INQUIRY

The stewards posted the Inquiry sign following this first event of the meet. At the start of

this three hundred fifty yard mule event #2 OKIE PRIDE PETE (Martin Arriaga) dwelt at the start. There was no starting gate malfunction of any kind. The stewards placed all the blame on OKIE PRIDE PETE himself. In a unanimous decision there was 'no change' in the order of finish.

Prior to the start of this race there was an approximate four (4) minute delay as #6 CASHING IN ON GEM (Trainer Bruce Towell) failed to load in the starting gate. This mule was subsequently a late scratch.

10-03-13<sup>3</sup> **RACE #3 - INQUIRY**

The stewards posted the Inquiry sign in order to review the start of this three hundred thirty (330) yard Quarter Horse race. In this race second place finisher #6 THE SPECIAL SNOW (Luis Langarcia) breaks into eventual first place finisher #5 JESS DANCEN THRU (Martin Arriaga) who then makes contact with third place finisher #4 CHICKY DEE CARTEL (Hugo Herrera). The stewards unanimously ruled that this incident at the start did not cost #4 CHICKY DEE CARTEL an opportunity for a better placing as she was beaten one (1) full length for second position. In a unanimous decision there was 'no change' in the order of finish.

10-03-13<sup>4</sup> **TIMING SYSTEM MALFUNCTION**

The fractional and final times of today's races were not posted on the toteboard today at the Big Fresno Fair. One (1) Arabian and five (5) Thoroughbred races were hand timed by clocker/timer Melody Truitt and fractional times were telephoned by Ms. Truitt to Pegasus Communications who has the electronic timing contract at this meet. They were then posted on TV monitors during the running of the races. Pegasus Communications staff and Big Fresno Fair Director of Racing Larry Swartzlander are currently working on the problem. More to follow.

10-04-13<sup>1</sup> **JUAN HERNANDEZ INFORMAL MEETING**

Jockey Juan Hernandez appeared in the steward's office along with his agent Ramon Silva.

Jockey Hernandez was aboard #3 JACK'S GONE who finished seventh and was eased in yesterday's eighth race going one (1) mile. This horse was eased before the ¼ pole. Jockey Hernandez subsequently trotted his mount back to the finish line in order to get unsaddled. The stewards told Hernandez to dismount when safe following the easing of a horse prior to the finish. Jockey Hernandez understood.

10-04-13<sup>2</sup> **CATALINO MARTINEZ FILM REVIEW**

Jockey Catalino Martinez appeared in the steward's office in order to review replays of yesterday's sixth race. Jockey Martinez was aboard #5 KVELL A LITTLE who finished eighth (last) in this race. Jockey Martinez's mount drifted in shortly after the start and made contact with fifth place finisher #4 ITSGONNACOSTYOU. The stewards placed some of the blame of this incident on the horse itself, however the stewards and Jockey Martinez all felt better corrective measures could have been taken. Warning issued.

10-04-13<sup>3</sup> **RULING NO. 1 – ADOLFO ORTIZ RULING**

The stewards unanimously ruled to issue the ruling listed below after Adolfo Ortiz waived his right to a hearing. The Ortiz trained EL JAGUAR is a two (2) year old first time starting Quarter Horse listed as a 'colt' in the official program but is actually a 'gelding.'

Trainer **ADOLFO C. ORTIZ** is fined the sum of seven hundred and fifty dollars (\$750)\* for failure to properly report the gelding of the horse **EL JAGUAR** which started in the third race on October 3, 2013; a violation of CHRB Rule #1865 (Altering of Sex of Horse).

10-04-13<sup>4</sup> **RACE #1 - OBJECTION**

The objection sign was posted after this race. Trainer Diana Skinner, who trains third place finisher #6 TM SHES ALL THAT (Luis Langarcia), lodged an objection against first place finisher #7 BARBARO EL TEXANO (Carlos Villalobos) for alleged interference at the start.

Film review shows #7 BARBARO EL TEXANO step in and make slight contact with #6 TM SHES ALL THAT who in turn made slight contact with fourth place finisher #5 SYLVIAS DOLL. The stewards spoke with Jockeys Villalobos and Langarcia via telephone. It was unanimously determined that the incident was minor in nature and did not warrant a change in the order of finish.

10-04-13<sup>5</sup> **RUSSELL BAZE PRESENTATION**

The California Authority of Racing Fairs (CARF) presented Jockey Russell Baze with a ring following the running of today's sixth race. This ring was to commemorate Jockey Baze's twelve thousandth (12,000) win which took place on closing day of the 2013 Alameda County Fair in Pleasanton (REF: 7-7-2013<sup>5</sup>). On hand to present the gift were Big Fresno Fair Chief Executive Officer John Alkire, CARF Executive Director Christopher Korby, Alameda County Fair Chief Executive Officer and Director of Racing Jerome Hoban, Big Fresno Fair Director of Racing/CARF Chief Operating Officer Larry Swartzlander, CARF Racing Secretary Tom Doutrich and Alameda County Fair Assistant Director of Racing Jeanne Wasserman.

**Saturday**10-05-13<sup>1</sup>**JOSE PEREZ BARAJAS HEARING (CASE NO: 13GG0112)**

A formal hearing was held today for Groom (suspended) Jose Perez Barajas. The CHRB has filed a complaint against Barajas for alleged violation of CHRB Rule 1484 (Evidence of Unfitness for License), Rule 1489(h) (Grounds for Denial or Refusal of License) and Rule 1890 (Possession of Contraband). CHRB Investigator Louis Quezada presented the case in front of Steward Grant Baker, Steward John Herbuveaux and Safety Steward Vic Stauffer. Court Reporter Vanessa Harkscamp (Niccoli Reporting). Groom Jose Perez Barajas failed to appear for this hearing.

10-05-13<sup>2</sup>**RACE #1 - WAGERING POOL ALTERATION**

In today's first race (mules) place and show wagering pools were not offered. In the six (6) mule event #5 SENORITA, trained by Peggy Hanford, was morning line favorite at odds of one to nine (1/9) and went off at that price also. Senorita won this race and paid \$2.10 to win.

10-05-13<sup>3</sup>**RACE #3 – INQUIRY / DISQUALIFICATION**

The stewards posted the Inquiry sign following the running of this three hundred and fifty (350) yard Quarter Horse race. At the break fifth place finisher #4 CORONA STYLE SNL (Hugo Herrera) broke in very sharply, bumping and virtually eliminating #3 BOTTICHELLI (Luis Langarcia) from any competition. Following a patrol judge report and film review the stewards, in a unanimous decision, #4 CORONA STYLE SNL was disqualified and placed ninth (last). Jockey Hugo Herrera was ordered to film review.

10-05-13<sup>4</sup>**RACE #9 – INQUIRY / OBJECTION / DISQUALIFICATION**

The stewards posted the Inquiry sign following the running of this one (1) mile event. There was also a jockey's objection in this race. Jockey Catalino Martinez was aboard second place finisher #3 LAST MEMORIES and he claimed foul against first place finisher #5 ROCK SOLID CHARM (IRE) (Russell Baze) for alleged interference in the final one hundred (100) yards.

The stewards reviewed replays of this race from all angles. Race replays show #5 ROCK SOLID CHARM (IRE) drift out in the final sixty (60) yards and make contact with #3 LAST MEMORIES. This action forced #3 LAST MEMORIES about one and one half (1 ½) body widths off his straight course towards the outside portion of the racetrack. The stewards spoke with both jockeys involved. In a unanimous decision the stewards disqualified #5 ROCK SOLID CHARM (IRE) and placed him second. Jockey Russell Baze was ordered to film review.

10-05-13<sup>5</sup>**RACE #10 – TEN (10) MINUTE DELAY**

Prior to the start of this five and one half (5 ½) furlong final race of the day, Assistant Starter 'Butch' Zollinger was kicked by a horse he was helping to load. Human ambulance personnel attended to Zollinger while the jockeys dismounted from their horses.

Safety Steward Vic Stauffer accompanied Big Fresno Fair Nurse Practitioner (NP) Breena Siliznoff out onto the racetrack to address this situation. Assistant Starter Zollinger eventually rose to his feet and took the race off. A kick in the leg was reported. After a ten (10) minute delay this race went off without incident.

10-06-13<sup>1</sup> **MAGGIE HARDISON MEETING**

Apprentice Jockey Maggie Hardison came into the steward’s office at our request today. The stewards wanted to discuss the actions of Apprentice Hardison who rode #6 MAHMOUD MEMORY in yesterday’s (October 5) ninth race. This horse was charted as eased in this race and the stewards wished to talk about when pulling up a horse that is well out of competition is a better alternative to riding them out to the wire.

10-06-13<sup>2</sup> **RULING NO. 2 – HECTOR SANCHEZ RULING**

The stewards spoke to Trainer Hector Sanchez today on the telephone. Trainer Sanchez was not present in the paddock to saddle his horse in the ninth race on October 5, 2013. Two (2) valets saddled the horse in his absence. The stewards unanimously ruled to issue the following ruling.

Trainer **HECTOR SANCHEZ** who was scheduled to saddle **JAY’S FIRETRUCK** in the ninth race on Friday, October 4, 2013 at the Big Fresno Fair, is hereby fined the sum of one hundred dollars (\$100)\* for violation of California Horse Racing Board rule 1894 (Duties of Trainer – Failure to Saddle Horse).

10-06-13<sup>3</sup> **RULING NO. 3 – RUSSELL BAZE FILM REVIEW (REF: 10-05-13<sup>4</sup>)**

Jockey Russell Baze appeared in the steward’s office to view his ride in yesterday’s ninth race. Jockey Baze was aboard original first place finisher #5 ROCK SOLID CHARM (IRE) who was disqualified and placed second for interference in the final sixty (60) yards. Jockey Baze didn’t completely agree with the stewards unanimous interpretation of events yesterday. He felt second place finisher #3 LAST MEMORIES (Catalino Martinez) contributed to the events which led to #5 ROCK SOLID CHARM (IRE) being disqualified.

Today’s film review shows Jockey Baze whip his mount left handed before initiating contact with his outside rival. He grabs (corrects) his horse at the point of contact, but at that time a foul had already been committed. The actions (errant path) of ROCK SOLID CHARM (IRE) could not be placed on the horse himself. In a unanimous decision the following ruling was issued:

Jockey **RUSSELL BAZE** who rode **ROCK SOLID CHARM** in the ninth race on Saturday, October 5, 2013 at the Big Fresno Fair, is suspended three (3) racing days (October 13, 14 & 17, 2013) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from first to second; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

- 10-06-13<sup>4</sup> **TIMER PROBLEM (REF: 10-03-13<sup>4</sup>)**  
 For this four (4) day racing week race times were not posted on the toteboard during or after the race. This issue is being addressed according to onsite representatives of Pegasus Communications the video and timing operator here at the Big Fresno Fair. The stewards have requested a letter of explanation from Pegasus Communications regarding the timing problem at this meet. That letter will be included with next week’s minutes.
- 10-06-13<sup>5</sup> **RACE #2 – INQUIRY**  
 The stewards posted the Inquiry sign following the running of this three hundred fifty (350) yard Quarter Horse race. Race replays show contact between first place finisher #2 WILLIE DASHER (Cruz Mendez) and second place finisher #7 Z BEST CONTENDER (Hugo Herrera). #2 WILLIE DASHER won this race by a short head. Films indicate that most of the contact in this race was caused by second place finisher #7 Z BEST CONTENDER who veered in and bumped the winner at least twice in the races latter stages. In a unanimous decision there was no change in the order of finish. Jockey Hugo Herrera was ordered to film review.

 Apprentice Jockey Maggie Hardison was unseated from the second place finishing #1 DARK NIGHT’S LIGHT while pulling up following today’s fourth race. Accident report attached.
