The stewards are in receipt of a remand order concerning the two day driving suspension of Driver David Siegel. Ruling #142 suspending Siegel was set aside. The matter is set for hearing on July 27, 2007.

- Ruling # 143**
- Driver Richard Wojcio, who drove “Dusty Colors” in the First Race on Friday July 20, 2007, is hereby fined the sum of One Hundred (\$100) Dollars for violation of California Horse Racing Board Rule #1530 (Cases Not Covered – Driving with Foot Out of Stirrup/Urging by Contact).
- The above ruling was issued after Wojcio was contacted by phone and accepted the penalty. He understands future penalties for similar violations will result in stiffer fines.

The inquiry sign was posted to review the third (3rd) place finisher #6 “Cast British” (Rick Plano) at the finish.
