Proceedings of the Board of Stewards for the period of Monday, August 20, 2007 through Sunday, August 26, 2007. Steward Michael W. "Wayne" Oke was the Reporting and Duty Steward for the enclosed period.

08/20/07 (1) **Dark Day**

08/21/07 (1) **Double Entry/Draw for Friday and Sunday**

The race office was open today accepting entries for Friday, August 24 and Saturday, August 25, 2007. The draw for Friday August 24, 2007 was conducted with ninety-three (93) horses drawing in to twelve (12) races. Scratch time for Friday's races is Wednesday August 22, 2007 at 9:00 a.m. The complete card for Saturday August 25, 2007 will be drawn on Thursday, August 23, 2007.

08/21/07 (2) **"Cat Burglar" – Gelding/Filly**

Further inquiries in to this situation have revealed that this horse was mistakenly registered as a 'gelding' with the United States Trotting Association (USTA).

However, at the time this horse was identified, tattooed and DNA tested, it was correctly identified as a 'filly' by Technician Bill Vallandingham.

08/21/07 (2) continued

This horse has, at this point, been properly identified as a filly and all official records have been changed to reflect the change. This horse was bred and is currently owned by Desomer Stables, trained by Vicki Desomer.

Senior Special Investigator Marty Snezek has been provided copies of the documents in question and will investigate further.

08/21/07 (3) **Identification Procedures**

In light of recent problems in the identification process, these procedures have been refined and 'tightened up' considerably.

08/22/07 (1) **Scratch Time**

Scratch time for Friday August 24, 2007 was at 9:00 a.m. today. There were no scratches and five (5) driver changes.

Additionally, thirty three (33) horses were drawn to compete in six (6) qualifying races commencing at 4:30 p.m.

08/22/07 (2) **Qualifying Races**

Six (6) qualifying races were contested at 4:30 p.m. under the supervision of Stewards Meyers and McClaren. Twenty four (24) horses were successful in their qualifying attempts.

08/22/07 (3) **First Race – Driver Communication/Sanction**

Immediately after the running of Race #1, the stewards were in telephone contact with Driver R. Plano (the driver of #6 "Nextopmodel") concerning the start of the race, when #6 was 'off the gate'. Driver Plano offered no acceptable explanation for the situation; Driver Plano was fined One Hundred (\$100) Dollars for 'Failing to Come Up into Position'. Driver Plano accepted the sanction and stated "He would attempt to avoid further happenings of this nature".

Entries were taken and the draw conducted for Saturday August 25, 2007. Scratch time was at the draw. There were ninety seven (97) entered to compete in twelve (12) races.

08/23/07 (2) First Race – Starter’s List

After this contest, and after consulting with Starter Bill Vallandingham, the stewards contacted Driver/Trainer R. Plano by telephone and informed him that the horse “Cast British” was being placed on the ‘Starters List’. The horse must be ‘schooled’ and approved by the Starter before re-entry.

The horse was rank and bad gaited behind the gate and Driver Plano did an exceptional job in getting the horse away without breaking stride. Driver Plano concurred with this decision.

#4 “Credible Preciosa” was claimed for \$4,200.00. The owner will be F. Navarrez and the trainer will be J. Ramirez.

Friday**08/24/07 (1) Second Race – Inquiry/Disqualification/Sanction**

The inquiry sign was posted immediately following the second race to investigate the stretch drive during which #7 “Little Rocknroll”, driven by S. Hyman, appeared to go inside multiple pylons in order to improve his position. After reviewing the films the stewards unanimously concluded that #7 was indeed in violation of the pylon rule. #7 finished fifth (5th) was placed eighth (8th) for violation of the pylon rule. Consequently, Driver Hyman was sanctioned for violation of the pylon rule. See Ruling #17.

08/24/07 (2) Second Race – “Jungle Girl” – Tattoo #/Investigation

The winner of this race, #2 “Jungle Girl”, was sent to the test barn after this race for routine testing.

The stewards were contacted by State Veterinarian Dr. Robert Goodbary communicating that there was a potential problem with the tattoo number/freeze brand on “Jungle Girl”. It was determined that this horse was originally tattooed incorrectly. However the tattoo #/freeze brand had been corrected using procedures approved by the USTA. The problem occurred when the information transmitted to Dr. Goodbary by Identifier Carl Sobey did not reflect the updated information. This horse was bred and is currently owned by Desomer Stables, trained by Vicki Desomer.

Senior Special Investigator Marty Snezek is aware of the situation and will investigate further.

Double Draw

The race office was open this morning taking entries for Wednesday, August 29, 2007 and Thursday August 30, 2007. For Wednesday August 29, 2007 there were eighty three (83) horses to compete in ten (10) races. For Thursday, August 30, 2007 there were eighty three (83) horses to compete in ten (10) races. Scratch time for both days is today at 8:00 p.m. For Wednesday's card there is one (1) scratch and three (3) driver changes. For Thursday's card there were no scratches and two (2) driver changes.

Trainer McConnell Telephone Call

Trainer McConnell was in telephone contact with the stewards and acknowledged her responsibility under the 'Trainer Responsibility' rule. The horse competed on July 28, 2007 in Race #5 at Cal-Expo. Routine testing revealed a reading for Flunixin (Banamine). This was Ms. McConnell's first violation this year. She was assessed and accepted a Three Hundred (\$300) Dollar fine. She stated that after consulting with Dr. R. Goodbary, they had determined how this violation occurred and that she was taking steps to avoid a recurrence. See Ruling #19.

Twelfth Race – Double Inquiry/Refund/No Change

Prior to the start of Race #12 the inquiry sign was flashed owing to the fact that #6 "Cautious Spirit N" refused the starting gate. It was determined at the conclusion of the race that #6 would be considered a non starter and all monies wagered would be refunded. #6 "Cautious Spirit" was placed on the stewards' list and will be required to qualify before re-entry. This scratch resulted in a refund of \$1,114.20.

A second inquiry was necessitated by some close quarters racing at the head of the stretch between #8 "Chicote", driven by R. Kuebler, and the eventual winner #7 "Go Minnie O", driven by Katie Scott. After reviewing the films and speaking to both drivers it was determined that no change was warranted. Driver Scott will review films with the stewards Thursday August 30, 2007.
