Proceedings of the Board of Stewards for the period of Monday, October 08, 2007 through Sunday, October 14, 2007. Steward Michael W. "Wayne" Oke was the Reporting and Duty Steward for the enclosed period.

10/08/07 (1) **Dark Day**

10/09/07 (1) **Draw for Friday October 12, 2007**

The racing office was open this morning accepting entries for Friday October 12, 2007. There were ninety-six (96) horses drawn to race in twelve (12) races. Scratch time is October 10, 2007 at 9:00 a.m.

10/09/07 (2) **Dark Day**

10/10/07 (1) **Scratch Time**

Scratch time for Friday October 12th resulted in four (4) driver changes and no scratches. Additionally, the horse "Yes It Is", who was making his first start at Cal-Expo, was discovered to be a gelding, not a stallion as indicated by the records to the USTA.

10/10/07 (1) continued

The appropriate parties were notified (Program Dept, USTA, Race Secretary and Dr. R. Goodbary). The program should contain the proper information. Also, the claiming price for this participant should read \$15,000 not \$12,000. This problem was also corrected prior to scratch time.

10/10/07 (2) **Entries for Saturday October 13th**

The race office was open this morning, accepting entries for Saturday October 13, 2007. Eleven (11) races were drawn with the remainder of the card [three (3) races] to be drawn Thursday October 11, 2007 at 9:00 a.m.

10/10/07 (3) **Draw for Qualifying Races**

The race office took entries this morning for qualifying entries to be contested at 4:00 p.m. There were forty-five (45) horses entered in seven (7) qualifying races.

10/10/07 (4) **Qualifying Races**

Seven (7) qualifying races were commencing at 4:00 p.m. under the supervision of Stewards Baker and Meyers. Thirty (30) horses were successful in their qualifying efforts.

10/10/07 (5) **Seventh Race – Inquiry/No Change**

The stewards posted the inquiry sign immediately at the conclusion of this race in order to investigate an incident that occurred immediately after the start. Shortly after the start the eventual race winner, #3 “Blue Overcoat”, made a brief ‘break in stride’. After reviewing films, the stewards concluded that #3 complied with the breaking rule and no change was warranted.

Thursday10/11/07 (1) **Completion of Entries and Draw**

The race office was open this morning accepting entries to complete the card for Saturday October 13, 2007.

A total of one hundred and ten (110) horses were drawn in to fourteen (14) races for Saturday's card.

10/11/07 (2) **California Breds – 2 & 3 Year Olds**

Saturday October 13th's program includes four (4) California Sire Stakes races with twenty-seven (27) horses competing in the four (4) events.

10/11/07 (3) **First Race – Claim**

#4 "Doctor Gates" was claimed from Frank Petrelli and Rick Walter Stables for \$5,625. The new owner will be Jessica Hensley.

10/11/07 (4) **Fifth Race – Claim**

#4 "Colie" was claimed from Mark Knutson for \$4,500. The new owners will be Frank Petrelli and Owen Eiler, Jr.

10/11/07 (5) **Sixth Race – Claim**

#5 "Mid West Hottie" was claimed from Frank Petrelli and Rick Walter Stables for \$4,350. The new owner will be Jessica Hensley.

10/11/07 (6) **Eighth Race – Claim**

#2 "Mighty Fella" was claimed from Henry Wieseneck for \$7,500. The new owner will be Joseph Ricco, Jr.

10/11/07 (7) **Ninth Race – Inquiry/No Change**

The stewards posted the 'inquiry' sign following the running of Race #9 to investigate an incident immediately after the start, in which #3 "Challenge The King", the eventual fourth (4th) place finisher, and #5 "Mistress Of The Ball", both, broke stride. After reviewing films the stewards concluded that both horses had complied with the 'breaking rule' and no change was warranted.

Friday10/12/07 (1) **Financial Responsibility Hearing**

A hearing was scheduled for Friday October 12, 2007 at 3:30 p.m. to hear a financial responsibility complaint filed against Owner Dean Matthew Eckley by Trainer Jeffrey Waltenburgh.

Owner Eckley failed to appear and will be suspended for 'failure to appear'. The following ruling was issued:

Ruling # 47

Owner Dean Matthew Eckley, is hereby suspended pending an appearance before a Board Of Stewards for violation of California Horse Racing Board Rule #1547 (Failure to Appear) as ordered in Complaint 07SW-0074 to answer charges of alleged violation of California Horse Racing Board Rule #1876 (Financial Responsibility).

10/12/07 (2) **Track Condition**

Due to an all day rain, the stewards, after consultation with the starter and horseman's representative, listed the track condition as 'good'.

The horseman did an excellent job of avoiding any problems under less than ideal conditions.

10/12/07 (3) **Third Race – Inquiry/No Change**

Immediately after the conclusion of Race #3, the stewards posted the 'inquiry' sign to investigate an incident immediately after the start in which #6 "Legal Table", driven by Steve Wiseman, 'made a break'. The break was very brief and after viewing the films, the stewards determined that #6 had complied with the breaking rule and no change was warranted.

10/12/07 (4) **Fifth Race – Inquiry/No Change**

The 'inquiry' sign was posted at the conclusion of Race #5 to inquire into an incident at the 1/4 pole at which point #2 "Slicker N Quicker" and #4 "Cheyenne Wyoming", both, made breaks. #2 also went off the course at this point and made another 'break' in the stretch. After reviewing films the stewards concluded that there were no rule violations and no change was warranted.

Saturday10/13/07 (1) **Petrelli/Hensley Confrontation**

There is apparently a problem with these two (2) licensees stemming from Hensley claiming two (2) horses on Thursday October 11, 2007. The situation elevated to the point of confrontation; at which point the on duty steward intervened and both parties were informed that no such recurrences will be tolerated.

10/13/07 (2) **Plano/Detention Barn**

Trainer Rick Plano contacted the stewards prior to Race #1 to inform of a situation with his horse "Themaninthefwindow". When Plano's people went to retrieve the horse to get him ready, the horse was not properly secured and was in a potentially harmful situation. Senior Special Investigator William Arietta was called and an investigation was begun. More to follow.

10/13/07 (3) **Fifth Race – Inquiry/No Change**

The 'inquiry' sign was flashed immediately after the completion of Race #5 to investigate an incident at the start of the contest when #6 "Stars And Sites", the eventual race winner, broke stride. After reviewing the films the stewards concluded that #6 had complied with the 'breaking rule' and no change was warranted.

10/13/07 (4) **Eighth Race – Inquiry/No Change**

The stewards posted the 'inquiry' sign following the finish to investigate an incident nearing the finish when #'s 1, 2, 3, 4, and 6 were in tight quarters at the wire. After viewing films the stewards concluded there were no rule violations and no changes were warranted.
