Friday10/26/07 (1) **Petrelli Rulings****Ruling # 54**

Trainer Frank Petrelli, who trained "Garland Bot Joeefee" in the Eighth Race on Thursday October 25, 2007, is hereby fined the sum of Fifty Dollars (\$50) for violation of California Horse Racing Board Rule #1530 (Cases Not Covered – Late Leaving Paddock).

The above ruling was issued after Petrelli was contacted by phone. He claims he had broken equipment, but Paddock Judge Wayne Short reported no problems. Either way, the trainer is responsible to have his horse ready to go.

Ruling # 55

Trainer Frank Petrelli is hereby fined the sum of Two Hundred (\$200) Dollars for submitting a late declaration on "Cherry Lane Star" in the Ninth Race on October 25, 2007. A violation of California Horse Racing Board Rule #1894 (Duties of Trainer – Late Declaration)

The above ruling was issued after Petrelli was informed by phone that he was late with his scratch request and should have contacted the stewards before the identifier had reported his horse missing.

10/27/07 (2) **Kuebler Hearing [Ref 10/05/07 (3)] Case #07SW-0084**

A hearing was held today concerning the bad claiming price in the program on October 5th for "Pip's Jenny G". Testimony was taken from Trainer Lou Pena, Assistant Race Secretary Joe Nefsky and Racing Secretary Fred Kuebler. Bottom line was that Assistant Secretary Nefsky knew about the problem before the race and failed to take action to correct the problem. Kuebler agreed that it is his responsibility to supervise the personnel and program information. As 'the boss', Kuebler candidly accepted full responsibility.

10/27/07 (3) **Tenth Race – Inquiry/No Change**

The inquiry sign was posted to review a possible incident involving #2 "Enunciator" (Jim Lackey) and #6 "Bob Lee" (Lemoyne Svendsen), who finished fifth (5th) and seventh (7th), respectively. #2 appeared to come in, brushing the legs of #6 near the wire. After review it was determined that the race was actually over when the minor incident occurred. No change.
