02/18/08 (1) Entries for Thursday

Eleven (11) races drew eighty nine (89) entries for Thursday. No Cal-Bred races were used.

02/18/08 (2) Hensley Ruling

#### Ruling # 33

Driver Ed Hensley, who drove "Schemes" in the Fourth Race on Saturday, February 16, 2008, is hereby fined the sum of One Hundred (\$100) Dollars for violation of California Horse Racing Board Rule #1731 (E) (Driver Infractions [Starting Rules] – Crossing Over Before Reaching the Start).

The above ruling was issued after Hensley was contacted and pled guilty to a mental lapse at the start of the fourth race. The penalty was accepted without argument.

 Friday's fourteen (14) race card drew ninety six (96) entries. No Cal-Bred races were used. Ninety seven (97) horses are entered for Saturday's fourteen (14) race card. No Cal-Bred races were used.

### **Wednesday**

- 02/20/08 (1) **Scratches for Friday and Saturday**  
 Scratches and changes were held this morning with a half dozen driver changes for each day.

- 02/20/08 (2) **Dark Day**

### **Thursday**

- 02/21/08 (1) **Qualifiers**  
 Six (6) qualifying races were held on a sloppy surface this afternoon. Twenty one (21) of twenty eight (28) participants made the grade.
- 02/21/08 (2) **Inclement Weather**  
 The first five races were conducted with the track listed as 'sloppy'. Races 6 through 11 were listed as 'good'.
- 02/21/08 (3) **Fourth Race – Inquiry/No Change**  
 #4 "London Calling" (Tim Maier) went off stride at the wire, finishing second (2<sup>nd</sup>). Driver Maier complied with the breaking rule and no competitors were 'lapped on'. No change.

02/21/08 (4) **Seventh Race – Flat Tire**

The inside tire of #1 “Jen U Win B B” (Steve Wiseman) popped at the start. No other horses were involved. #1 ended up last from the mishap.

02/21/08 (5) **Tenth Race – Inquiry/Disqualification**

The inquiry sign was posted to review possible interference near the first 1/4 involving third (3<sup>rd</sup>) place finisher #7 “Prospect Speed” (Rocky Stidham) and seventh (7<sup>th</sup>) place finisher #4 “Anns Nestegg” (Luke Plano).

Tapes show #7 and Driver Stidham attempting to force their way into a small opening (hole) in front of #4 and Driver Plano. Plano is forced to grab and pull his horse off stride in order to avoid #7’s wheels. #4 recovered to be seventh (7<sup>th</sup>), but was cost any chance at a better placing by being forced off stride. #7 was disqualified from third (3<sup>rd</sup>) and placed seventh (7<sup>th</sup>) behind #4.

Driver Stidham will review the tapes with the stewards tomorrow.

02/21/08 (6) **Eleventh Race – Inquiry/No Change**

The winner, #3 “The Situation” (Gilbert Herrera) raced inside a pylon at the top of the stretch while attempting to pass #2 “Credible Preciosa” (8<sup>th</sup>, James Kennedy) on the inside. After review it was determined that room existed for #3 to get through and the #2 comes down, forcing #3 inside the pylon. No Change.

Driver James Kennedy will review his actions with the stewards tomorrow.

**02/22/08 (2) Soto Ruling – Case No. 07SW-0104****Ruling # 34**

Racing Official Zachary Soto is hereby fined the sum of Four Hundred (\$400) Dollars for failure to provide accurate information in the official program at The Big Fresno Fair on October 6, 2007. A violation of California Horse Racing Board Rules #1581 (Racing Secretary to Establish Conditions).

The above ruling was issued after a plea agreement was reached.

**02/22/08 (3) Stidham Ruling****Ruling # 35**

Driver Rocky Stidham, who drove “Prospect Speed” in the Tenth Race on Thursday, February 21, 2008, is hereby fined the sum of Two Hundred (\$200) Dollars for violation of California Horse Racing Board Rule #1721(E)(I) (Driving Rules – Crowded a Horse – Forced a Hole Causing Interference – Quarter Mile Pole).

The above ruling was issued after Stidham appeared and reviewed last night's tenth race with the stewards. Stidham was candid in admitting his mistake, stating “I thought I had more room than I did”.

**02/22/08 (4) Kennedy Ruling****Ruling # 36**

Driver James Kennedy, who drove “Credible Preciosa” in the Eleventh Race on Thursday, February 21, 2008, is hereby fined the sum of One Hundred (\$100) Dollars for violation of California Horse Racing Board Rule #1721 (I) (Driving Rules – Impede Progress of Another Horse in the Stretch) and #1721 (J) (Change Course After Selecting a Position in the Homestretch or Bear In or Out in Such a Manner as to Interfere With Another Horse).

The above ruling was issued after Kennedy appeared and pled his case. He felt he was just trying to keep the inside closed so horses couldn't pass on the inside. The stewards explained that once the hole opens and a horse starts to come through, you can't 'shut the door' and drive them off the track.

Early rains caused the track to be listed as “sloppy” for the first nine races. Races 10 through 14 were listed as “good”.

## **Saturday**

02/23/08 (1) **Luke Plano Ruling**

### **Ruling # 37**

Driver Luke Plano, who drove “Only In California” in the Twelfth Race on Friday, February 22, 2008 is hereby fined the sum of Five Hundred Dollars (\$500) for violation of California Horse Racing Board Rule #1734 (Whipping – No Driver Shall Use Unreasonable or Unnecessary Force in the Whipping of a Horse).

The above ruling was issued after young Plano appeared, reviewed the tape and apologized profusely for losing his cool. The severity of the penalty reflects the inappropriateness of his actions.

02/23/08 (2) **Second Race – Inquiry/No Change**  
The inquiry sign was posted to review possible interference involving the winner #1 “The Pand Illusion” (Rick Plano) and third place finisher #5 “California Dream” (Luke Plano) in the stretch. After review it was determined that while the two sulkies did bump together momentarily, no interference occurred.

02/23/08 (3) **Third Race – Inquiry/Disqualification**  
 #5 “Allata Collada” (George Luster) came out down the backside as #2 “Ima Princess Tu” (Harold Herrera) attempts to pass. The action of #5 causes both horses to lock wheels, which in turn causes #2 to go off stride. #5 finished fifth (5<sup>th</sup>) and #2 finished sixth (6<sup>th</sup>). #5 was placed sixth (6<sup>th</sup>) for the interference.

02/23/08 (4) **Inclement Weather Causes Many Scratches & a Delay**  
 Bad weather caused sixteen (16) late declarations. Heavy rains and high winds made the first three races run on a very flooded racing surface. Following the third race, the stewards received a call from Driver Rick Plano who said a number of drivers were concerned with visibility on the track. A meeting was held with the drivers, General Manager Dick Feinberg, Steward Will Meyers and track maintenance. The drivers were concerned that only one tractor was being utilized to remove the standing water. During the meeting we were informed a second tractor was now being utilized and the water would be removed at a faster pace. The drivers were satisfied, and after two passes by the tractors and a twenty minute delay, racing resumed. The weather calmed and the rest of the evening was uneventful.

 Drivers were permitted to beg off their mounts for visibility issues if they so desired. Chris Hernandez, Tim Maier, Frank Petrelli and Richard Bertrand opted off their drives.
