Proceedings of the Board of Stewards for the period of Monday, March 17, 2008 through Sunday, March 23, 2008. Steward Michael W. "Wayne" Oke was the Reporting and Duty Steward for the enclosed period.

03/17/08 (1) **Draw for Thursday 03/20/08**

The race office was open this morning accepting entries for Thursday. At 12:30 p.m. the draw was held with ninety-three (93) horses drawing in to eleven (11) races. Scratch time will be Tuesday March 18, 2008 at 9:00 a.m.

03/17/08 (2) **Dark Day**

03/18/08 (1) **Scratch Time for Thursday 03/20/08**

At scratch time there were two (2) scratches and thirteen (13) driver changes.

03/18/08 (2) **Draw for Friday 03/21/08 & Saturday 03/22/08**

The race office was open this morning accepting entries for Friday's and Saturday's programs.

At 3:00 p.m. the draw for Friday was held with one hundred five (105) horses drawing to compete in thirteen (13) events. Immediately thereafter

the draw was conducted for Saturday's program with one hundred four (104) horses drawn to compete in thirteen (13) events.

Scratch time for both programs is Wednesday March 19, 2008 at 9:00 a.m.

03/19/08 (1) **Scratch Time for Friday 03/21/08 & Saturday 03/22/08**

Scratch time for both programs was today at 9:00 a.m. For Friday's card we had eight (8) driver changes and one (1) scratch.

For Saturday's card we had ten (10) driver changes and no scratches.

03/19/08 (2) **Qualifying Race Draw**

Entries were taken for qualifying races to be contested Thursday, March 20, 2008 at 4:30 p.m. Six (6) qualifying races are scheduled for Thursday p.m. with forty one (41) horses scheduled to compete.

03/20/08 (1) **Brian Solden Hearing – CHRB Case #08SW-0051**

Trainer Brian Solden appeared before the stewards concerning California Horse Racing Board Complaint #08SW-0051. Trainer Solden waived his right to a hearing and accepted the penalty for a first offense. See Ruling #14.

03/20/08 (2) **Qualifying Races**

Qualifying races were held today at 4:30 p.m. under the supervision of Stewards Meyers and McLaren. Thirty (30) of forty-one (41) entrants were successful in their qualifying efforts.

03/20/08 (3) **Race #2 – Late Declaration/Owner**

On Thursday afternoon the stewards were notified via the daily problem sheet that Owner Gene Kelly had not paid the fine (\$500) assessed under Ruling #04, dated March 08, 2008. The stewards scratched #6 "Four Starz Bambino" from Race #2 and issued Ruling #15 rescinding the reinstatement of Owner Gene Kelly's license.

03/20/08 (4) **Race #9 – Driver/Trainer – Conflict**

Immediately following Race #9, it was brought to the attention of the stewards that there was a possible conflict of interest relative to Trainer/Driver Frank Petrelli. Following is a narrative forwarded to Executive Director Breed at his request, outlining the circumstances from the steward's perspective:

03/21/08 (2) **Race #11 – Timer Malfunction**

At the conclusion of Race #11, the timer on the infield tote board showed the race time as 1:54. The official computer in the judge's stand showed the actual race time to be 1:54².

Officials at Plusmic USA have been informed and are investigating.

Saturday03/22/08 (1) **David Siegel/Stewards**

Driver David Siegel met with the stewards today at 5:00 p.m. The meeting (in response to a request by Mr. Siegel) was called to discuss a variety of concerns expressed by Mr. Siegel.

Mr. Siegel's concerns appeared to center around a situation which developed on Saturday, January 05, 2008 when Driver Siegel was not allowed to be named on drives for Thursday, January 10, 2008, due to the fact that he had been excused from his driving commitments on Friday, January 04, 2008 and Saturday, January 05, 2008 due to an injury suffered off-track on the previous Sunday.

Mr. Siegel's contention was that in light of the fact that he had provided a doctor's clearance effective Sunday, January 06, 2008, he should have been allowed to accept these driving assignments.

After a rather lengthy discussion, during which the stewards assured Mr. Siegel that he was being treated as would any other licensee, the meeting was adjourned.

03/22/08 (2) **Race #6 – Inquiry/Start**

At the start of this race, it appeared that #1A "Webstar" (James Kennedy), and second (2nd) place finisher #3 "Bud's Buddy" (Benedicto Alavarez [P]) were momentarily 'out of position' behind the starting gate. However, the situation was quickly rectified and the start continued. After viewing films and talking to the starter, the stewards unanimously

concluded there were no rule violations and thus no change in the official order of finish.

03/22/08 (3) **Race #12 – Timer Malfunction**

At the conclusion of Race #12, the timer on the infield tote board showed 1:55 while the official computer in the judge’s stand showed 1:55³. This was the second incident of this kind in the past three (3) days.

Management at Plusmic Inc. are aware of this ‘intermittent problem’ and are attempting to isolate the problem.

03/22/08 (4) **TVG Returns – Good Racing/Improving Handle**

The previous problems with TVG have been resolved and TVG is carrying our signal and accepting wagers. The week’s programs featured extremely competitive racing and management expressed optimism with the improving handle.
