A hearing was held concerning Mark Kennedy's citation by the State Fair Police Department for driving within the enclosure without a valid driver license.

03/29/08 (4) **Mark Kennedy Ruling**

The stewards fined Mr. Kennedy Fifty (\$50) Dollars for violation of California Horse Racing Board Rule #1530 (Cases Not Covered – Backstretch Traffic Regulation).
