12/22/08 (1) **Entries and Draw for Friday 12/26/08 & Saturday 12/27/08**

Entries were taken and a double draw held for Friday and Saturday's card. At the 4:00 p.m. draw for Friday's card one hundred twenty seven (127) head were drawn to compete in fifteen (15) events. Scratch time for this card will be tomorrow at 9:00 a.m.

At the 4:45 p.m. draw for Saturday's card one hundred thirty one (131) head were drawn to compete in fifteen (15) events. Scratch time for this card will be tomorrow at 9:00 a.m.

12/27/08 (1) **Entries and Draw for Thursday 01/01/09**

Entries were taken and a draw held for the New Years Day program. At the 10:45 a.m. draw seventy nine (79) horses were drawn to compete in ten (10) races. Scratch time is tonight at 8:00 p.m.

12/27/08 (2) **Qualifying Entries for Saturday 12/27/08**

Entries were taken and a qualifying sheet produced for two (2) qualifying races with eleven (11) horses competing. These races to be conducted this evening at 4:30 p.m.

12/27/08 (3) **Informal Hearing – Case #08-SW0117/Trainer Dario Solares – Phenylbutazone**

Trainer Dario Solares appeared in the steward's office, having waived his right to a formal hearing, to address California Horse Racing Board Complaint #08-SW0117 'Bute Overage' on the horse "Cherry Tree Kate" who raced on November 26, 2008 and subsequently, tested high (5.54 ug/ml). Also in attendance were the Board of Stewards (Baker, McLaren and Oke) along with Supervising Investigator Greg Fabbri and California Horse Racing Board Veterinarian Dr. Robert Goodbary.

Trainer Solares admitted his culpability in this matter and reviewed his medication procedures with Dr. Goodbary. More to follow.

12/27/08 (4) **Qualifying Races**

At 4:30 p.m. two (2) qualifying races were held under the supervision of Stewards Baker and McLaren. In these events nine (9) of eleven (11) participants were successful in their qualifying efforts.

12/27/08 (5) **Eighth Race – Driver Objection/No Change**

At the conclusion of Race #8, the driver of #8 "Adora" (Jason Ricco), the third (3rd) place finisher in this event, lodged an 'objection' against #3 "The Situation" (Gilbert Garcia-Herrera), the second (2nd) place finisher, for interference in the stretch. After viewing films and speaking with the drivers involved, the stewards unanimously concluded that the incident did not cost #8 an opportunity for a better placing, thus no change.

12/27/08 (6) **Tenth Race – Driver Objection/Inquiry/Double Disqualification**

At the conclusion of Race #10, the stewards posted the 'inquiry' sign to view two (2) separate incidents in the race. Simultaneously, the driver of #8 "Algebra" (Jason Ricco) filed an 'objection' against #3 "Jane The Brain" (Gilbert Garcia Herrera) alleging interference in the stretch.

In the opinion of the stewards, there were two (2) separate incidents during the stretch drive.

In the first incident, the second (2nd) place finisher #3 "Jane The Brain" (Gilbert Garcia Herrera) 'bears out' throughout the stretch drive causing #8 "Algebra" (Jason Ricco) to check abruptly, costing #8 an opportunity for a better placing, thus the stewards unanimously vote to disqualify #3 and place her fourth (4th) behind #8.

In the second incident, #6 "Charmer" (Jason Maier) shifted out midstretch causing #4 "Sandra Hotspur" to check, costing #4 a chance for a better placing, thus the stewards unanimously voted to disqualify #6 and place her behind #4.

Drivers Herrera and Maier were ordered to film review.
