Proceedings of the Board of Stewards for the period of Monday, January 19, 2009 through Sunday, January 25, 2009. Steward Michael W. "Wayne" Oke was the Reporting and Duty Steward for the enclosed period.

Monday

01/19/09 (1) **Entries for January 22, 2009**

The racing office was open today with the purpose of filling a card for Thursday January 22nd.

Eleven (11) races, made up of eighty seven (87) horses, are scheduled to be contested. Scratch time is tomorrow at 9:00 a.m.

01/19/09 (2) **Dark Day**

Tuesday01/20/09 (1) **New "P" Driver**

"P" Driver Sean Smithpeters was listed on two (2) horses on Thursday's overnight. This individual was completely unknown to the Board of Stewards and was not licensed in California.

Upon further checking it was discovered that this individual had been granted a provisional license by the stewards at Balmoral Park in January 2009. To this date, Mr. Smithpeters has never driven in a pari-mutuel event in any jurisdiction. After conferring with another member of the Board of Stewards, Mr. Smithpeters was informed he would be required to drive in qualifying events before being allowed to participate in pari-mutuel events. Based on this decision, Mr. Smithpeters was approved for a "Q" (qualifying) license. Mr. Smithpeters grudgingly accepted the steward's decision.

01/20/09 (2) **Scratch Time – Friday 01/22/09**

At scratch time for Thursday's program there were six (6) driver changes.

01/20/09 (3) **Entries and Draw for Friday 01/23/09**

Entries were taken and draw conducted for Friday's card. One hundred seventeen (117) horses were drawn to compete in fifteen (15) races. Scratch time is tomorrow at 9:00 a.m.

In addition, seven (7) races were drawn for Saturday's card.

01/20/09 (4) **Dark Day****Wednesday**01/21/09 (1) **Scratch Time for Friday 01/23/09**

At scratch time there were nine (9) driver changes.

01/21/09 (2) **Entries and Draw for Saturday 01/24/09**

Entries were taken and the draw concluded for Saturday's program. At the 10:20 a.m. draw one hundred fifteen (115) head were programmed to compete in fifteen (15) races. Scratch time is tomorrow at 9:00 a.m.

01/21/09 (3) **Trainers Test**

Licensee James Kennedy, who is currently licensed as a driver, took the trainers test under the supervision of the duty steward. Kennedy was successful in his test and will be assembling a small stable. The Board of Stewards wish him well.

01/21/09 (4) **Dark Day**

- 01/22/09 (1) **Scratch Time for Saturday 01/24/09**
At scratch time there were eleven (11) driver changes.
- 01/22/09 (2) **Qualifying Entries**
Entries were taken and a qualifying sheet was produced showing nineteen (19) head competing in four (4) qualifying events with first post at 4:30 p.m.
- 01/22/09 (3) **Qualifying Races Postponed**
The qualifying races scheduled for 4:30 p.m. were postponed due to inclement weather.
- 01/22/09 (4) **Track Condition – Good/Clean Card**
Afternoon rains resulting in the qualifying races being postponed and a track condition listed as ‘good’. With the exception of a third race ‘inquiry’ in which second (2nd) place finisher “Sintillating” (T. Maier) was in close quarters with fourth (4th) place finisher “Crazy Cathy” (Bruce Clarke) were observed to be in close quarters. After reviewing film and speaking with the drivers involved, the stewards unanimously concluded there were no rule violations, thus no change.

- 01/23/09 (1) **Qualifying Races – Track Condition – Sloppy**
Qualifying races were conducted on a track listed as ‘sloppy’, with a two (2) second allowance. These events, under the supervision of Stewards Baker and McLaren, resulted in ten (10) of thirteen (13) participants being successful in their qualifying efforts.
- 01/23/09 (2) **Hearing Postponed**
As a result of the postponement of the qualifying events from the previous day, three (3) formal hearings scheduled for today have been rescheduled for Wednesday, February 04, 2009. These hearings are to be held at California Horse Racing Board Headquarters.

01/23/09 (3) **Second Race – Inquiry/Change**

At the conclusion of Race #2 the stewards lit the ‘inquiry’ sign to investigate an incident in the last turn when fifth (5th) place finisher #2 “Peddle On The Right” (James Kennedy) was observed inside multiple pylons in the last turn. After viewing films, the stewards disqualified #2 and placed him sixth (6th).

01/23/09 (4) **Ninth Race – Inquiry/Change**

At the conclusion of Race #9 the stewards lit the ‘inquiry’ sign to investigate an incident approaching the 1/2 mile marker when #3 “Pips Jenny G” (David Siegel) broke stride and while ‘offstride’ impeded the progress of #7 “Laissez Faire N” (Tim Maier). After viewing film, the stewards disqualified seventh (7th) place finisher #3 “Pips Jenny G” and placed her eighth (8th) for ‘causing interference while on break’.

First Race – Inquiry/Change

At the conclusion of Race #1 the stewards flashed the ‘inquiry’ sign to investigate an incident past the 3/4 mile marker when the eventual fourth (4th) place finisher #1 “Top Site” (Steve Desomer) was observed inside multiple pylons. After viewing films, #1 was disqualified and placed sixth (6th) for ‘violation of the pylon rule’.

Fourth Race – Inquiry/No Change

After viewing films and speaking with the drivers involved, the stewards unanimously concluded there were no rule violations, thus no change.

Thirteenth Race – Inquiry/Disqualification

The stewards flashed the ‘inquiry’ sign to investigate an incident approaching the wire when #1A “Anns Nestegg” (L. Plano) and #4 “Edgar Allen Coe” (L. Svendsen) were offstride and continued ‘offstride’ through the finish. After viewing films the stewards disqualified fourth (4th) place finisher #1A and placed her sixth (6th) for violation of the breaking rule. The stewards concluded that #4 complied with the breaking ruled, thus no change.
