02/10/09 (2) **Entries and Draw/Friday 02/13/09**

Entries were taken and a draw conducted for Friday's program. At the 1:15 p.m. draw, one hundred sixteen (116) head were programmed to compete in fifteen (15) races.

02/11/09 (2) **Entries and Draw/Saturday 02/14/09**

Entries were taken and a draw conducted for Saturday's program. At the 11:00 a.m. draw one hundred nineteen (119) head were drawn to compete in fifteen (15) races.

02/11/09 (3) **Un-Raced Entrants**

Despite carding forty two (42) races over the three (3) day week, fifteen (15) horses, which were entered to race, were not afforded the opportunity.

02/11/09 (4) **Informal Meeting/Big Fresno Fair**

A delegation from "The Big Fresno Fair" was present on the backstretch this morning, meeting informally with horsemen in order to familiarize horsemen with their facility. Also to gather information for their own use in formulating a proposal to host harness racing at their venue.

02/12/09 (2) **Qualifying Entries & Sheet**

On the qualifying card there are twenty three (23) horses scheduled to compete in four (4) qualifiers.

02/12/09 (3) **Qualifying Races**

Four (4) qualifying races were conducted commencing at 4:30 p.m. under the supervision of Stewards Baker and McLaren. In these events, sixteen (16) of twenty three (23) participants were successful in their qualifying efforts. These events were conducted over a track rated "good" with a one (1) second time allowance.

- 02/12/09 (5) **Fourth Race – Claim**
6 “Boo Coo Blush” was claimed by Phylis Crescenti from Robert J. Johnson for Six Thousand (\$6,000) Dollars. The new trainer will be Richard Dunneback.

- 02/13/09 (1) **Trainer Frank Petrelli/CHRB Complaint #09SW-0013**
The stewards were presented with a negotiated settlement in the aforementioned complaint.
- The stewards reluctantly accepted the settlement, citing a lack of detail. Steward Grant Baker dissented on the settlement (felt an informal hearing should have been convened).
- 02/13/09 (2) **Clean Card/Bad Weather**
The fifteen (15) race card contested over a “sloppy” racetrack with intermittent rain storms was incident free with one minor exception.
- An Inquiry in Race #11 involving the race winner and the fifth (5th) place finisher. The stewards unanimously concluded there was no rule violation, thus no change.
- Otherwise, a clean competitive card with some very close finishes.

02/13/09 (3) **First Race – Claim**
 # 7 “Red Star Engineer” was claimed by Larry and Carol Parlan from Robert M. Murphy for Five Thousand (\$5,000) Dollars. The new trainer will be Ken Kakugawa.

02/13/09 (4) **Tenth Race – Claim**

02/14/09 (1) **Second Race – Inquiry/Change**
 The stewards lit the “inquiry” sign at the conclusion of Race #2 to investigate an incident entering the first turn when #1 “Bankers Babe” (Pierre Girard) appeared to be inside multiple pylons.

After viewing replays, the stewards unanimously concluded that #1 was in fact inside multiple pylons. #1, the fifth place finisher, was disqualified and placed seventh for violation of the pylon rule. Driver Girard was ordered to film review. More to follow.

02/14/09 (2) **Track Condition/Horsemen’s Concerns**
 Track committee member Bob Johnson contacted the stewards after the second race in order to express the horsemen’s concern with the condition of the racetrack. The track was extremely hard and according to the horsemen, had holes in it.

Track Superintendent J.R. Williams was not in attendance and the personnel on site apparently were unsure as to what, if any, remedial action would be appropriate.

Additionally, there were some concerns about a storm which was forecast for the area.

The stewards checked the weather radar and found that the storm was not due in the area until approximately 1:00 a.m.

After Race #4 Trainer Johnson contacted the stewards and stated that the track crew was reluctant to 'cut' the track surface due to the incoming weather so he stated the horsemen "will just have to live with it".

The Board of Stewards have subsequently learned that twelve (12) horses were injured to varying degrees. Injuries that were directly attributable to 'track condition'.

02/14/09 (3) **Fourth Race – Inquiry/No Change**

The stewards posted the 'inquiry' sign to investigate an incident when #4 "Anns Nestegg" (Luke Plano) went off-stride. After viewing film, the stewards unanimously concluded that #4 complied with the breaking rule, thus no change.

02/14/09 (4) **Sixth Race – Inquiry/No Change**

The stewards posted the 'inquiry' sign to investigate an incident at the 3/4 mile marker when #1 "Cherry Tree Mike" (Tim Maier) broke stride and continued off-stride while moving to the outside. #1 regained his stride mid stretch however, in the unanimous opinion of the stewards, #1 was in violation of the breaking rule (extended break and failure to lose sufficient ground while on a break), thus #1, who finished third, was disqualified and placed eighth.

02/14/09 (5) **Eighth Race – Inquiry/No Change**

The stewards lit the 'inquiry' sign at the conclusion of Race #8 to investigate an incident at the start when #9 "Only In California" (Luke Plano) was observed 'off-stride' before and after the start. The stewards unanimously concluded that #9 complied with the breaking rule, thus no change.

02/14/09 (6) **Fifteenth Race – Inquiry**

The stewards posted the inquiry sign following this race to observe an incident approaching the 1/2 mile marker. The stewards noticed several horses shifting. Patrol Judge Bill Vallandingham radioed in with his version of the events. The stewards were looking at possible interference between fourth place finisher #7 "Misdori" (Jason Ricco) and fifth place finisher #8 "OGS Bonnie Scotch" (Rick Plano).

After speaking to both drivers and a film review, the stewards made 'no change' in the order of finish.
