03/02/09 (1) **Field Size Expanded**

Management informed the steward's office that effective with Thursday's program, they wished to go with ten (10) horse fields wherever possible. After polling the other members of the Board of Stewards, the duty steward concurred.

The Board of Stewards retains the option to order outside horses to start from a trailing position during inclement weather, in the interest of safety.

Entries were taken and a draw held for Thursday's card. At the 11:00 a.m. draw, ninety nine (99) horses were drawn to compete in twelve (12) events.

At scratch time there were ten (10) driver changes.

03/03/09 (2) **Entries and Draw for Friday 03/06/09**  
 Entries were taken and a draw held for Friday's card. At the 12:30 p.m. draw, one hundred fourteen (114) head were programmed to compete in fifteen (15) events.

Scratch time is tomorrow at 9:00 a.m.

03/04/09 (1) **Scratch Time - Friday 03/06/09**  
 At scratch time for Friday's card, there were five (5) driver changes.

03/04/09 (2) **Entries and Draw for Saturday 03/07/09**  
 Entries were taken and a draw held for Saturday's program. At the 11:00 a.m. draw one hundred fifteen (115) head were drawn to compete in fifteen (15) races.

Scratch time is tomorrow at 9:00 a.m.

03/04/09 (3) **USTA Trainers Test**  
 Owner Gretchen Smith (recently arrived from Chicago) took her trainer's test under the supervision of the duty steward. More to follow.

03/05/09 (1) **Scratch Time - Saturday 03/07/09**  
 At scratch time there were fifteen (15) driver changes.

03/05/09 (2) **Entries & Qualifying Sheet**  
 Entries were taken and qualifying sheet produced for four (4) qualifying races to be held today at 4:30 p.m. There are twenty three (23) horses scheduled to compete.

03/05/09 (3) **Will Meyers Returns to Cal-Expo**  
 The Cal-Expo Board of Stewards welcomed Veteran Steward Will Meyers Back after an assignment at Los Alamitos. Steward Grant Baker has started a new assignment at Golden Gate Fields.

03/05/09 (4) **Qualifying Races**  
 Four (4) qualifying events were held this evening commencing at 4:30 p.m. These events were held under the supervision of Stewards Meyers and McLaren. In these races, seventeen (17) of twenty three (23) participants were successful in their qualifying efforts.

03/05/09 (5) **Driver Meeting – Driving and Whipping Rules**  
 Steward Wayne Oke met with California Harness Horsemen's Association Representative Jim Perez and a group of the drivers to discuss the proposed driving and whipping rules.

Four (4) of the six (6) drivers were quite strong in their opinion that these changes were not necessary and could be potentially harmful to the industry.

03/05/09 (6) **Eighth Race – Incident Before the Start**

As the horses were coming to the gate for Race #8, #5 “Pedal On The Right” (Gene Vallandingham) broke stride and was ‘hooked’ from behind by #4 “Look Left N” (Luke Plano). The resulting collision unseated Driver Vallandingham, who was thrown to the track. Driver Vallandingham, who was unconscious briefly, was transported to the hospital for evaluation. #5 was scratched by the stewards. Accident report to follow.

The tests revealed a concussion and Gene was sent home to rest until Monday. His two (2) drives on tonight’s card will be handled by substitute drivers.

03/06/09 (2) **Meeting Postponed**

A meeting between the Board of Stewards, Dave Elliott and Joe Nefsky of Cal Expo, scheduled for 4:30 p.m. today, was postponed. The purpose of the meeting was to discuss Mr. Elliott’s concerns with certain entries in the steward’s minutes. The meeting was postponed when Mr. Elliott was unable to attend due to other commitments. The stewards are awaiting word from Mr. Elliott as to a suitable date to reschedule the meeting.

03/06/09 (3) **Second Race – Timer Malfunction**

As the field passed the 3/4 mile marker, the infield timer reset. The times on the monitors remained. The timer was reset and functioned properly for the remainder of the card.

03/06/09 (4) **Third Race – Inquiry/Disqualification**

The inquiry sign was lit at the conclusion of Race #3 when #4 “Revenator” (Steve Hyman) broke stride midstretch and continued ‘off stride’ through the finish.

After reviewing films, the stewards disqualified #4 who finished fourth (4<sup>th</sup>) and placed #4 seventh (7<sup>th</sup>) for violation of the breaking rule.
