Proceedings of the Board of Stewards for the period of Monday, April 11, 2011 through Sunday, April 17, 2011. Steward Michael W. "Wayne" Oke was the Reporting and Duty Steward for the enclosed period.

04/11/11 (1) **Entries & Draw for Current Week's Races (Thursday, Friday, Saturday)**

The race office was open this morning, accepting entries for the week's racing programs.

At the 11:15 a.m. draw for Thursday's card, seventy six (76) head were drawn to compete in ten (10) races.

Scratch time is Tuesday at 9:00 a.m.

04/11/11 (2) **Dark Day**

04/12/11 (1) **Scratch Time for Thursday 04/14/11**

At scratch time for Thursday's card there were eight (8) driver changes and one (1) injured scratch.

04/12/11 (2) **Draw for Friday and Saturday's Cards**

At the 12:30 p.m. draw for Friday's card, one hundred thirteen (113) head were drawn to compete in fourteen (14) races.

Immediately following, a draw was held with one hundred eleven (111) head drawn to compete in fourteen (14) events.

Scratch time is Wednesday at 9:00 a.m. for both cards.

04/12/11 (3) **Amateur Driving Series**

Part of the draw for Friday and Saturday's cards consisted of four (4) races on each card for horses to be driven by amateurs.

An excellent illustration of cooperation between trainers and race office personnel in filling eight competitive fields.

04/12/11 (4) **Dark Day**

04/13/11 (1) **Scratch Time for Friday and Saturday's Cards**

At scratch time for Friday's card there were multiple driver corrections and one (1) injured scratch.

Similarly, for Saturday's card there were multiple driver corrections and one (1) claiming price correction.

04/14/11 (1) **Formal Hearing - Financial Complaint**

CHRB Case #115SW-0014, 115SW-0015 & 115SW-0016

The hearing in the above matters was opened, the complaints entered on the record and it was formally noted that all of the respondents failed to appear; thus the hearing was continued. More to follow.

04/14/11 (2) **First Race – Recall**

Starter Bill Vallandingham called a "Recall" after #3 "Swing Vote" (Richard Wojcio) suffered broken equipment (head pole) before the start. Repairs were made, the field was reformed and the second attempt at a start went off with no problems. The incident caused approximately a five (5) minute delay.

The wagering was erroneously stopped by "Sportech" personnel. Sportech has been requested to submit a letter of explanation. More to follow.

04/14/11 (3) **Second Race – No Show Wagering**

As a result of the late injured scratch of #5 "Sweet Treats", trained by Tim Maier, show wagering was cancelled on this race.

04/14/11 (4) **Fifth and Sixth Race – Tote Problems**

The tote system experienced intermittent problems during Races 5 and 6. Sportech personnel instituted corrective measures and the remainder of the evening program was completed with no further problems.

At all times the video monitors displayed correct and current information.

04/14/11 (5) **Sixth Race – Inquiry/No Change**

The 'inquiry' sign was posted to determine the status of breaking horses in the race. Specifically, #6 "Final Chapter" (Richard Wojcio, 7th) and #8 "Exquisite Gem (Gene Vallandingham, 3rd).

After reviewing film, the stewards unanimously concluded that the breaking horses complied with the breaking rule, thus no change.

04/15/11 (1) **Third Race – Recall**

Prior to the start of Race #3, Starter Bill Vallandingham called a recall because #7 “KD Nichol” (Keith Willey), coming to the starting gate ‘out of position’.

After reforming the field, the second attempt at a start went off with no problems.

Delay – approximately three (3) minutes.

04/15/11 (2) **Third Race – Driver to Film Review**

At the conclusion of Race #3, Driver Keith Willey was contacted by the stewards.

Driver Willey accepted full responsibility for the incident, which caused the ‘recall’.

In light of these facts, the stewards issued the following ruling:

Ruling # 36

Driver Keith Willey, who drove “KD Nicol” in the Third Race on April 15, 2011 at Cal Expo, California, is hereby fined One Hundred (\$100) Dollars for violation of California Horse Racing Board Rule #1731 (D) (Driver Infractions – Come to Gate Out of Position - Necessitating Recall).

04/15/11 (3) **Driver Illness – Excused**

Driver James Kennedy contacted the stewards at the conclusion of Race #3, stating that he was suffering from an “intestinal disorder”.

Driver Kennedy was excused from his remaining drives and substitutes were named: 6th Race - #2 Tony Succarotte; 8th Race - #2 James Lackey; 9th Race - #2 Tony Succarotte; 10th Race - #7 Scott Cisco; 11th Race - #3 Tony Succarotte; 14th Race - #8 James Lackey

04/15/11 (4) **Ninth Race – Tote Problems**

While the results for Race #9 were being posted on the ‘infield tote board’, the intermittent tote problems flared up, yet again.

Ruling # 34

Owner Mary Morrison (DBA JMS Racing Stable), having failed to respond to written notice to appear before the Board of Stewards at Cal-Expo on or before April 14, 2011, is hereby Suspended for violation of California Horse Racing Board Rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board Rules #1876 (Financial Responsibility - Training Fees Owed to Marco Rios). During the term of suspension all licenses and license privileges of Mary Morrison are suspended and pursuant to California Horse Racing Board Rule # 1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

Ruling # 35

Owner Elizabeth Foley, having failed to respond to written notice to appear before the Board of Stewards at Cal-Expo on or before April 14, 2011, is hereby Suspended for violation of California Horse Racing Board Rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board Rules #1876 (Financial Responsibility - Training Fees Owed to Marco Rios). During the term of suspension all licenses and license privileges of Elizabeth Foley are suspended and pursuant to California Horse Racing Board Rule # 1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

04/16/11 (2) **Driver Film Review – Tony Succarotte – Ref: 04/15/11 (5)**

Driver Succarotte attended film review, as requested, to review his drive in Race #11 on 04/15/11.

Driver Succarotte entered the office with a very negative attitude, which did not improve throughout the course of the film review.

Upon conclusion of the review, the stewards issued the following ruling and strongly suggested to Driver Succarotte he not only alter his driving habits, but also his attitude.

Ruling # 37

Driver Tony Succarotte, who drove “Adora” in the Eleventh Race on April 15, 2011, is hereby fined the sum of One Hundred (\$100) Dollars for violation of California Horse Racing Board Rule #1530 (Cases Not Covered – Violation of ‘Cal-Expo House Whipping Rule’ – (4)(A) Any Blatant or Exaggerated Movements of the Whipping Arm Which Will Result From Raising the Elbow Above the Driver’s Shoulder Height and/or Allowing the Hand Holding the Whip to Reach Behind the Driver During the Use of the Whip).

04/16/11 (3) **Fifth Race – Inquiry/No Change**

The ‘inquiry’ sign was posted to review the stretch drive when #7 “Satire” (Lemoyne Svendsen), the eventual race winner, and #5 “Star Time Kid” (Luke Plano, 2nd) were in very close quarter in the stretch.

#7 prevailed in a very close finish.

The stewards unanimously concluded that #4 appeared to bother #7 near the wire. As #7 finished first (1st), no change was necessary.

Driver Plano was held blameless in the incident.

04/16/11 (4) **Amateur Driving Series**

The team of amateurs from the East prevailed in a very closely contested series of eight (8) races, conducted on Friday and Saturday's cards.

Of particular note was a very gracious example of sportsmanship, when David Siegel of Team West relinquished his drive in Saturday's 12th Race (the final event of the series) to a member of Team East (Simeon Hunsdon) after two (2) of Team East's drives in the race were late injured scratches.
