Outrider/ Driver Discussion

Outrider Billy Don Wainscott and Driver Williams Hernandez met with the Stewards before the first today. Outrider Wainscott told the Stewards that Driver Hernandez was training a horse 'the wrong way' at a high rate of speed earlier this week. Hernandez told the Stewards "other people do it." The Stewards told Hernandez that Outrider Wainscott supervises training on the racetrack and that he will determine what is 'too fast.' Warning issued.

David Siegel Film Review [Ref: 10/18/17 (7)]

Driver David Siegel appeared in the Stewards office in order to review his drive of #7 'I'm An Athlete' who finished first in the fifteenth race on Saturday, October 18th. Driver Siegel survived a Stewards inquiry in this race when he 'cut the corner' by racing inside one (1) trackside pylon after the ¾ mile marker. He accepted responsibility for mistakenly leaving the main course. In a unanimous vote the following ruling was issued:

RULING # 03

DRIVER DAVID SIEGEL, WHO DROVE "I'M AN ATHLETE" IN THE FIFTEENTH RACE ON SATURDAY OCTOBER 18, 2014 IS HEREBY FINED THE SUM OF FIFTY (\$50.00)* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1721 (K) (DRIVING RULES – CARELESS DRIVING – RACED INSIDE A PYLON ENTERING THE STRETCH).

Tenth Race Inquiry/ Disqualification

The Stewards posted the inquiry sign after viewing fifth place finisher #4 "Flight of the Kiwi" (Daniel Gassien) make a break in stride with 1/16th of a mile left to trot. After film review, in a unanimous decision, the Stewards disqualified #4 "Flight of the Kiwi" and placed him eighth for violation of California Horse Racing Board Rule #172 (Breaking).
