DRIVER TIM MAIER, WHO DROVE “EARLY BOY” IN THE SEVENTH RACE ON APRIL 12, 2015, IS HEREBY FINED THE SUM OF FIFTY (\$50.00)* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1731 (G) (DRIVER INFRACTIONS – FAIL TO COME UP INTO POSITION).

The above ruling was issued after Maier accepted the penalty for being off the gate.
