The Board of Stewards reviewed the compliance with the California Horse Racing Board Rulings #24, #25, #26, #27, and #28 by the licensees repayment of purse monies received ordered in those rulings. After being advised that there had not been any compliance with those rulings, the Board of Stewards voted unanimously to issue Rulings #35 to Raynor W. Marsland Jr., #36 to Marissa Tyler, #37 to Jennifer Petrelli, #38 to Owen Eiler Jr., and #39 to Frank Petrelli which state:

RULING #35

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITHHELD). OWNER **RAYNOR W. MARSLAND JR.**, IS HEREBY ISSUED A FULL AND INDEFINITE SUSPENSION FOR FAILURE TO ABIDE BY THE TERMS OF CALIFORNIA HORSE RACING BOARD WATCH AND WAGER LLC – CAL EXPO RULING NUMBER **#24 AND #25, DATED FEBRUARY 21, 2016.**

SAID SUSPENSION TO REMAIN IN FULL FORCE AND EFFECT UNTIL THE LICENSEE IS IN FULL COMPLIANCE WITH THE TERMS OF SAID RULINGS.

DURING THE TERM OF THE SUSPENSION ALL LICENSE PRIVILEGES OF **RAYNOR W. MARSLAND JR.** SHALL REMAIN SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE **#1528** (JURISDICTION OF STEWARDS) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

RULING #36

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITHHELD). OWNER/TRAINER **MARISSA TYLER**, IS HEREBY ISSUED A FULL AND INDEFINITE SUSPENSION FOR FAILURE TO ABIDE BY THE TERMS OF CALIFORNIA HORSE RACING BOARD WATCH AND WAGER LLC – CAL EXPO RULING NUMBERS **#24, #25, #26, #27, AND #28, DATED FEBRUARY 21, 2016.**

RULING #37

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITHHELD). OWNER **JENNIFER PETRELLI**, IS HEREBY ISSUED A FULL AND INDEFINITE SUSPENSION FOR FAILURE TO ABIDE BY THE TERMS OF CALIFORNIA HORSE RACING BOARD WATCH AND WAGER LLC – CAL EXPO RULING NUMBERS #24, #26, #27, AND #28, DATED **FEBRUARY 21, 2016**.

OWNER **OWEN EILER JR.**, IS HEREBY ISSUED A FULL AND INDEFINITE SUSPENSION FOR FAILURE TO ABIDE BY THE TERMS OF CALIFORNIA HORSE RACING BOARD WATCH AND WAGER LLC – CAL EXPO RULING NUMBERS #26 AND #28, DATED **FEBRUARY 21, 2016**.

SAID SUSPENSION TO REMAIN IN FULL FORCE AND EFFECT UNTIL THE LICENSEE IS IN FULL COMPLIANCE WITH THE TERMS OF SAID RULINGS.

DURING THE TERM OF THE SUSPENSION ALL LICENSE PRIVILEGES OF **OWEN EILER JR.** SHALL REMAIN SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

Sunday03/13/16 (1) **Starter's List Discussion**

The Horsemen's Representative, Robin Clements had requested a brief meeting with the Board of Steward's and with the Starter, Kenneth Fowler to discuss what situations may cause a horse to be placed on the Starter's List. A brief productive meeting was held to discuss this topic.

03/13/16 (2) **Film Review with Driver Plano**

Film review was conducted with Driver Luke Plano of sixth race conducted at Cal Expo on February 27th, 2016. Driver Plano apologized for losing his temper at another driver at the finish of this race. Driver Plano took full responsibility. Driver Plano also explained that he had decided that "I'M SO BLUE" should not be encouraged through use of the whip at the finish as the horse was exhausted. Upon further review the Stewards accepted Driver Plano's explanation. Driver Plano was warned that this type of behavior should not happen again.

03/13/16 (3) **Claim Disallowed**

In the fourth race there were two claims filed on "WINDSUN T BIRD." One of those claims was filed by Nicki Hudson of Sacramento. Ms. Hudson is the wife of WINDSUN T BIRD's program Trainer, Luke Plano. The Board of Stewards unanimously decided to disallow this claim per CHRB rule 1652 (b) and 1420 (n) as it would be a violation to claim a horse trained by yourself. The other claim was filed by Robin Clements and this claim was allowed.

03/13/16 (4) **Fifth Race/Driver Violation**

Driver Edward Hernandez who drove #4 "KG CODY" drove back into the Paddock after coming out onto the track for the Fifth race and participating in the post parade. The Stewards were advised that Driver Hernandez went into the Paddock to spray off the mud apron on his race bike and the horse. Mr. Hernandez was advised to come to the Stewards office on Saturday, March 19th to discuss this. More to follow.

03/13/16 (5) **Fifth Race/ Inquiry**

#6 "MIGHTY FINE HI HO" broke from the top of the stretch and through the wire. After reviewing video of the race the Stewards unanimously decided to place #6 "MIGHTY FINE HI HO" from his sixth place finish to eighth for violation of the breaking rule.

03/13/16 (6) **Eleventh Race/ Driver Film Review**

Driver Richard Schneider who drove #2 "CHIEF SARATOGA" to a sixth place finish was summoned to film review on Saturday, March 19th, for possible violation of the Cal-Expo whipping rule.

03/13/16 (7) **Twelfth Race/ Inquiry**

#1 "LIVE A LITTLE" broke stride after the start of the race and finished third. An Inquiry was held to review the video of this incident. The Board of Stewards unanimously decided that "LIVE A LITTLE" (Driver Mark Kennedy) did comply with the Breaking Rule and no change was warranted.
