After reviewing film it was unanimous decision of the Stewards that no violation occurred. Thus no change in the original order of finish.

After film review the Stewards unanimously concluded that a warning was in order. However, Driver Kennedy was placed on probation and any further Whipping Rule violations will result in "days."
