01/14/17 (3) **Track Condition**

The track condition for tonight’s fourteen (14) race program was rated fast.

01/14/17 (4) **Seventh Race - Recall**

Starter Ken Fowler recalled the start of race seven (7) after he thought #7 “Goodtobeking” scored out of position. The recalled caused a mechanical problem with one of the wings. Horses were directed to return to the paddock until the repair was made. After a lengthy delay the race was off at 8:49PM.

01/14/17 (5) **Twelfth Race – Inquiry – Disqualification**

Williams Hernandez, while driving #1 “Fast Lane Ferrari” finished first and appeared to go inside the pylons during the stretch drive. After a review of the race and head-on camera view it was determined that “Fast Lane Ferrari’s” left sulky wheel did go inside two (2) pylons. That allowed her to gain an unfair advantage over other horses. #1 “Fast Lane Ferrari”, who finished first, was disqualified and placed third. Driver Hernandez was notified to appear in the Stewards office on Friday, January 20th to review his drive.

01/14/17 (6) **Fourteenth Race – Possible Whip Violation**

During the stretch drive Mike Jarvis, while driving #4 “At Last” may have been in violation of the “whipping rule.” He was directed to appear in the Stewards office Friday, January 20th to review his drive.
