RULING # 3

PROVISIONAL DRIVER **EDWARD HERNANDEZ**, WHO DROVE “**PICTURETHISALESHIA**” IN THE THIRD RACE ON FRIDAY, NOVEMBER 17, 2017 IS HEREBY FINED THE SUM OF ONE HUNDRED (**\$100.00**)* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #**1734 (D)** (WHIPPING – DRIVERS MAY NOT USE THE WHIP MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND.) FIRST OFFENSE IN LAST SIXTY (60) DAYS.
