DRIVER **TERRY KAUFMAN**, WHO DROVE #1 “**HE’S DONE IT ALL**” IN THE TWELFTH RACE ON SATURDAY, MARCH 31, 2018 IS HEREBY FINED THE SUM OF ONE HUNDRED (**\$100.00**)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1734 (**D**) (WHIPPING – DRIVERS MAY NOT USE THE WHIP MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND.) FIRST OFFENSE IN LAST SIXTY (60) DAYS.

Late Declaration - #5 “BANKERS FOR ALL” – Trainer Earl Kennedy – Stewards Track Condition.

**RULING # 30**

DRIVER **RICHARD REMILLARD**, WHO DROVE #1 “COSMOS” IN THE SIXTH RACE ON FRIDAY, APRIL 6, 2018 IS HEREBY FINED THE SUM OF ONE HUNDRED (**\$100.00**)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1734 (D) (WHIPPING – DRIVERS MAY NOT USE THE WHIP MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND). FIRST OFFENSE IN LAST SIXTY (60) DAYS.

- 04/07/18 (2) **Qualifiers**  
One (1) qualifying race was held prior to the regularly scheduled races at 5:45PM. Five (5) horses went postward on a track rated “fast.” Five (5) of the five (5) horses met the qualifying time. ONCE AGAIN, the timer malfunctioned, so the race was timed manually from the video replay. It was thought that perhaps the abundant sunshine may have had something to do with the malfunction as the timer worked properly for the remainder of the night.
