There were numerous driver corrections and no scratches.

The Stewards office was open to take changes for Saturday night card. Several driver changes and no scratches.

11/30/18 (1) **Race office/Qualifying entries**
Entries this morning for the qualifiers to be held prior to the regular scheduled races of Saturday with two (2) races scheduled at 5:15 P.M. Seven (7) Of the ten (10) participants met the qualifying standards.

11/30/18 (2) **Second Race Inquiry with Placing**
The Stewards posted the inquiry sign following the finish of the second race #6 "SILVERHILL VOLO" driver James Lackey first place finisher, for possible violation of the Watch and Wager pylon rule. After film review The Stewards unanimously agreed that the horse went inside two (2) pylons in the last turn. The horse was lapped on by the second-place finisher and was therefore disqualified and placed second.

11/30/18 (3) **Ninth Race Whipping Violation**
Driver Edward Hernandez who drove #4 "LAISSEZ MOI PASSER" was informed he was being cited for violation of the California Horse racing Board Rule #1734 (d). Whipping. Drivers first offense in sixty (60) days One Hundred (\$100.00) dollar fine.

DRIVER **EDWARD HERNANDEZ**, WHO DROVE "LAISSEZ MOI PASSER" IN THE NINTH RACE ON FRIDAY, NOVEMBER 30, 2018 IS HEREBY FINED THE SUM OF ONE HUNDRED (**\$100**) * DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1734(D) (WHIPPING-DRIVERS MAY NOT USE THE WHIP MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND.) FIRST OFFENSE IN LAST SIXTY (60) DAYS.
