Groom Lisa Marie Magnussen appeared before the stewards regarding the hearing held on January 10th, regarding Complaint #18SW0048. Ms. Magnussen was informed of the Steward's unanimous decision and the following ruling was written:

RULING # 5

LICENSEE LISA MARIE MAGNUSSEN IS SUSPENDED FOR TWO HUNDRED AND EIGHTY (280) DAYS (JANUARY 23, 2019 THROUGH AND INCLUDING OCTOBER 31, 2019) FOR VIOLATION OF THE FOLLOWING CALIFORNIA HORSE RACING BOARD RULES:

CALIFORNIA HORSE RACING BOARD RULE #1489 (a) (8) (GROUNDS FOR DENIAL OR REFUSAL TO LICENSE)(ENGAGED IN THE USE OF PROHIBITED DRUGS). CALIFORNIA HORSE RACING BOARD RULE

#1900 (GROUNDS FOR SUSPENSION OR REVOCATION). CALIFORNIA HORSE RACING BOARD RULE **#1874** DISORDERLY CONDUCT (INFLUENCE OF METHAMPHETAMINE). CALIFORNIA HORSE RACING BOARD RULE **#1890 (a)** POSSESSION OF CONTRABAND (METHAMPHETAMINE). CALIFORNIA HORSE RACING BOARD RULE **#1902** CONDUCT DETRIMENTAL TO HORSE RACING.

MS. MAGNUSSEN IS REQUIRED TO SUCCESSFULLY PARTICIPATE IN CHEMICAL DEPENDENCY TREATMENT. DOCUMENTATION OF SUCCESSFUL TREATMENT PARTICIPATION SHALL BE PROVIDED TO THE CALIFORNIA HORSE RACING BOARD STEWARDS PRIOR TO REINSTATEMENT.

DURING THE TERM OF THE SUSPENSION ANY AND ALL LICENSES AND LICENSE PRIVILIGES OF LISA MARIE MAGNUSSEN ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE **#1528** (JURISDICTION OF STEWARDS TO SUSPEND OR FINE). SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION. LICENSEE LISA MAGNUSSEN WILL VACATE ALL TACKROOMS.
