Ruling Written

The following ruling was written after an informal hearing had been conducted with Licensee Linda Bloom on January 10, 2019 and subsequent communications with Ms. Bloom were unsuccessful.

RULING NO. 6

In the Matter of:
 Associate Employee Linda C. Bloom

Linda C. Bloom is hereby suspended for the term of her license, through March 31, 2021. Pursuant to California Horse Racing Board rule #1900 (Grounds for Suspension or Revocation) for violation of California Horse Racing Board rules #1874 (Disorderly Conduct), #1489 (8) (Grounds for Denial or Refusal of license-Possession of Methamphetamine and Marijuana), #1890 (a) Possession of Contraband (Methamphetamine For Sale), #1890 (a) Possession of Contraband (Hypodermic Needles and Syringes), and #1902 (Conduct Detrimental to Horse Racing).

Prior to the re-instatement of her license privileges Ms. Bloom must show proof of completion of a chemical dependency program acceptable to the Board of Stewards.

During the term of this suspension, all licenses and license privileges of Linda C. Bloom are suspended and pursuant to California Horse Racing board rule #1529 (Jurisdiction of Stewards) subject is denied access to all premises in this jurisdiction.
