One qualifying race was held prior to the regularly scheduled races at 5:00 P.M. Five (5) horses went postward on a track rated fast. All five (5) of the entries met the qualifying time.

Two (2) Three (3) year old California Sired pacing fillies competing for a purse of Six thousand five hundred (\$6,500.00) dollars with a post time of 5:15 P.M.

Four (4) three (3)year old California Sired pacing colts and geldings going for a purse of Six thousand five hundred (\$6,500.00) dollars with a post time of 5:30 P.M.

03/15/19 (5) **Non Wagering / Sire Stakes**

Two (2) three (3) year old California sired trotting colts competing for a purse of Six thousand five hundred (\$6,500.00) with a post time of 5:30 P.M.

The track timer malfunctioned again during the first two (2) California Sired Stakes causing the race to be timed by the stewards using the video of the race.

03/15/19 (7) **Fifth Race Inquiry**

The inquiry sign was posted for the fifth (5) race concerning a possible interference violation by the first (1) place finisher #4 Brushing Albert before the half. Possible hooking wheels with #5 "I Will Score" finishing Seventh (7). After film review the Stewards unanimously agreed there was no interference violation and the original order of finish stands.
