Ruling No. 33

In the Matter Of:

Trainer Jessie L. Pacheco

Trainer Jessie L. Pacheco, trainer of the horse "JOHNNY GUN", winner of the seventh race at Cal Expo on March 29, 2019, is hereby fined the sum of One Thousand Five Hundred Dollars (\$1,500.00) pursuant to California Horse Racing Board rule #1887 (a) (Trainer or Owner to Ensure the Condition of Horse), for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances) and #1844 (c) (1) (Authorized Medications-in excess of 2 mcg/ml Phenylbutazone 3.12 ug/ml). Second offense within 365 day period.
