4th race, had Seven (7) entries, Seven (7) starters no driver changes, #3 AHEAD BY A CEBTURY add lasix, no scratches, #7 CENALTA SUNRISE ran up on the wheel of #5 GLITTER AND GINGER causing #7 CENALTA SUNRISE to go off stride. This appeared to be the fault of the horse CENALTA SUNRISE not the driver Phil Knox. We met with Phil Knox the next day and confirmed our suspicions.
