Hearing for Robin Clements. Three stewards, Renee Sheward, Rod Newhart, and Rich Williams were present with a court reporter. Testimony was heard from Robin Clements and Dr. De La Cruz. The Stewards reached a decision of a Five Hundred (\$500.00) \* dollar fine with no suspension mitigated by this being her first offense and aggravated by the levels being higher than was allowed prior to the rule changes.

**Ruling #06**

Trainer ROBIN SUE CLEMENTS, who qualified the horse MARCED MAGIC, on Saturday, November 2, 2019 and having waived her right to a formal hearing is hereby fined the sum of five hundred (\$500.00) dollars for violation of the CHRB rules Rule #1834(a)(d)-Medication, Drugs and other Substances Rule #1843.1 (a)-Prohibited Drug Substances and Rule #1887(a)-Trainer to ensure condition of horse. Sample NC37637 was obtained and submitted to the UC Davis Maddy Laboratory, official testing laboratory of the CHRB board for testing. The official results showed the presence of Triamcinolone Acetonide at the level of 150 pg/ml which is in excess of the allowable threshold of zero tolerance, and is considered a class 4, Penalty class C violation.
