Wednesday

08-27-08¹ **DISQUALIFICATION HEARING** (Case 07SW-0109)

A hearing was postponed today for a possible purse redistribution based on California Horse Racing Board rules #1859.5 (Disqualification Upon Positive Test Finding) and #1760 (Purse Award or Prize to Be Withheld). Prior to opening the hearing, Steward **Grant Baker** noticed that only one of two owners had been notified. The hearing was immediately postponed. Owner **DAVID SHELL** wanted to object to the stewards' jurisdiction in that trainer **PATTY HARRIS** had already opted to have her case heard by the Office of Administrative Hearings. The hearing convened on August 20, 2008 and was postponed until October 20, 2008. Shell contends the owners and trainer should be heard at the same time. The horse in question is a standard bred named BIGGEST BIG BERTHA, who raced at the Sacramento Harness race meet on November 3, 2007 at Cal-Expo. The alleged positive is for the Class 3 drug 4-Hydroxypropranolol, a metabolite of Propranolol.

08-27-08² **RULING NO. 4 – KAENEL**

Jockey **KYLE KAENEL**, who was scheduled to ride **ROCKET PLUS** in the ninth (9th) race on Sunday, August 24, 2008 at the California State Fair, is hereby fined the sum of one hundred dollars (\$100.00) for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

The foregoing ruling was issued after Kaenel accepted the penalty. Kaenel only had one mount in the last race and left San Francisco late and got caught in major traffic.

Thursday08-28-08¹ **RULING NO. 5 – FLORES**

Apprentice Jockey **PABLO FLORES**, who was scheduled to ride EAT MY STARDUST in the third (3rd) race on Wednesday, August 27, 2008 at the California State Fair, is hereby fined the sum of one hundred dollars (\$100.00) for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

The above ruling was issued after **Flores** appeared and accepted the ruling. Flores explained that he misunderstood his agent and thought his mount scratched.

08-28-08² **RULING NO. 6 – RUBIO**

Jockey **FRANCISCO RUBIO**, is hereby fined the sum of one hundred dollars (\$100.00) for failure to fulfill his riding engagements at the

California State Fair on Sunday, August 24, 2008; a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

The above ruling was issued after **Rubio** appeared and accepted the penalty. He had hit the steam box to try and make weight. The effort was unsuccessful as it made him ill and too weak to ride.

08-28-08³ **PETRELLI – PAQUET HEARING** (Cases 07SW-0112; 07SW-0113)

A telephonic hearing was held today concerning a stipulated agreement for standardbred trainer **FRANK PETRELLI**.

Petrelli ran the horse **ONLY IN CALIFORNIA** on November 15, 2007 and the post race urine test indicated presence of the Class II drug substance *Detomidine*. A subsequent barn search turned up several items of contraband.

Petrelli agreed to the stipulated agreement on the record and stated he was also speaking on behalf of owner Jamie Paquet.

The stipulated agreement was accepted on the record by the State and Petrelli. In addition, the purse will be returned. Petrelli will serve thirty days (September 1-30) and pay a \$3,000 fine. Rulings to that effect will follow.

08-28-08⁴ **INQUIRY / ACCIDENT – DISQUALIFICATION – Seventh Race**

The inquiry sign was posted after jockey **Rachel Goodgame** was unseated from her mount #5 DONS SIBERIAN DAME. After review, it was determined that #4 ARONSLITTLESTAR, ridden by **James Wooten**, ducks out shortly after the start and into the path of #5 who clips heels and stumbles, causing Goodgame to fall. #4 was disqualified and placed unplaced for the infraction. **Goodgame** suffered a shoulder injury and was transported to the hospital. The horse appeared uninjured. An accident report will be attached to these minutes.

08-28-08⁵ **INQUIRY – NO CHANGE – Eighth Race**

The stewards posted the inquiry sign to review an incident in the stretch concerning the winner, #3 TAKIN A BREAK (Francisco Duran) and fourth place finisher #1 SEATTLE DELEGATE (Alex Bisono) in the stretch.

#1 steadies in the stretch as #3 drops down in front of that rival. #1 was dying and it was apparent the rider was just being cautious. After talking to the riders, no change was ordered. Bisono confirmed that he was just being cautious on a dying mount.

Friday08-29-08¹ **JOCKEYS IN**

Jockeys **James Wooten** and **Francisco Duran** reviewed races from yesterday's seventh and eighth races in which there were inquiries. **Wooten** was exonerated as this horse ducked sharply with him and he made every effort to avoid yesterday's accident. **Duran** was cautioned to give a little more clearance when dropping to the rail.

08-29-08² **HANDLE DOWN**

The new San Mateo Fair Satellite facility has averaged \$75,000 less per day than the regular Bay Meadows Satellite did for the other fairs according to recent reports.

08-29-08³ **INQUIRY – DISQUALIFICATION – First Race (Mules)**

The stewards posted the inquiry sign to review an incident in the stretch involving the winner, #2 **GUCCIS N DIAMONDS** (Anthony Ayala) and #3 BLACK VELVET (James Wooten) who finished third. After review it was determined that #2 comes out into the path of #3 causing jockey Wooten to check sharply. In a majority decision (Nicolo dissenting) #2 was disqualified and placed third for the interference.

08-29-08⁴ **INQUIRY – DISQUALIFICATION – Second Race (Quarter Horses)**

The stewards posted the inquiry sign to review an incident at the start involving #5 **POWER TO WOW** (Francisco Rubio) and the three horses to his inside. Tapes show #5 breaks in sharply, interfering with #4 FIXINTODASH (G. Arriaga, 5th), #3 EXTRAVEGANT AFFAIR (Barrington Harvey, 6th) and #2 TWO TIMES A DEAL (Alfredo Miranda, 4th). After review #5, who finished second, was disqualified from second and placed sixth for the interference.

Saturday08-30-08¹ **HECTOR ROMERO LICENSE**

HECTOR ROMERO was given an exercise rider license today based on a proposed decision written by Steward **John Herbuveaux** and adopted by the California Horse Racing Board. Romero signed a testing agreement and understood the limitations on his license.

08-30-08² **PETRELLI RULINGS NO. 7 and 8** (Refer 8-28-08³)

NO. 7 Acting upon a finding by the University of California, Davis, Maddy Laboratories, that urine sample #CE-07288, taken from the horse **ONLY IN CALIFORNIA**, the first place finisher in the sixth race at Sacramento Harness, Cal Expo, on November 15, 2007, tested positive for the prohibited substance Detomidine (Class II), it is ordered that **ONLY IN CALIFORNIA** be disqualified from all purse monies earned in said race, pursuant to California Horse Racing Board rule 1859.5 (Disqualification Upon Positive Test Finding).

It is further ordered that the owners of **ONLY IN CALIFORNIA**, Jamie Paquet and Frank Petrelli (\$2,280) and Driver Fern Paquet, Jr. (\$100), return the purse monies listed to the Paymaster of Purses at Sacramento Harness Association for redistribution in accordance with the following revised order of finish:

- 1st – TV MOM
- 2nd – TAG N WIN
- 3rd – JADE'S CORWN
- 4th – PUSSY CAT
- 5th – CHERRY TREE LUKE
- 6th – NV WARLORD

All records shall be changed to reflect this order. Pursuant to California Horse Racing Board rule #1956 (Race Declared Official), this order shall not affect the pari-mutuel payoffs.

NO. 8 Pursuant to a stipulated agreement with the California Horse Racing Board, trainer **FRANK PETRELLI**, who started the horse **ONLY IN CALIFORNIA**, place finisher in the sixth race at Sacramento Harness Cal Expo on November 15, 2007, is suspended thirty (30) days and fined the sum of three thousand dollars (\$3,000) pursuant to California Horse Racing Board Rule 1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rules 1843(a) (c) (d) (Medication, Drugs and Other

Substances – Detomidine [Class II] and 1890 (Possession of Contraband).

The suspension shall be served from September 1, 2008 through September 30, 2008 and during the term of this suspension all licenses and license privileges of Frank Petrelli are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine) subject is denied access to all premises in this jurisdiction.

The above rulings were issued to affirm the stipulated agreements heard Thursday.

08-30-08³ **TRAINER'S PRACTICALS**

Steward Baker proctored a practical test for **Jose Godinez** this morning. Trainer Terri Eaton gave the exam.

Steward Meyers proctored a practical test for **Nona Smith** today. Trainer Dennis Hopkins gave the exam.

Both applicants passed the practical and are now awaiting the veterinarian portion of the test.

08-30-08⁴ **RULING NO. 9 – HOLLENDORFER**

Trainer **JERRY HOLLENDORFER**, who was scheduled to saddle STELLA'S POSADA in the eighth race on August 29, 2008 at the California State Fair, is hereby fined one hundred dollars (\$100.00) for violation of California Horse Racing Board rule 1894 (Duties of Trainer – Failure to saddle horse).

The above ruling was issued after HOLLENDORFER was contacted by phone and accepted the penalty. Apparently his assistant dropped the ball.

08-30-08⁵ **RULING NO. 10 – AYALA**

Jockey **ANTHONY AYALA**, who rode **GUCCIS N DIAMONDS** in the first race at the California State Fair on Friday, August 29, 2008, is suspended three (3) racing days (September 6, 7 and 10, 2008) for failure to make a proper effort to maintain a straight course in mid-stretch and causing interference resulting in the disqualification of his mount from first to third; a violation of California Horse Racing Board rule 1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after AYALA appeared and reviewed the race with the stewards. He was not happy with our decision and felt he made a proper effort on a stubborn mule.

08-30-08⁶ **JOCKEY REVIEW**

Jockey **Francisco Rubio** was in and reviewed yesterday's second race disqualification. Rubio made an admirable effort and the blame was placed on an unruly Quarter horse.

08-30-08⁷ **CERTIFIED REPORTING SERVICE CHANGES**

Capitol Reporters, led by **Esther Schwartz**, has been replaced by Wendy V. Frazier

Reporting. Esther has been a good reliable reporter and friend for many years and will be missed.

08-30-08⁸ **LONGTIME HORSEPERSON LICENSED AS OWNER**

CHERYL BOULLE, former owner and trainer, was given an owner's license today. Supervising Investigator Gregg Fabbri stated that he was obligated under his guidelines to refuse her license for a past conviction even though her probation ended three years ago. Boulle has never had major problems on the racetrack and trained for thirty (30) years. Licensing as an owner is not inimical to the best interest of racing.

08-30-08⁹ **INQUIRY – DISQUALIFICATION – Sixth Race**

The stewards posted the inquiry sign to review an incident in the stretch between #2 **JAMES CREEK RED** (Pablo Flores) and #7 BUEN MOZO (Juan Ochoa) who finished in a dead heat for second place. After talking to the riders and reviewing the tapes, #2 was disqualified from dead heat second to third place. #2, while driving on the inside of #7, comes out repeatedly under left handed whipping, bumping and impeding #7. Apprentice jockey Flores was ordered to the stewards' office.

The stewards posted the inquiry sign to review an incident in the stretch involving the winner, #3 DONE GONE QUACKERS (Pablo Flores) and 2nd place finisher #5 A R RIO BRAVO (Kyle Kaenel). #3 comes in taking the path of #5, causing him to alter course; however, the stewards felt #5's placing was not affected. No Change.

Jockey **JAVIER GOMEZ**, who was scheduled to ride **WILBURS FOLLEY** in the first (1st) race on Friday, August 29, 2008 at the California State Fair, is hereby fined the sum of one hundred dollars (\$100.00) for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

The above ruling was issued after Gomez failed to make his engagement on Friday.

08-31-08² **RULING NO. 12 – ANTON**

Trainer **WILLIAM ANTON**, who was scheduled to saddle GOLAZO in the sixth race on Saturday, August 30, 2008 at the California State Fair, is hereby fined one hundred dollars (\$100.00) for violation of California Horse Racing Board rule #1894 (Duties of Trainer – Failure to saddle horse).

The above ruling was issued after Anton was contacted by phone. He stated he got busy with a sick horse at Pleasanton and dropped the ball. He accepted the penalty with apologies.

08-31-08³ **JOCKEY IN**

Jockey **BARRINGTON HARVEY** reviewed yesterday's seventh race with the stewards and cautioned to give a little more room when dropping in to the rail.

08-31-08⁴ **RULINGS NO. 13 & 14 – FLORES**

NO. 13 Apprentice Jockey **PABLO FLORES**, who rode **JAMES CREEK RED** in the sixth race at the California State Fair on Saturday, August 30, 2008, is suspended five (5) racing days (September 7, 10, 11, 12 and 13, 2008) for altering course without sufficient clearance in the stretch and causing interference resulting in the disqualification of his mount from second to third; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

NO. 14 Apprentice Jockey **PABLO FLORES**, who rode **DONE GONE QUACKERS** in the tenth race at the California State Fair on Saturday, August 30,

2008, is suspended five (5) racing days (September 14, 17, 18, 19 and 20, 2008) for altering course without sufficient clearance in the stretch and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above rulings were issued to young apprentice rider Flores for two separate races yesterday. Flores had served three (3) days recently so five days were given in these instances. Flores is exceptionally polite and shows an eagerness to learn. Steward Nicolo has gone out of his way to help young Flores.

08-31-08⁵ **INQUIRY – DISQUALIFICATION – First Race (Quarter Horse)**

The stewards posted the inquiry to review an incident halfway through this 350 yard dash concerning second place finisher #3 **MYRNAS JAZZ** (Carlos Villalobos) and the two horses to the inside. #3 comes in forcing jockey Gregorio Arriaga aboard #1 CBD GOODEN (6th) and jockey Olivo Maldonado aboard #2 CHECKTHISMEMO to check sharply costing them any chance at a better placing. #3 was disqualified from second and placed sixth. Jockey Villalobos was ordered to see the stewards in the morning.

08-31-08⁶ **MULE RUNAWAY – Second Race**

As the mules were loading, 6/5 favorite #4 GENIE-JONES dumped jockey Olivo Maldonado and ran off the wrong way of the track. He was caught by outrider Billy Don Wainscott and unsaddled at the receiving barn after being scratched. Time was given for patrons to change their wagers and the race was off after a five minute delay.

08-31-08⁷ **INQUIRY / OBJECTION – DISQUALIFICATION – Fourth Race**

The stewards posted the inquiry to review an incident in the stretch involving the winner #3 **NIKI’S LAST SECRET** and second place finisher, #1 LOUIE C (Kyle Kaenel). Kaenel also lodged a claim of foul. After talking to the riders and a film review, #3 was disqualified and placed second. Tapes clearly show #3 duck in sharply as #1 is gaining on his inside which causes jockey Kaenel to check his mount sharply.

Jockey **CARLOS VILLALOBOS**, who rode **MYRNAS JAZZ** in the first race at the California State Fair on Sunday, August 31, 2008, is suspended three (3) racing days (September 10, 11 and 12, 2008) for failure to make a proper effort to maintain a straight course in mid-stretch and causing interference resulting in the disqualification of his mount from second to sixth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Villalobos appeared and accepted the penalty.
