07-13-16<sup>1</sup> **DUTY STEWARD**

07-14-16<sup>1</sup> **DUTY STEWARD**

07-14-16<sup>2</sup> **ENTRIES & DRAW**

Eight races were drawn for Sunday's card consisting of eight Thoroughbred races and one Arabian Stakes race. The draw was completed at 12:30 p.m.

07-14-16<sup>3</sup> **CAL-BRED REPORT**

**Friday**

07-15-16<sup>1</sup> **SCRATCHES**  
Friday scratches were taken at 9:00 a.m. resulting in one scratch, one rider change and no equipment changes for Sunday's program.

07-15-16<sup>2</sup> **RULING NO. 6 - FIGUEROA FILM REVIEW & RULING**  
Apprentice Jockey **CERAPIO FIGUEROA** who rode **THROUGHLEAP** in the second race at the California State Fair & Exposition (Sacramento) on July 10, 2016 is hereby suspended three (3) racing days (July 22, 23 and 24, 2016) for altering course without sufficient clearance in the stretch and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – Careless Riding).

The foregoing ruling was issued after Jockey Cerapio Figueroa and the stewards reviewed the film replays of the second race on July 10, 2016. The stewards advised Jockey Figueroa to use his reins to straighten his mount instead of his crop.

07-15-16<sup>3</sup> **HERRERA FILM REVIEW**  
Jockey Cristobal Herrera was in to review his ride in the sixth race on Sunday, July 10, 2016 where his mount #2 DELTA RANGER came over and bumped #5 WARREN'S JOE T. Jockey Herrera felt that he had done all he could to straighten his mount. The stewards countered that a better effort would be expected in the future. A warning was issued.

07-15-16<sup>4</sup> **RACE #1 - ARRIAGA INCIDENT**  
After the finish of the first race #5 LORETTA JONES propped and unseated her rider. Paramedics were on the scene promptly and reported Jockey Arriaga had the wind knocked out of him. He remounted his stead and had his picture taken.

07-15-16<sup>5</sup> **RACE #5 - CLAIM VOIDED**  
In the fifth race, an \$8,000 claiming event, the claim of #9 CHEROKEE DYNASTY by Bob Hess was voided post-race after the three year old colt was placed on the Vet's List as unsound by Dr. Dooley. CHEROKEE DYNASTY was returned to trainer Steve Miyadi's barn.
