used more than three times without giving the horse a chance to respond [second offense in past sixty days]).

Ruling 07

Jockey **LUIS GODOY** who rode **MANY MOODS** in the fifth race at the California State Fair on Saturday, July 20, 2019 is hereby fined the sum of two hundred dollars (\$200.00)* for violation of California Horse Racing Board rule #1688 (use of Riding Crop – used more than three times without giving the horse a chance to respond [second offense in past sixty days]).

The foregoing rulings were issued after both riders met with the Stewards and acknowledged they violated the crop rule.
