Report of the Board of Stewards for the period August 8, 2007 through August 13, 2007.

WEDNESDAY

1 SECURITY VIOLATION NOTICE

Groom Henry Sanchez, who works for trainer Martin Jones, appeared in the stewards' office to address a security violation notice issued by DMTC backside security for displaying another person's license on August 8th. Groom Sanchez's own license is in 'good standing' with the CHRB. He stated he inadvertently grabbed his sister's expired groom's license when leaving his home for work. The stewards found no motivation for Groom Sanchez to not tell the truth. Steward Scott Chaney translated the Sanchez testimony into English at this informal hearing. Warning issued.

2 DAN JENSEN RULING

Owner/Trainer Dan Jensen failed to show up at a hearing in the Del Mar stewards' office on August 6th. This hearing (Case #07DM016) concerned an outstanding bill owed to Southern California Equine Foundation in the amount of \$1027.00. The stewards issued the following ruling:

Ruling #35

Owner/Trainer Daniel M. Jensen having failed to appear before the Board of Stewards to answer a complaint alleging violation of California Horse Racing Board Rule #1876 (Financial Responsibility), is suspended for violation of California Horse Racing Board Rule #1547 (Failure to Appear). During the term of suspension, all license and license privileges of Daniel M. Jensen are suspended and pursuant to California Horse Racing Board #1528 (Jurisdiction of Stewards to Suspend or fine) subject is denied access to all premises in this jurisdiction.

3 EIGHTH RACE/INQUIRY/OBJECTION/DISQUALIFICATION

The stewards posted the Inquiry sign immediately following the running of this race after viewing an incident about eighty (80) yards before the finish. Also in this race, Jockey Aaron Gryder (Third place #3 “First Opportunity”) lodged an objection against #4 “Dr Zaentz” (Chris Landeros) who finished first. Eighty (80) yards before the finish #4 “Dr Zaentz” was racing in a straight line while being whipped left handed by Jockey Landeros. At this point, Jockey Landeros goes into a strong hand ride, at which point his mount drifts inward. “Dr Zaentz” then bumps #3 “First Opportunity” on his ‘far side’. After the bump, “Dr Zaentz” crosses over in front of #3 “First Opportunity” forcing Jockey Gryder to steady sharply off of heels. After steadying, Jockey Gryder’s mount finishes strongly while beaten ½ of a length for second position. The stewards received patrol judge input and spoke to both riders involved. After film review of all camera angles, the stewards, in a unanimous vote, disqualified #4 “Dr Zaentz” from first position and placed him third. Jockey Chris Landeros was ordered to film review.

1 JOCKEY CHRIS LANDEROS FILM REVIEW

Jockey Chris Landeros appeared as ordered to review his ride aboard #4 “Dr Zaentz” in yesterday’s eighth race. Jockey Landeros finished first in this race but was disqualified and placed third. This informal hearing revolved around a bumping incident about eighty (80) yards before the finish. (Ref 08/08/07 (3)).

Jockey Landeros took full responsibility for his actions in this race. In what is out of the ordinary, his mount was actually running in a straighter line under left handed whipping than under the subsequent strong hand ride. It was at this point that Landeros had his mount pointed in an inward direction. His charge then interferes with third place finisher #3 “First Opportunity” (Aaron Gryder). After conferring, the stewards unanimously felt a suspension was warranted for this ride. The following ruling was issued:

RULING #36

Jockey Chris Landeros, who rode “Dr. Zaentz” in the eighth race at Del Mar Thoroughbred Club on Wednesday, August 8, 2007 is suspended for three (3) racing days (August 16th, 17th, and 18th 2007) for failure to make the proper effort to maintain a straight course in the stretch and causing interference, resulting in the disqualification of his mount from first to third, which is a violation of California Horse Racing Board Rule # 1699 (Riding Rules – Careless Riding).

The terms of this suspension shall not prohibit participation in designated races in California.

2 JOCKEY ROOM FILM SESSION

The stewards held their weekly 12:30 pm race replay session with the jockeys in the film room this afternoon. Races that involved inquiries or questionable race riding were played for review. Comments were lively as the lines of communication between the judges and jockeys were kept open.

3 WARREN STUTE

Legendary horse trainer Warren Stute passed away this morning at his Arcadia home. He was 85. Mr. Stute was born Sept 21, 1921 in Fort Wayne, Indiana. He came to Southern California with his family in 1934, the year Santa Anita opened. He took out his trainer’s license in 1940. Trainer Stute won 1,946 races in his career. He was still galloping his own horses into his 80’s. With his passing California racing loses a true gentleman who loved the sport of racing and taught many how to train horses in a classy, professional manner. He will be sorely missed.

4 RULINGS #37 THRU #40

The following rulings were issued as a result of parking violations that were issued by DMTC backside security:

Salvador Morfin is fined Twenty Dollars (\$20.00)* for violation of Stable area parking regulations. California Horse Racing Board Rule # 1530 (Cases Not Covered by Rules & Regulations).

Martin Rosado is fined Twenty Dollars (\$20.00)* for violation of Stable area parking regulations. California Horse Racing Board Rule # 1530 (Cases Not Covered by Rules & Regulations).

Stacy Young is fined Twenty Dollars (\$20.00)* for violation of Stable area parking regulations. California Horse Racing Board Rule # 1530 (Cases Not Covered by Rules & Regulations).

Alejandro Uribe is fined Ten Dollars (\$10.00)* for violation of Stable area parking regulations. California Horse Racing Board Rule # 1530 (Cases Not Covered by Rules & Regulations).

5 SEVENTH RACE JOCKEY’S OBJECTION

Following the running of the seventh race, ‘Quick Official’ employee Larry Gilligan radioed the stewards to inform them that Jockey Corey Nakatani wanted to lodge an objection. Nakatani rode fourth place finisher #2 “Warning Smile” and the claim of foul was made against second place finisher #3 “Frank the Barber” (David Flores) for alleged interference at the 1/8th pole (turf).

Approaching the 1/8th pole Jockey Nakatani attempted to shoot between rivals #3 “Frank the Barber” and #8 “Law Breaker” (Aaron Gryder). While doing so Jockey Nakatani himself initiates contact with the hind quarters of #3 “Frank the Barber”. In the unanimous opinion of the stewards both Jockeys Flores and Gryder were racing straight. After patrol judge report and speaking with both Nakatani and Flores, no change was made in the order of finish. This decision was reached relatively swiftly as the stewards felt the objection lacked seriousness.

1 APPRENTICE QUINONEZ FILM REVIEW

Apprentice Jockey Alonso Quinonez appeared in the stewards' office to review his ride in the second race yesterday (August 9). Quinonez rode #4 "Neon Princess" who finished fifth in the aforementioned race. At the 1/8th pole Apprentice Quinonez pulled off of # 6 "Zee Topper" (Michael Baze), who was passing him while racing between horses. When pulling off, "Neon Princess" tightened the racing room of sixth place finisher #3 "Honeeluv Dron" (Joel Rosario).

Apprentice Quinonez understood the stewards' admonishment in this matter. He was cautioned once again to be aware of horses on both sides of him in the stretch run.

2 MICHAEL BAZE FILM REVIEW

Jockey Michael Baze appeared in the stewards' office to review his ride aboard second place finisher #7 "Tejano Forever". Jockey Baze appeared to force an opening between winner #1 "Si Chimi" (Alonzo Quinonez) and fourth place finisher #3 "Thundering Rhythm" (Martin Pedroza).

The stewards have noticed a pattern lately of Jockey Baze entering very tight openings between horses just after the ¼ pole on the Polytrack surface. The stewards cautioned Jockey Baze that interference going through these openings could lead to a suspension.

3 FOURTH RACE INQUIRY/JOCKEY'S OBJECTION

The stewards posted the Inquiry sign immediately following this race to view two (2) incidents (start & 1/8th pole). Also the rider of second place finisher #1 "Wild and Ready" (Isasis Enriquez) lodged an objection against first place finisher #4 "Black Mallou" (Corey Nakatani) for alleged interference at the 1/8th pole.

In the first incident the stewards were concerned with the start where it was believed that interference was initiated by eighth (last) place finisher #2 "El Vago" (Alonzo Quinonez). Race replays also show first place finisher #4 "Black Mallou" contribute to the incident of which third place finisher #3 "Tough Contender" (Joseph Talamo) was the recipient. "Tough Contender" was beaten 2 ¼ lengths for second position and the stewards ruled 'no change' for the incident at the start was warranted.

In the second incident Jockey Corey Nakatani and "Black Mallou" veer inward, into the path of #1 "Wild and Ready" forcing Jockey Isasis Enriquez to 'take up' sharply at the 1/8th pole. "Black Mallou" was 'blowing by' "Wild and Ready" at this point and the stewards felt this incident did not cost "Wild and Ready" the 3 ¼ length margin at the finish. After all the patrol judges reported and the stewards spoke with Jockeys' Enriquez and Nakatani it was ruled no disqualification were warranted in this race. Jockey Corey Nakatani was ordered to film review tomorrow morning.

4 LATE DECLARATION/REAL GOOD DEAL STAKES

The stewards made a ‘late declaration’ in this race after finding out that #9 “Earnedneveragain” (Trainer Michael Machowsky) had been treated prior to the running of this seventh race. The ‘Real Good Deal Stakes’ with a purse of \$100,000 is one of over thirty (30) races that are surveilled by DMTC security and the CHRB.

DMTC security reported that at 5:30 p.m. they observed the groom of “Earnednevergiven” administer a dose syringe of a substance taken from a plastic bottle. The plastic bottle was marked ‘Air Power Equine Cough Formula’ CHRB Senior Special Investigator Frank Fink and Assistant Steward Luis Jauregui were notified at this time. At approximately 5:49 p.m. Fink and Jauregui went to Machowsky’s barn and confiscated the aforementioned plastic bottle. The stewards were notified shortly thereafter.

The stewards then conferred with CHRB Equine Medical Director Rick Arthur and CHRB veterinarian Gary Beck. The stewards then interpreted CHRB Rule 1843.5 (Medication, Drugs and Other Substances Permitted After Entry in a Race). At approximately 6:19 p.m. the stewards informed Trainer Michael Machowsky that #9 “Earnedevergiven” would be a ‘late scratch’.

1 MIKE LUND RULING

The ruling below was issued after Owner Mike Lund paid Melinda Blue DVM \$206.50 on a past due bill.

RULING #41

Owner Mike Lund, having complied with provisions of California Horse Racing Board Rule # 1876 (Financial Responsibility), is restored to good standing. Ruling #25, issued at Del Mar Thoroughbred Club on August 3, 2007, is set aside.

2 DONALD BATEMAN RULING

The ruling below was issued after Mr. Bateman paid an outstanding veterinarian bill. Mr. Bateman had originally failed to show up at a hearing May 16, 2007 at Hollywood Park.

RULING #42

Owner Donald Bateman, having complied with provisions of California Horse Racing Board Rule #1876 (Financial Responsibility), is restored to good standing. Ruling #26, issued at Hollywood Park on May 16, 2007, is set aside.

3 COREY NAKATANI FILM REVIEW

Jockey Corey Nakatani appeared in the stewards' office to review his ride aboard first place finisher #4 "Black Mallou" in yesterday's fourth race. Jockey Nakatani survived a stewards' inquiry and jockey objection (Ref: 08/10/08 (3)) in this race for alleged interference at the 1/8th pole.

Film review showed Jockey Nakatani and "Black Mallou" racing past second place finisher #1 "Wild and Ready" (Isaias Enriquez) at the 1/8th pole. While under a strong hand ride Jockey Nakatani's mount veers inward forcing Jockey Enriquez to steady sharply off of the heels of "Black Mallou". Nakatani adamantly placed the blame of the incident on his horse and felt he made corrective measures, by "pulling back" on his horse.

The stewards felt that Nakatani performed some corrective measures well after what the stewards considered sub par steering. The stewards felt Nakatani's ride led to a near heel-clipping incident. The following ruling was issued:

RULING #43

Jockey Corey Nakatani, who rode "Black Mallou" in the fourth race at Del Mar Thoroughbred Club on Friday, August 10, 2007 is suspended for three (3) racing days (August 18th, 19th, and 20th 2007) for failure to make the proper effort to maintain a straight course in the stretch and causing interference, which is a violation of California Horse Racing Board Rule # 1699 (Riding Rules – Careless Riding).

The terms of this suspension shall not prohibit participation in designated races in California.

4 FOURTH RACE INQUIRY

The stewards briefly posted the Inquiry sign to review an incident involving a ‘minor placing’. At issue was an incident inside the 1/8th pole where sixth place finisher #5 “Deputy Lad” (Martin Garcia) attempts to enter a very narrow opening along the rail. The horse in front of him was fifth place finisher #3 “Common Trust” (Isaias Enriquez).

Race replays show Jockey Martin Garcia and “Deputy Lad” steady sharply after what the stewards considered questionable judgment on his part. Jockey Enriquez and “Common Trust” appeared to step inward slightly but this action was outweighed by Jockey Garcia’s judgment in this case. After patrol judge input, no change was made in the order of finish. Jockey Enriquez was ordered to film review.

5 SEVENTH RACE INQUIRY/DISQUALIFICATION

The stewards posted the Inquiry sign immediately following this race to review a bumping incident with less than one hundred (100) yards before the finish. In this 1 1/16th mile turf race, second place finisher #4 “Artist’s Tale” (Jose Valdivia) drifts out under left handed whipping and bumps rival #8 “Kendargent” (Martin Pedroza). “Kendargent” finished in a dead heat for third position with #12 “Blue Torpedo” (Brice Blanc).

The stewards felt that the bump to #8 “Kendargent” was significant due to the fact that it jarred him and took him off his straight course in the crucial, later stages of the race. Adding much weight to the decision was the fact that the offended horse was involved in a dead heat. After patrol judge input and speaking with Jockey’s Valdivia and Pedroza the stewards disqualified #4 “Artist’s Tale” and place him fourth. Jockey Jose Valdivia was ordered to film review.

1 ISASIS ENRIQUEZ FILM REVIEW

Jockey Isasis Enriquez appeared in the steward's office to review his ride in the fourth race yesterday . Jockey Enriquez was involved in an inquiry for a 'minor placing' (fifth place) in this race.

Jockey Enriquez's horse in this race (#3 "Common Trust") steps in slightly inside the 1/8th pole. At which time sixth place finisher #5 "Deputy Lad" (Martin Garcia) steadied while entering a very tight opening along the rail. The stewards issued a warning to Jockey Enriquez in this matter, as they felt Jockey Garcia's judgment contributed to this incident that resulted in 'no change'.

2 JOSE VALDIVIA FILM REVIEW

Jockey Jose Valdivia appeared in the steward's office to review his ride aboard #4 "Artist's Tale" in yesterdays seventh race. Jockey Valdivia was involved in a disqualification of his mount from second to fourth in this race.

During the film review, the stewards and Jockey Valdivia viewed his horse drift out under left handed whipping and bump dead heat third place finisher #8 "Kendargent" (Martin Pedroza). The stewards took into account Jockey Valdivia's good riding record at this meet. The bump was significant as far as yesterday's disqualification was concerned. However the stewards felt this incident fell short of issuing a suspension. Warning issued.

3 SMOOTH CARD

Today's ten (10) race card went well. Attendance was 16,832 on-track and all sources handle was listed at \$16,110,167. The stewards were happy to witness an inquiry and objection free Sunday slate.

1 MUTUEL MANAGER CALL

DMTC Mutuel Manager Bill Navarro phoned the stewards to state that race program information for Laurel, Maryland and Chile will not appear in today's program. Therefore no wagering on either venue will take place today.

2 ADAM KITCHINGMAN COMPLAINT (CASE NO: 07DM002)

This informal hearing concerned a high 'flunixin' reading on the Adam Kitchingman trained "Capture The Car". Trainer Kitchingman sent a split sample to Industrial Laboratories in Denver CO. whose analysis did not come back in his favor. Trainer Kitchingman, stated his assistant trainer administered a banamine paste to his horse that obviously remained in the horses system too long. The following ruling was issued:

RULING #44

Trainer Adam Kitchingman, who started the horse "Capture The Cat" in the eighth race at Hollywood Park Race Track on June 29, 2007, is fined the sum of four hundred dollars (\$400.00)* pursuant to California Horse Racing Board Rule #1887 (Trainer to Insure Condition of Horse), for violation of California Horse Racing Board Rule #1843 (a) (d) (Medication, Drugs, and Other Substances – Flunixin – Cass VI).

3 JACK BENTLEY COMPLAINT (CASE NO: 07DM009)

A financial agreement was made in collaboration with the stewards on this matter. Trainer Bentley, who is currently in Texas, agrees to pay Skip Park DVM three (3) payments. Payments agreed to are \$200.00 due on 08/15/07, \$200.00 due on 09/01/07 and \$197.64 due on 10/01/07.

4 RALPH HAWKINS COMPLAINT (CASE NO:07DM015)

Owner Ralph Hawkins failed to appear for a hearing originally scheduled for August 11, 2007. The complaint concerns a bill for \$339.44 for services performed by Skip Park DVM. The following ruling was issued:

RULING #45

Owner Ralph Hawkins having failed to appear before the Board of Stewards to answer a complaint alleging violation of California Horse Racing Board Rule #1876 (Financial Responsibility) is suspended for violation of California Horse Racing Board Rule #1547 (Failure to Appear).

During the term of suspension, all license and license privileges of Ralph Hawkins are suspended and pursuant to California Horse Racing Board #1528 (Jurisdiction of Stewards to Suspend or Fine) subject is denied access to all premises in this jurisdiction.

5 KAREN HEADLEY RULING

Assistant Trainer Karen Headley pled guilty to parking in front of a 'no parking' sign in the Del Mar stable area. DMTC backside security issued a citation to Ms. Headley. The stewards issued the following ruling:

RULING #46

Karen Headley is fined Twenty Dollars (\$20.00)* for violation of Stable area parking regulations. California Horse Racing Board Rule # 1530 (Cases Not Covered by Rules & Regulations).

6 ALONSO QUINONEZ FILM REVIEW

Apprentice Jockey Alonso Quinonez appeared in the stewards' office to review his ride in the fifth race Saturday August 11th. In this race 1 1/16th mile turf race Apprentice Quinonez was aboard #7 "Likely A Star" (finished eighth). This horse was racing in third position behind two (2) leaders at the 6 ½ furlong pole. At this point #7 "Likely A Star" shifts outward, without clearance, in front of #5 "Mood Winner" (Jon Court). This action forces Jockey Court to steady sharply off the heels of #7 "Likely A Star" to avoid clipping heels.

Jockey Quinonez has been in the stewards' office at least three (3) times in this short meet to review sub-par rides this meet with the stewards. Today the warnings ceased. The stewards issued the following ruling:

RULING #47
