Report of the Board of Stewards for the week of Wednesday, August 27, 2008 through Wednesday, September 3, 2008. Steward Scott Chaney was the Reporting Steward for the enclosed period.

WEDNESDAY AUGUST 27, 2008

1 FILM REVIEW

Jockey ALONSO QUINONEZ met with stewards to review the fifth race from Monday in which he angled his horse outward in an abrupt manner near the eighth pole. The result was three horses having to steady slightly. While the move did not technically rise to the level of interference, we explained to Mr. Quinonez that quick moves such as these are almost never advisable. He agreed.

2 HEADLEY HEARING

Assistant trainer KAREN HEADLEY met with the stewards informally to discuss several citations issued by stable area security. Ms. Headley was cited several times for no parking decal on her car, once for a dog off of its leash and once for parking in a no parking zone. Ms. Headley explained that her parking decal was on the dashboard, but that she did have her dog off of its leash. She also explained that she has been parking in the same spot for a number of years. Decision to follow.

3 PURSE REDISTRIBUTION/DISQUALIFICATION

This Board of Stewards held a formal hearing this morning to address case 08DM001 which involved the potential disqualification (and purse redistribution) of “Zanda Blue,” trained by Thomas Bell II for a procaine overage at Hollywood Park. Present were the stewards, CHRB investigator Rick Amieva and court reporter Barbara Weinstein. Although the owner, trainer and jockey were noticed, they chose not to attend. The record was opened and evidence taken, with the intention of issuing a ruling later in the day.

DMTD Ruling #107

Based upon a report from the University of California, Davis Laboratories, an official laboratory for the California Horse Racing Board, that urine sample #HP04282, obtained from the horse ZANDA BLUE, the first place finisher in the first race at Hollywood Park Race Track on July 2, 2008, contained the drug procaine (Class 3) in excess of the permitted level, it is ordered that ZANDA BLUE be disqualified from all purse monies earned in said race, in accordance with California Horse Racing Board rule #1859.5 (Disqualification Upon Positive Test Finding).

It is further ordered that the purse money earned in said race (\$15,000.00) be returned by owners Betty and Robert G. Irvin (\$12,000.00), trainer T.R. Bell II (\$1,500.00), and jockey Jon Court (\$1,500.00) to the Paymaster of Purses at Hollywood Park by September 27, 2008, for redistribution in accordance with the revised order of finish.

The revised order of finish is as follows:

- 1st Dixieland Classic
- 2nd B.A. Homebody
- 3rd Gentlemen’s Crown
- 4th Skianis Girl
- 5th Violet Sky

All records are ordered changed to reflect this ruling. In accordance with California Horse Racing Board rule #1956 (Race Declared Official), neither the pari-mutuel payoff nor the distribution of any pari-mutuel pool shall be affected.

4 CROUSE NO SHOW

Owner RONALD CROUSE failed to appear for a hearing (case number 08DM0018) involving a complaint that alleged several CHRB violations: 1930 (Obedience to a Security), 1874 (Disorderly Conduct), 1922 (Identification Required) and 1923 (Association Credentials). 1 CROUSE RULING

The following ruling was issued after owner RONALD CROUSE failed to appear for the hearing referenced yesterday:

DMTD Ruling #108

Owner RONALD CROUSE, having failed to appear before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rules #1930 (Obedience to Security Officers and Public Safety Officers), #1874 (Disorderly Conduct), and #1922 (Identification Required), is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension all licenses and license privileges of RONALD CROUSE are suspended and pursuant to California Horse Racing Board rule #1527 (Jurisdiction of Stewards to Fine or Suspend) MR. CROUSE is denied access to all premises in this jurisdiction.

2 HEADLEY RULING

The following ruling was issued after discussing Ms. Headley's parking and dog issues yesterday:

DMTD Ruling #109

Assistant trainer KAREN HEADLEY is fined Fifty Dollars (\$50.00)* for violation of Stable area parking regulations and stable area dog regulations (not on leash) pursuant to California Horse Racing Board Rule # 1530 (cases not covered by Rules & Regulations).

3 MEAIRS HEARING

Assistant trainer JOHN MEAIRS failed to appear this morning to answer case number 08DM019 which embodied a complaint alleging disorderly conduct toward a racing official, namely, the racing veterinarian Dr. Jill Bailey. The incident's genesis involved a horse that Dr. Bailey scratched for unsoundness during her morning soundness exams on August 15, 2008 here at Del Mar.

1 FILM REVIEW

Apprentice jockey MICHAEL MARTINEZ met with the stewards to discuss his ride in the third race yesterday in which his mount drifted out shortly after leaving the gate. In reviewing the films, it appeared that Mr. Martinez allowed his mount to drift out about two horse paths for about seven strides before grabbing the rein and correcting his path. The result was making it very tight for the horses to his outside and causing at least two rivals to steady. While we try to be more lenient on jockeys leaving the starting gate because their mounts are more difficult to control, it was our opinion that Mr. Martinez’s actions constituted careless riding and therefore levied the following three day suspension:

DMTD Ruling #134

Apprentice Jockey MICHAEL MARTINEZ, who rode “Angel’s Reward” in the third race at Del Mar Thoroughbred Club on Thursday, August 28, 2008 is suspended for three (3) racing days (September 24th, 25th, and 26th, 2008) for failure to make the proper effort to maintain a straight course out of the starting gate, causing interference. This constitutes a violation of California Horse Racing Board Rule # 1699 (Riding Rules – Careless Riding).

The terms of this suspension shall not prohibit participation in designated races in California.

SATURDAY, AUGUST 30, 2008

1 FILM REVIEW

Jockey DAVID FLORES met with the stewards this morning to discuss his ride in the third race yesterday in which mount drifts in a couple of paths in the stretch. Although the rider to his inside steadies only slightly, we nevertheless admonished Mr. Flores that a straighter path keeps him out of the stewards’ office and clear of suspension days. He acknowledged his error.

2 CROUSE HEARING

Owner RONALD CROUSE met with the stewards informally regarding several parking issues and an incident with one of the stable gate attendants. After hearing his explanation for the alleged violations, we elected to issue the following ruling:

DMTC Ruling #135

Owner RONALD CROUSE, having appeared before the Board of Stewards, is restored to good standing. Ruling #108, issued at Del Mar Thoroughbred Club on August 28, 2008, is set aside. In addition, owner RONALD CROUSE is fined TWO HUNDRED DOLLARS (\$200.00)* for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers) and violation of stable area parking regulations pursuant to California Horse Racing Board Rule #1530 (Cases Not Covered by Rules and Regulations).

3 OBJECTION/OBJECTION/DISQUALIFICATION

Following the running of the second race, two jockeys lodged objections for what proved to be related incidents. Jockey Martin Pedroza, aboard sixth place finisher #9 Pinkerbelle, claimed foul against third place finisher #2 Black Magic Mama, ridden by jockey Martin Garcia, for interference at the eighth pole. Films revealed that Mr. Garcia shifts his mount out and in front of #9, causing that rival to steady sharply to avoid clipping heels. Since #9 was beaten a half of a length for fifth, the stewards voted unanimously to disqualify #2 and place her sixth. The second objection came from Martin Garcia who claimed foul against the winner, #10 Heatology for interference at the eighth pole. Mr. Garcia claimed that the winner crossed in front of his mount before he was clear and therefore caused him to alter course. After reviewing the films and speaking with the patrol judges and riders involved, the stewards believed that Mr. Flores and his mount were clear and that no action was therefore necessary.

1 FILM REVIEW

Jockey MARTIN GARCIA met with the stewards to discuss his ride in the second race yesterday in which his mount was disqualified for causing interference in the stretch. Mr. Garcia felt that David Flores had crossed in front of him before he was completely clear and therefore Mr. Garcia, at the time, believed that shifting out was the right move. After reviewing the films he acknowledged that he should have waited before easing his mount into the clear and therefore accepted the following penalty without objection:

DMTD Ruling #136

Jockey MARTIN GARCIA, who rode “Black Magic Mama” in the second race at Del Mar Thoroughbred Club on Saturday, August 30, 2008 is suspended for three (3) racing days (September 24th, 25th, and 26th, 2008) for altering course without sufficient clearance, causing interference which

resulted in the disqualification of his mount from third to sixth position, which is a violation of California Horse Racing Board Rule # 1699 (Riding Rules – Careless Riding).

The terms of this suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board rule #1766 (Designated Races).

Jockey DAVID FLORES met with the stewards to discuss his ride in the second race yesterday in which he allowed his mount to drift in about two paths in the stretch. Although films show that he was clear, the space was marginal and we therefore explained that a straighter path is always safer and less likely to result in a penalty.

MONDAY, SEPTEMBER 1, 2008

1 DEL MAR RULING

After careful consideration of case number 08DM014 which alleged that Del Mar violated CHRB rule #1865 (Altering Sex of Horse), this Board of Stewards elected to levy a fine of \$1,000.00. Del Mar management argued cogently that neither rule 1865 nor any other CHRB rule requires that the race track note in the program that horses are first time geldings. This Board of Stewards, while recognizing that Del Mar did not violate the letter of the law, believes that Del Mar violated the spirit of the law. It seems unfair that trainers (as well as other tracks that may not be as legally savvy) should be penalized for failing to report geldings but not tracks who fail to pass the information along to the wagering public.

DMTD Ruling #138

DEL MAR THOROUGHBRED CLUB is fined one thousand dollars (\$1,000.00)* for violation of California Horse Racing Board rule #1865 (Altering of Sex of Horse –Failure to Note First-Time Gelding) on August 9, 2008 in the eighth race.

Pursuant to the explanation in last week's minutes, owner JOAN HEMMING failed to present evidence that she had satisfied her debt to trainer Ray Bell and is therefore suspended in the following ruling:

DMTD Ruling #139

Owner JOAN HEMMING, having failed to comply with the terms outlined in DMTD ruling #88 issued on August 21, 2008, is suspended for violation of California Horse Racing Board rule #1876 (Financial Responsibility).

During the term of this suspension all licenses and license privileges of JOAN HEMMING are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards) subject is denied access to all premises within this jurisdiction.

1 CLOSING DAY

Today represents closing day at Del Mar, capping off what always proves to be an eventful, yet successful race meeting.

2 MULLINS RULING

The following ruling was issued after trainer Jeff Mullins contacted the stewards regarding the horse "Pathbreaking" in the eighth race today. Mr. Mullins explained that this horse had received a TCO2 overage recently and that he had some concerns about running him. He attempted to request a split sample for the horse but had some procedural difficulties which we were able to solve. However, Mr. Mullins still had some trepidation regarding running the horse, so we elected to scratch the horse but fined Mr. Mullins for the late declaration.

DMTD Ruling #151

Trainer Jeff Mullins is fined three hundred dollars (\$300.00)* pursuant to California Horse Racing Board Rule #1629 (Penalty for Late Declaration), for necessitating the late declaration of "Pathbreaking" from the eighth race on Wednesday, September 3, 2008, at Del Mar Thoroughbred Club.

3 INQUIRY/NO CHANGE

Following the running of the second race, the stewards posted the inquiry sign to examine an incident in which apprentice jockey Pedro Arambula was unseated at the break. Films revealed that Mr. Arambula's mount stumbles at the break, but no other horses were involved. No change was required.
