**SUNDAY**  
07/22/12<sup>1</sup>

**ENTRY ISSUE**

Racing Secretary Tom Robbins met with the Stewards to discuss allowing trainers to enter into both Stake races and Overnight Stake races at the same time on different days. The two races involved were the California Dreamin' Handicap (\$100,00.00 paid nomination-entry fee). The other race was the Wickerr Stakes (\$85,000.00, free nomination-entry fee). Mr. Robbins stated that for several years Del Mar has allowed this procedure and considered both types of races, as "stakes" races. There were differences of opinions of this procedure, pursuant to rule 1581.1(a). It is a normal practice to allow a trainer, when the horse is needed by the Racing Office, to enter from a lesser race into a similar or stronger condition race, but not enter "down" into a lesser condition race. It is also considered, if an owner pays to run in a race, they should be able to declare out without a penalty. A resolution will follow shortly.

**WILSON HEARING CASE #12HP072**

Racing Veterinarian Dana Stead filed a complaint against trainer Lance Wilson for an alleged violation of CHRB rule 1581 (Racing Secretary to Establish Conditions) and 1437 (Conditions of a Race Meeting). Although Mr. Wilson was one hour late arriving on the grounds, the horse was medicated within the required guidelines. Mr. Wilson stated his trailer lights weren't working due to vandalism. He produced proof of his purchase of new "plugs" bought to fix his trailer lights before he could

travel. Mr. Wilson was informed he should have notified the Stewards and the receiving barn and explained his dilemma. Decision to follow.

**LOPEZ FORMAL HEARING CASE #12HP075**

The CHRB filed a complaint against jockey Lorenzo Lopez for an alleged violation of CHRB rules 1489 (h) (Grounds for Denial or Refusal of License) and 1890 (Possession of Contraband). Investigator Rick Amieva represented the CHRB and Safety Steward Luis Jauregui translated for Mr. Lopez. Mr. Lopez was sworn in and testified that he had tried marijuana for the pain in his shoulder due to old riding injuries. The hearing was continued until Mr. Lopez could meet with Winners Foundation and find a local doctor to evaluate his physical condition and his capabilities to work under CHRB rules.

**CLERK OF SCALES REPLACEMENT**

Assistant Clerk of Scales Charles McCaul replaced Clerk of Scales Ruben Hernandez for the afternoon duties. Mr. Hernandez was relieved of his duties due to violation of DMTC personnel policy. The matter was referred to the CHRB investigative staff.

**INQUIRY FIRST RACE (5 ½ furlongs)/NO CHANGE**

After the finish of the race the inquiry sign was posted to review an incident approaching the 1/16 marker. Involved were # 7 Spring Rocks (1st J. Talamo) and # 5 Buds Pal (2nd E. Flores). As # 7 passed # 5 he drifted slightly inward causing # 5 to change its direction. After conversation with the Patrol Judges and both jockeys involved it was a unanimous decision to let the original order of finish stand. It was the Stewards opinion that # 5 was not compromised the opportunity of a better placing and the race was made official. Mr. Talamo will meet with the Stewards Wednesday morning to discuss the race.

The Stewards and DMTC jointly agreed to relieve Mr. Hernandez of his duties pending a hearing.

**FILM REVIEW**

Jockey Joe Talamo met with the Stewards to review the first race on Sunday. He left the office with a warning to stay straight and not to cross over without sufficient clearance. He agreed to be more aware.

**INQUIRY FIFTH RACE (1 mile-polytrack)/NO CHANGE**

After the finish of the race the inquiry sign was posted to review the start. Involved was #8 Magic Fire (M. Pedroza). Simultaneously to the starting gate doors opening #8 reared up, and the rider stepped off of the fractious horse. After a review of the videos and talking to the Starter and the Patrol Judge it was unanimous to declare the horse a starter and the race was made official.

**JOCKEY OBJECTION SEVENTH RACE (1 mile-turf)/NO CHANGE**

After the finish of the race jockey Martin Garcia who rode # 9 Calimonco (2<sup>nd</sup>) lodged a claim of foul against #2 Suggestive Boy (ARG) (1<sup>st</sup> J. Talamo) for alleged interference in the stretch. After a review of the videos and conversation with the Patrol Judges and both jockeys it was a unanimous decision to make the original order of finish official. The #7 Key Decision (ARG) (3<sup>rd</sup> V. Espinoza) was on the inside of the three horse spread and initiated the pressure which was applied to #2 the winner and this tipped #9. No change was applicable because #7 ran third.

Trainer **TEVIS McCAULEY** is fined **FOUR HUNDRED DOLLARS (\$400.00)\*** for failure to have the horse "Grace for Grace" prepared to start in the sixth race at Del Mar Thoroughbred Club on July 26, 2012,

resulting in a late declaration. This constitutes a violation of California Horse Racing Board rule #1629(Penalty for Late Declaration).
